# Quasi-periodic incompressible Euler flows in 3D

#### Abstract

We prove the existence of time-quasi-periodic solutions of the incompressible Euler equation on the three-dimensional torus $\mathbb{T}^{3}$, with a small time-quasi-periodic external force. The solutions are perturbations of constant (Diophantine) vector fields, and they are constructed by means of normal forms and KAM techniques for reversible quasilinear PDEs. Keywords: Fluid dynamics, Euler equation, vorticity formulation, KAM for PDEs, quasi-periodic solutions. MSC 2010: 37K55, 35Q31.

## 1 Introduction

We consider the Euler equation for an incompressible fluid on the three-dimensional torus $\mathbb{T}^{3}, \mathbb{T}:=\mathbb{R} / 2 \pi \mathbb{Z}$,

$$
\left\{\begin{array}{l}
\partial_{t} U+U \cdot \nabla U+\nabla p=\varepsilon f(\omega t, x)  \tag{1.1}\\
\operatorname{div} U=0
\end{array}\right.
$$

where $\varepsilon \in(0,1)$ is a small parameter, $\omega \in \mathbb{R}^{\nu}$ is a Diophantine $\nu$-dimensional vector, the external force $f$ belongs to $\mathcal{C}^{q}\left(\mathbb{T}^{\nu} \times \mathbb{T}^{3}, \mathbb{R}^{3}\right)$ for some integer $q>0$ large enough, $U=\left(U_{1}, U_{2}, U_{3}\right): \mathbb{R} \times \mathbb{T}^{3} \rightarrow \mathbb{R}^{3}$ is the velocity field, and $p: \mathbb{R} \times \mathbb{T}^{3} \rightarrow \mathbb{R}$ is the pressure. We look for time-quasi-periodic solutions of (1.1), oscillating with time frequency $\omega$. This leads to solve the equation

$$
\left\{\begin{array}{l}
\omega \cdot \partial_{\varphi} U+U \cdot \nabla U+\nabla p=\varepsilon f(\varphi, x)  \tag{1.2}\\
\operatorname{div} U=0
\end{array}\right.
$$

where the unknown velocity field $U: \mathbb{T}^{\nu} \times \mathbb{T}^{3} \rightarrow \mathbb{R}^{3}$ and the unknown pressure $p: \mathbb{T}^{\nu} \times \mathbb{T}^{3} \rightarrow \mathbb{R}$ are functions of $(\varphi, x) \in \mathbb{T}^{\nu} \times \mathbb{T}^{3}$. We look for solutions which are small perturbation of a constant vector field $\zeta \in \mathbb{R}^{3}$, namely we look for solutions of the form

$$
U(\varphi, x)=\zeta+u(\varphi, x) \quad \text { with } \quad \operatorname{div} u=0
$$

Plugging this ansatz into the equation, one is led to solve

\left\{\begin{array}{l}
\omega \cdot \partial_{\varphi} u+\zeta \cdot \nabla u+u \cdot \nabla u+\nabla p=\varepsilon f(\varphi, x)  \tag{1.3}\\
\operatorname{div} u=0
\end{array}\right.
$$

We assume that the forcing term $f(\varphi, x)$ is an odd function of the pair $(\varphi, x)$, namely

$$
\begin{equation*}
f(\varphi, x)=-f(-\varphi,-x) \quad \forall(\varphi, x) \in \mathbb{T}^{\nu} \times \mathbb{T}^{3} \tag{1.4}
\end{equation*}
$$

We look for solutions $(u, p)$ of (1.3) that are even functions of the pair $(\varphi, x)$, namely

$$
\begin{equation*}
u(\varphi, x)=u(-\varphi,-x), \quad p(\varphi, x)=p(-\varphi,-x) \quad \forall(\varphi, x) \in \mathbb{T}^{\nu} \times \mathbb{T}^{3} \tag{1.5}
\end{equation*}
$$

For any real $s \geq 0$, we consider the Sobolev spaces of real scalar and vector-valued functions of $(\varphi, x)$

$$
\begin{align*}
H^{s}=H^{s}\left(\mathbb{T}^{\nu+3}, \mathbb{R}^{n}\right) & :=\left\{u(\varphi, x)=\sum_{(\ell, j) \in \mathbb{Z}^{\nu+3}} \widehat{u}(\ell, j) e^{i(\ell \cdot \varphi+j \cdot x)}:\|u\|_{s}:=\left(\sum_{(\ell, j) \in \mathbb{Z}^{\nu+3}}\langle\ell, j\rangle^{2 s}|\widehat{u}(\ell, j)|^{2}\right)^{\frac{1}{2}}<\infty\right\} \\
H_{0}^{s} & :=\left\{u \in H^{s}: \int_{\mathbb{T}^{3}} u(\varphi, x) d x=0\right\}, \quad\langle\ell, j\rangle:=\max \{1,|\ell|,|j|\} . \tag{1.6}
\end{align*}
$$

We fix any bounded open set $\Omega \subseteq \mathbb{R}^{\nu} \times \mathbb{R}^{3}$ to which the parameters $(\omega, \zeta)$ belong. The main result of the paper is the following theorem.
Theorem 1.1. There exist $q=q(\nu)>0, s=s(\nu)>0$, such that for every forcing term $f \in \mathcal{C}^{q}\left(\mathbb{T}^{\nu} \times \mathbb{T}^{3}, \mathbb{R}^{3}\right)$ satisfying (1.4) there exist $\varepsilon_{0}=\varepsilon_{0}(f, \nu) \in(0,1), C=C(f, \nu)>0$ such that for every $\varepsilon \in\left(0, \varepsilon_{0}\right)$ the following holds. There exists a Borel set $\Omega_{\varepsilon} \subset \Omega$ of asymptotically full Lebesgue measure, i.e. $\lim _{\varepsilon \rightarrow 0}\left|\Omega \backslash \Omega_{\varepsilon}\right|=0$, such that for every $(\omega, \zeta) \in \Omega_{\varepsilon}$ there exist $u=u(\cdot ; \omega, \zeta) \in H^{s}\left(\mathbb{T}^{\nu+3}, \mathbb{R}^{3}\right)$ and $p=p(\cdot ; \omega, \zeta) \in H^{s}\left(\mathbb{T}^{\nu+3}, \mathbb{R}\right)$, even functions of the pair $(\varphi, x)$, that solve equation (1.3), with $\|u\|_{s},\|p\|_{s} \leq C \varepsilon^{b}$ for some $b \in(0,1)$.

Theorem 1.1 is deduced from Theorem 1.2 below, dealing with the vorticity formulation of the problem, which we now introduce.

As is well-known, if we take the divergence of the first equation in (1.3), we can determine the pressure $p$ in terms of the unknown $u$ and the forcing term $f$, namely we have

\Delta p+\operatorname{div}(u \cdot \nabla u)=\varepsilon \operatorname{div} f(\omega t, x)
$$

whence

$$
\begin{equation*}
p=\Delta^{-1}[\varepsilon \operatorname{div} f(\omega t, x)-\operatorname{div}(u \cdot \nabla u)] . \tag{1.7}
\end{equation*}
$$

If we consider the average in the space variable $x \in \mathbb{T}^{3}$ of equation (1.3), we get the equation

$$
\omega \cdot \partial_{\varphi} u_{0}(\varphi)=f_{0}(\varphi), \quad \text { where } u_{0}(\varphi):=\frac{1}{(2 \pi)^{3}} \int_{\mathbb{T}^{3}} u(\varphi, x) d x, \quad f_{0}(\varphi):=\frac{1}{(2 \pi)^{3}} \int_{\mathbb{T}^{3}} f(\varphi, x) d x
$$

This equation can be solved by assuming that the frequency vector $\omega$ is Diophantine, i.e.

$$
|\omega \cdot \ell| \geq \frac{\gamma}{|\ell|^{\tau}} \quad \forall \ell \in \mathbb{Z}^{\nu} \backslash\{0\}
$$

because, by (1.4), $f$ has zero average in $(\varphi, x)$. Hence, without loss of generality, we can assume that $f$ has zero average in space, namely

$$
\begin{equation*}
\int_{\mathbb{T}^{3}} f(\varphi, x) d x=0 . \tag{1.8}
\end{equation*}
$$

We define the vorticity

$$
v:=\nabla \times u:=\operatorname{curl} u:=\left(\begin{array}{l}
\partial_{x_{2}} u_{3}-\partial_{x_{3}} u_{2}  \tag{1.9}\\
\partial_{x_{3}} u_{1}-\partial_{x_{1}} u_{3} \\
\partial_{x_{1}} u_{2}-\partial_{x_{2}} u_{1}
\end{array}\right) .
$$

By taking the curl of equation (1.3) (recall that $\nabla \times \nabla \Phi=0$ for any smooth scalar function $\Phi$ ), as is well known, one obtains the equation for the vorticity $v(\varphi, x)$

$$
\omega \cdot \partial_{\varphi} v+\zeta \cdot \nabla v+u \cdot \nabla v-v \cdot \nabla u=\varepsilon F(\varphi, x), \quad F:=\nabla \times f .
$$

We construct an odd solution $v(\varphi, x)$ of the latter equation and we shall prove that there are even functions $(u(\varphi, x), p(\varphi, x))$ which solves the equation (1.3). Since $\operatorname{div} u=0$, one has

\operatorname{curl} v=\operatorname{curl}(\operatorname{curl} u)=-\Delta u ;
$$

therefore, if the space average of $u$ is zero, then

$$
u=(-\Delta)^{-1} \operatorname{curl} v
$$

and one has the vorticity equations

$$
\left\{\begin{array}{l}
\omega \cdot \partial_{\varphi} v+\zeta \cdot \nabla v+u \cdot \nabla v-v \cdot \nabla u=\varepsilon F(\varphi, x), \quad F:=\nabla \times f,  \tag{1.10}\\
u=\nabla \times\left[(-\Delta)^{-1} v\right]
\end{array}\right.
$$

where $(-\Delta)^{-1}$ is the Fourier multiplier of symbol $|\xi|^{-2}$ for $\xi \in \mathbb{Z}^{3}, \xi \neq 0$, and zero for $\xi=0$, namely

$$
\begin{equation*}
u(x)=\sum_{\xi \in \mathbb{Z}^{3}} \hat{u}(\xi) e^{\mathrm{i} \xi \cdot x} \Rightarrow(-\Delta)^{-1} u(x)=\sum_{\xi \in \mathbb{Z}^{3} \backslash\{0\}} \frac{1}{|\xi|^{2}} \hat{u}(\xi) e^{\mathrm{i} \xi \cdot x} \tag{1.11}
\end{equation*}
$$

The divergence of $v$ and the space average of $v$ are both zero, because $v$ is a curl. We will prove that if $v$ solves (1.10) then $u:=\nabla \times\left(\Delta^{-1} v\right)$ solves (1.2).

We define the spaces of even/odd functions of the pair $(\varphi, x)$

\begin{align*}
& X:=\left\{h \in L^{2}\left(\mathbb{T}^{\nu+3}, \mathbb{R}^{3}\right): h(\varphi, x)=h(-\varphi,-x)\right\} \\
& Y:=\left\{h \in L^{2}\left(\mathbb{T}^{\nu+3}, \mathbb{R}^{3}\right): h(\varphi, x)=-h(-\varphi,-x)\right\} \tag{1.12}
\end{align*}
$$

and

$$
\begin{equation*}
\Pi_{0} h:=\frac{1}{(2 \pi)^{3}} \int_{\mathbb{T}^{3}} h(\varphi, x) d x, \quad \Pi_{0}^{\perp}:=\mathrm{Id}-\Pi_{0} \tag{1.13}
\end{equation*}
$$

We will prove that it is enough to look for smooth solutions $v(\varphi, x) \in Y$ with zero average that solve the projected equation

$$
\left\{\begin{array}{l}
\Pi_{0}^{\perp}\left(\omega \cdot \partial_{\varphi} v+\zeta \cdot \nabla v+u \cdot \nabla v-v \cdot \nabla u\right)=\varepsilon F(\varphi, x), \quad F:=\nabla \times f  \tag{1.14}\\
u=\nabla \times\left[(-\Delta)^{-1} v\right]
\end{array}\right.
$$

It is convenient to replace $(-\Delta)^{-1}$ with an extension of it that is invertible also on functions with nonzero space average; with $\Pi_{0}$ defined by (1.13), we then define

$$
\begin{equation*}
\Lambda:=\Pi_{0}-\Delta, \quad \Lambda^{-1}:=\Pi_{0}+(-\Delta)^{-1} \tag{1.15}
\end{equation*}
$$

so that $\Lambda, \Lambda^{-1}$ are Fourier multipliers of symbols, respectively, $|\xi|^{2},|\xi|^{-2}$ for $\xi \in \mathbb{Z}^{3} \backslash\{0\}$, and 1 for $\xi=0$. Thus $\Lambda \Lambda^{-1} u=u$ for all periodic functions $u$ (of course, introducing smooth cutoff functions, these symbols can be extended to all $\mathbb{R}^{3}$ by preserving the property $\Lambda \Lambda^{-1}=\mathrm{Id}$ ).

We introduce the rescaling $v=\tilde{\varepsilon} \tilde{v}, \tilde{\varepsilon}:=\varepsilon^{1 / 2}$, and write (1.14) (with $(-\Delta)^{-1}$ replaced by $\Lambda^{-1}$ ) in terms of $\tilde{\varepsilon}$, $\tilde{v}$, namely

\begin{equation*}
\Pi_{0}^{\perp}\left(\omega \cdot \partial_{\varphi} \tilde{v}+\zeta \cdot \nabla \tilde{v}+\tilde{\varepsilon} \tilde{u} \cdot \nabla \tilde{v}-\tilde{\varepsilon} \tilde{v} \cdot \nabla \tilde{u}\right)=\tilde{\varepsilon} F(\varphi, x), \quad \tilde{u}=\operatorname{curl}\left(\Lambda^{-1} \tilde{v}\right) \tag{1.16}
\end{equation*}
$$

We will show the existence of solutions of (1.16) with a Nash-Moser approach, by finding zeros of the nonlinear operator (after dropping all the tilde)

$$
\mathcal{F}: H_{0}^{s+1}\left(\mathbb{T}^{\nu+3}, \mathbb{R}^{3}\right) \cap Y \rightarrow H_{0}^{s}\left(\mathbb{T}^{\nu+3}, \mathbb{R}^{3}\right) \cap X
$$

defined by

$$
\begin{equation*}
\mathcal{F}(v):=\omega \cdot \partial_{\varphi} v+\zeta \cdot \nabla v+\varepsilon \Pi_{0}^{\perp}[\mathcal{U}(v) \cdot \nabla v-v \cdot \nabla \mathcal{U}(v)-F(\varphi, x)], \quad \mathcal{U}(v):=\operatorname{curl}\left(\Lambda^{-1} v\right) . \tag{1.17}
\end{equation*}
$$

We consider parameters $(\omega, \zeta)$ in a bounded open set $\Omega \subseteq \mathbb{R}^{\nu} \times \mathbb{R}^{3}$; we will use such parameters along the proof in order to impose appropriate non resonance conditions. Now we state precisely the main results of the paper.

Theorem 1.2. There exist $q=q(\nu)>0, s=s(\nu)>0$, such that for every forcing term $f \in \mathcal{C}^{q}\left(\mathbb{T}^{\nu} \times \mathbb{T}^{3}, \mathbb{R}^{3}\right)$ satisfying (1.4) there exists $\varepsilon_{0}=\varepsilon_{0}(f, \nu) \in(0,1)$ such that for every $\varepsilon \in\left(0, \varepsilon_{0}\right)$ the following holds. There exists a Borel set $\Omega_{\varepsilon} \subset \Omega$ of asymptotically full Lebesgue measure, i.e. $\lim _{\varepsilon \rightarrow 0}\left|\Omega \backslash \Omega_{\varepsilon}\right|=0$ such that for any $(\omega, \zeta) \in \Omega_{\varepsilon}$ there exists $v(\cdot ; \omega, \zeta) \in H_{0}^{s}\left(\mathbb{T}^{\nu+3}, \mathbb{R}^{3}\right)$, $v=\operatorname{odd}(\varphi, x)$ such that $\mathcal{F}(v)=0$. Moreover $\sup _{(\omega, \zeta) \in \Omega_{\varepsilon}}\|v(\cdot ; \omega, \zeta)\|_{s} \leq C \varepsilon^{a}$ for some constants $C=C(\nu)>0$ and $a=a(\nu) \in(0,1)$.

From Theorem 1.2 we will deduce (see Section (11) the existence of $u(\varphi, x), p(\varphi, x)$ solving (1.3).
Related literature: Euler equations. The celebrated Euler equation, one of the most important mathematical models from fluid dynamics, has been extensively studied in the last century; we refer, for example, to the book [34] and the survey [22] for a rich introduction to the subject with a detailed overview of its vast literature and its interesting open problems.

Starting from the Seventies, the Cauchy problem for the incompressible Euler equation has been analyzed by many authors. Without even trying to be exaustive, we mention just few results (see e.g. 34 for much more references). The local-in-time existence of smooth solutions for the incompressible Euler equation has been established by Kato in [37, [38. Concerning the global existence of smooth solutions, the situation is very different in the two-dimensional (2D) case and in the three dimensional (3D) one. Indeed, the Beale-Kato-Majda criterion [12] says that if a smooth solution of the Euler equation on a time interval $\left[0, T_{*}\right.$ ) cannot be continued to $T_{*}$, then its vorticity $v(t, x)$ satisfies $\int_{0}^{T_{*}}\|v(t, \cdot)\|_{L_{x}^{\infty}} d t=\infty$; viceversa, a priori estimates on that vorticity integral implies the existence of global smooth solutions. In the 2D case, the vorticity is conserved along the fluid particle trajectories; this implies the identity $\|v(t, \cdot)\|_{L_{x}^{\infty}}=\|v(0, \cdot)\|_{L_{x}^{\infty}}$ and, therefore, the existence of a unique smooth global solution (by Beale-Kato-Majda criterion). We also mention that for the 2D Euler equation Yudovich [46] proved the existence of global weak solutions when the initial vorticity is in the space $L_{x}^{\infty} \cap L_{x}^{1}$, while ill-posedness for strong solutions of borderline Sobolev
regularity has been recently proved by Bourgain and Li [19]; we also refer to [19] for other references on ill-posedness in both 2D and 3D. We mention the very recent work of Elgindi 26] about singularity formation in finite time for solutions $C_{t, x}^{1, \alpha}$ with spatial decay.

In 3D, the vorticity equation contains an additional term, called "stretching term". Whether smooth solutions of the 3D Euler (and also Navier-Stokes) equation blow up in finite time or exist globally in time is one of the most famous open problems in the theory of PDEs. Global weak solutions in 3D have been investigated starting form the Ninetiees. Schnirelman 45] constructed global and distributional solutions in $L_{t, x}^{2}$; De Lellis and Székelyhidi in [25] constructed global weak solutions in $L_{t, x}^{\infty}$ with compact support; then these results have been followed by several important improvements, see e.g. [20] and 31].

Regarding time quasi-periodic solutions of the Euler equation, to the best of our knowledge the only result in literature is the 2D one of Crouseilles and Faou [24], where the scalar vorticity formulation allows the construction of quasi-periodic solutions as localized travelling profiles of special form with compact support, avoiding the small divisors problem one usually encounters in KAM results. On the other hand, KAM techniques have been used by Khesin, Kuksin and Peralta-Salas in [32, [33] to obtain non-mixing results for the 3D Euler equation around steady flows.

In this paper, using normal form and KAM (Kolmogorov-Arnold-Moser) techniques, we construct smooth (strong) solutions of the forced 3D Euler equations that are quasi-periodic in time; as a consequence, in particular, they are global in time. This is one of the few KAM results for quasilinear PDEs in higher space-dimension.
Related literature: KAM for quasilinear PDEs. The existence of time-periodic and quasi-periodic solutions of PDEs (which is often referred to as "KAM for PDEs" theory) started in the late 1980s with the pioneering papers of Kuksin [39], Wayne [47] and Craig-Wayne [21; we refer to the recent review [13] of Berti for a general presentation of the theory, of its protagonists and its state-of-the-art. Many PDEs arising from fluid dynamics are fully nonlinear or quasi-linear equations, namely equations where the nonlinear part contains as many derivatives as the linear part. The key idea in order to deal with these kind of PDEs has been introduced by Iooss, Plotnikov and Toland [30] in the problem of finding periodic solutions for the water waves equation. Using a Nash-Moser iteration to overcome the small divisors problem, their strategy to solve the linearized equation at any approximate solution relies on a normal form procedure based on pseudo-differential calculus. This approach to quasilinear and fully nonlinear PDEs with small divisors has been further developed in [2], 1] for periodic solutions, and it has been successfully combined with a $K A M$ reducibility procedure to develop a general method for 1D problems for the construction of quasi-periodic solutions of quasilinear and fully nonlinear PDEs and for the analysis of the dynamics of linear PDEs with time-quasi-periodic unbounded potentials, see [4], 5], [17, 3], [7, 8]; see [13] for a more complete list of references. We recall that, in this context, a linear operator is said to be reducible if there exists a change of variables, bounded on Sobolev spaces, that conjugates it to a diagonal (or block-diagonal) operator.

The extension of KAM reducibility results to higher space dimension $d>1$ is a difficult matter. The first reducibility result in higher dimension has been obtained by Eliasson and Kuksin in [27] for the linear Schrödinger equation with a bounded analytic potential. Their proof is strongly based on the fact that the eigenvalues of the Laplacian on $\mathbb{T}^{d}$ are separated and hence some kind of second order Melnikov conditions (lower bounds on differences of the eigenvalues) can be imposed block-wise.

By extending the Craig-Wayne method [21, Bourgain 18 and then Berti-Bolle [14, [15, Berti-CorsiProcesi [16] proved the existence of invariant tori for nonlinear wave (NLW) and Schrödinger (NLS) equations with bounded perturbations in higher space dimension. These results are based on a technique called multiscale analysis, which allows to solve the linearized equations arising in the Nash-Moser iterative procedure by imposing suitable lower bounds, called first order Melnikov conditions, on its eigenvalues.

Extending KAM theory to PDEs with unbounded perturbations in higher space dimension is one of the open problems in the field. A natural strategy is to try to extend the normal form methods based on pseudo-differential calculus developed in 1D in [4], [5], [17, 3, [7, [8]. Up to now, this has been achieved only in few examples, namely the Kirchhoff equation [35], [23, the non-resonant transport equation [29], [11] and the quantum harmonic oscillator on $\mathbb{R}^{d}$ and Zoll manifolds [9, 10.

### 1.1 Description of the strategy

In the present paper, to overcome the small divisors problem, we construct invariant tori of the Euler equation by means of a Nash-Moser iteration. Therefore, the core of the paper is the analysis of the linearized operators (see (3.3)) arising in the Nash-Moser scheme, performed in Sections $4 \sqrt{8}$. The strategy is somehow related to the one developed in [11], since the linearized Euler equation is a linear transport-like equation with a small, quasi-periodic in time perturbation of order one. On the other hand the procedure developed in 11] does not apply. The main reason is that in this case we deal with a vector transport operator of the form

h=\left(h_{1}, h_{2}, h_{3}\right) \mapsto \mathcal{L} h:=\omega \cdot \partial_{\varphi} h+\zeta \cdot \nabla h+\varepsilon a(\varphi, x) \cdot \nabla h+\varepsilon \mathcal{R}(\varphi) h \tag{1.18}
\end{equation*}
$$

where $\mathcal{R}(\varphi)=\left(\mathrm{Op}\left(r_{i j}(\varphi, x, \xi)\right)\right)_{i, j=1,2,3}$ is a $3 \times 3$ matrix-valued pseudo-differential operator of order 0 , whereas in [11] the transport operator to normalize is scalar. In order to invert the operator $\mathcal{L}$ in (1.18), we construct a normal form procedure which reduces the operator (1.18) to a $3 \times 3$ block-diagonal operator of the form

$$
\omega \cdot \partial_{\varphi} h+\zeta \cdot \nabla h+\operatorname{Op}(Q(\xi)) h
$$

where the $3 \times 3$ matrix symbol $Q(\xi) \in \operatorname{Mat}_{3 \times 3}$ satisfies $\|Q(\xi)\|_{\mathrm{HS}} \lesssim \varepsilon\langle\xi\rangle^{-1}$ where the norm $\|\cdot\|_{\mathrm{HS}}$ is the standard Hilbert-Schmidt norm of the matrices. Note that we obtain only a $3 \times 3$ block-diagonalization. This is due to the fact that the unperturbed operator (which is (1.18) for $\varepsilon=0$ ) has eigenvalues of multiplicity 3 , namely for every $j \in \mathbb{Z}^{d} \backslash\{0\}$ the functions

\end{array}\right)
$$

are orthogonal eigenfunctions in $L^{2}\left(\mathbb{T}^{3}, \mathbb{C}^{3}\right)$ corresponding to the eigenvalue $\mathrm{i} \zeta \cdot j$.
The fact that we deal with $3 \times 3$ matrix-valued pseudo-differential operators is actually the main technical difficulty of the paper. The point is that, if we take two matrix-valued pseudo-differential operators $\mathcal{A}=$ $\operatorname{Op}(A(\varphi, x, \xi)), \mathcal{B}=\operatorname{Op}(B(\varphi, x, \xi))$ of order $m, m^{\prime}$ respectively, it is not true (unlike for scalar pseudodifferential operators) that the commutator $[\mathcal{A}, \mathcal{B}]$ gains one derivative, namely it is not of order $m+m^{\prime}-$ 1. Indeed the principal symbol of the commutator is given by the commutator of two $3 \times 3$ matrices $[A(\varphi, x, \xi), B(\varphi, x, \xi)]$, which, in general, is not zero. This difficulty appears at the normal form step which allows to eliminate the zeroth order term. In fact, at the highest order term (which is $\left.\omega \cdot \partial_{\varphi}+(\zeta+\varepsilon a(\varphi, x)) \cdot \nabla\right)$ the linearized operator $\mathcal{L}$ acts in a diagonal way with respect to the three components $\left(h_{1}, h_{2}, h_{3}\right)$, whereas at the zeroth order term the dynamics on these components is strongly coupled. This implies that, in order to reduce to constant coefficients the zeroth order term of the linearized operator, we need to solve a variable coefficients homological equation, see the equation (1.21) below.

In the reduction of the zeroth order term we use the reversible structure of the Euler equation: working with functions with even/odd parity in the pair $(\varphi, x)$ eliminates some average terms that would be an obstruction to the reduction procedure. By reversibility, the reduction to constant coefficients of the zero order term corresponds to its complete cancellation.

Once the zeroth order term has been removed, in order to reduce to constant coefficients also the lower order terms (starting from the order -1 ), we use the fact that the perturbation to normalize is at least onesmoothing. The homological equations arising along the procedure have constant coefficients (see (1.22)) and the solutions are of the same order as the remainders we want to normalize: this implies that they gain derivatives. This gain of regularity replaces the gain of derivatives that, in the scalar case, is given by the gain of one derivative of commutators.

Now we describe in more details all the steps of our reduction procedure.

- Reduction of the highest order term. As already said, at the highest order term the operator $\mathcal{L}$ acts in a diagonal way on the three components $\left(h_{1}, h_{2}, h_{3}\right)$. Hence, in order to reduce to constant coefficients the highest order term, it is enough to diagonalize the transport operator

\begin{equation*}
\mathcal{T}:=\omega \cdot \partial_{\varphi}+(\zeta+\varepsilon a(\varphi, x)) \cdot \nabla \tag{1.20}
\end{equation*}
$$

This is the content of Proposition 4.1, whose proof follows [29. The only difference is that here, since the vector field $a(\varphi, x)$ has zero space average and zero divergence, we conjugate $\mathcal{T}$ to the operator $\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla$, provided the vector $(\omega, \zeta) \in \mathbb{R}^{\nu+3}$ is Diophantine (see (4.7), whereas in 29] the operator (1.20) is conjugated to a constant coefficients operator of the form $\omega \cdot \partial_{\varphi}+m(\omega, \zeta) \cdot \nabla$ with constant vector field $\mathrm{m}(\omega, \zeta)=\zeta+O(\varepsilon)$.
Then in Lemma 4.6 we prove that the remainder $\varepsilon \mathcal{R}$ (see (1.18)) is conjugated, by means of the reversibility preserving invertible map $\mathcal{A}$ constructed in Proposition 4.1, to another reversible operator of order zero which has the form $\operatorname{Op}\left(R_{0}^{(1)}\right)+\operatorname{Op}\left(R_{-1}^{(1)}\right)$ where $R_{i}^{(1)}$ is a matrix-valued symbol of order $i, i=0,-1$. We prove that the zeroth order term $R_{0}^{(1)}$ satisfies the symmetry condition $R_{0}^{(1)}(\varphi, x, \xi)=R_{0}^{(1)}(\varphi, x,-\xi)$. This condition, together with the reversibility (which, for the symbol, becomes $R_{0}^{(1)}(\varphi, x, \xi)=-R_{0}^{(1)}(-\varphi,-x,-\xi)$ ), allows to perform the normal form step at the zeroth order term.

- Reduction of the zeroth order term. In order to eliminate the zeroth order term $\operatorname{Op}\left(R_{0}^{(1)}\right)$ from the operator $\mathcal{L}^{(1)}$ defined in (4.44), we conjugate such an operator by means of the transformation $\mathcal{B}=\operatorname{Id}+\operatorname{Op}(M(\varphi, x, \xi))$ where the zeroth order $\operatorname{symbol} M(\varphi, x, \xi)$ has to satisfy the variable coefficients homological equation

$$
\begin{equation*}
\left(\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla+R_{0}^{(1)}(\varphi, x, \xi)\right) M(\varphi, x, \xi)+R_{0}^{(1)}(\varphi, x, \xi)=0 \tag{1.21}
\end{equation*}
$$

This equation is solved in Section 5.1. The main point is to transform the operator $\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla+$ $R_{0}^{(1)}(\varphi, x, \xi)$ (acting on the space of symbols $\mathcal{S}_{s, 0}^{0}$ cf. Definition 2.5) into the operator $\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla$, for all Diophantine vectors $(\omega, \zeta) \in D C(\gamma, \tau)$. This is made by means of the iterative scheme of Lemma 5.3. using the property that the symmetry conditions (5.7) are preserved along the iteration. This means that the space-time average of the remainders is always zero and therefore there are no corrections to the normal form operator $\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla$. We finally get the operator $\mathcal{L}^{(2)}$ in (5.22) which is a one-smoothing perturbation of the constant coefficients operator $\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla$.
The fact that no correction to the constant vector field $\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla$ comes from terms of order one and zero in the linearized operator is due to two different reasons: as observed above, the first order term gives no corrections because the coefficient $a(\varphi, x)$ in (1.20) has zero space average and zero divergence, while the zeroth order term gives no corrections because Euler equation is reversible and we are working in the corresponding invariant subspace (namely, where the vorticity is odd in the pair $(\varphi, x))$.

- Reduction of the lower order terms. In Proposition 6.1 we construct a reversibility preserving transformation that conjugates the operator $\mathcal{L}^{(2)}$ in (5.22) to the operator $\mathcal{L}^{(3)}$ in (6.2), which is a regularizing perturbation of arbitrary negative order of the constant coefficients operator

$$
\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla+\mathcal{Q}
$$

Here $\mathcal{Q}$ is a $3 \times 3$ block-diagonal operator of order -1 of the form

$$
\mathcal{Q} h(x)=\sum_{\xi \in \mathbb{Z}^{3}} Q(\xi) \widehat{h}(\xi) e^{\mathrm{i} \xi \cdot x}, \quad h \in L^{2}\left(\mathbb{T}^{3}, \mathbb{R}^{3}\right)
$$

with

$$
Q(\xi) \in \operatorname{Mat}_{3 \times 3}(\mathbb{C}), \quad\|Q(\xi)\|_{\mathrm{HS}} \lesssim \varepsilon\langle\xi\rangle^{-1}
$$

This is proved iteratively in Lemma 6.2. In that Lemma, the homological equation we solve at each step is a constant coefficients equation of the form

$$
\begin{equation*}
\left(\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla\right) M(\varphi, x, \xi)=R(\varphi, x, \xi)-\langle R\rangle_{\varphi, x}(\xi) \tag{1.22}
\end{equation*}
$$

where $\langle R\rangle_{\varphi, x}(\xi)$ is the $(\varphi, x)$-average of the symbol $R$, see (6.13).

Since $R$ is a symbol of order $-n$ with $n \geq 1$, for $(\omega, \zeta)$ Diophantine, equation (1.22) has a solution $M$ which is a symbol of order $-n$, namely the same order as the one we want to normalize. At the $n$-th step, since the remainder that we normalize is of order $-(n+1)$, then also the solution of the equation (6.13) is of order $-(n+1)$. This allows to show that the new error term is of order $-(n+2)$.

- Reducibility. To complete the reduction to constant coefficients of the linearized operator, the next step is the reducibility scheme of Section 8, in which we conjugate iteratively the operator $\mathcal{L}_{0}$ in (7.3) to a $3 \times 3$, time independent block diagonal operator of the form $\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla+\mathcal{Q}_{\infty}$. Here $\mathcal{Q}_{\infty}$ is a $3 \times 3$ block diagonal operator $\operatorname{diag}_{j \in \mathbb{Z}^{3} \backslash\{0\}}\left(\mathcal{Q}_{\infty}\right)_{j}^{j}$ where the $3 \times 3$ matrices $\left(\mathcal{Q}_{\infty}\right)_{j}^{j}$ satisfy $\left\|\left(\mathcal{Q}_{\infty}\right)_{j}^{j}\right\|_{\mathrm{HS}} \lesssim \varepsilon|j|^{-1}$ for all $j \in \mathbb{Z}^{3} \backslash\{0\}$, see Lemma 8.4. Along the iterative KAM procedure, we need to solve the homological equation (8.15). In order to solve it (see Lemma 8.3), for any $\left(\ell, j, j^{\prime}\right) \in \mathbb{Z}^{\nu} \times\left(\mathbb{Z}^{3} \backslash\{0\}\right) \times\left(\mathbb{Z}^{3} \backslash\{0\}\right)$, $\left(\ell, j, j^{\prime}\right) \neq(0, j, j)$, we have to invert the linear operator

$$
\begin{equation*}
L\left(\ell, j, j^{\prime}\right): \operatorname{Mat}_{3 \times 3} \rightarrow \operatorname{Mat}_{3 \times 3}, \quad M \mapsto \mathrm{i}\left(\omega \cdot \ell+\zeta \cdot\left(j-j^{\prime}\right)\right) M+\mathcal{Q}_{j}^{j} M-M \mathcal{Q}_{j^{\prime}}^{j^{\prime}} \tag{1.23}
\end{equation*}
$$

where $\mathcal{Q}^{j}$ are time independent $3 \times 3$ matrices. Then we impose second order Melnikov non-resonance conditions with loss of derivatives both in time and in space, involving the invertibility of such kinds of operators and suitable estimates for their inverses, see (8.9). Note that, since the Hamiltonian structure of the Euler equations is not the standard constant one (see [42]), the $3 \times 3$ blocks $\mathcal{Q}_{j}^{j}$ are, in general, not self-adjoint. Hence, to verify that the set of parameters satisfying the required nonresonance conditions has a large Lebesgue measure, we need to control a sufficiently large number of derivatives with respect to the parameter $(\omega, \zeta)$. In particular we prove that the nineth derivative of the determinant of the $9 \times 9$ matrix representing $L\left(\ell, j, j^{\prime}\right)$ in (1.23) is big, in order to show that the resonant sets have small Lebesgue measure (see Lemmata 10.3 , A.1). Since the $3 \times 3$ blocks could be not self-adjoint, we cannot deduce that our solutions are linearly stable.

As a conclusion of this introduction, we remark that the quadratic nonlinearity of the Euler equation is already in normal form (in the sense of homogeneity order, namely as Poincaré-Dulac normal form) because the dispersion relation $\lambda(\xi)=\mathrm{i} \zeta \cdot \xi$ of the unperturbed operator $\zeta \cdot \nabla$ is exactly linear. This means that the normal form approach, which in KAM theory is usually a very efficient way of extracting the first contribution to the frequency-amplitude relation from the nonlinearity of a PDE , for the Euler equation gives no improvement with respect to the equation itself. This makes it especially difficult to construct of quasi-periodic solutions for the autonomous (i.e. without the external forcing $f$ ) Euler equation.

## 2 Norms and linear operators

In this section we collect some general definitions and known results concerning norms, pseudo-differential operators and matrix representation of operators which are used in the whole paper. Subsection [2.2 deals with some conjugacy properties of curl, $(-\Delta)^{-1}$ with changes of variables, required by the analysis of the Euler equation.
Notations. In the whole paper, the notation $A{\lesssim s, m, k_{0}, \alpha} B$ means that $A \leq C\left(s, m, k_{0}, \alpha\right) B$ for some constant $C\left(s, m, k_{0}, \alpha\right)>0$ depending on the Sobolev index $s$, the constants $\alpha, m$ and the index $k_{0}$ which is the maximal number of derivatives with respect to the parameters $(\omega, \zeta)$ that we need to control along our proof. We always omit to write the dependence on $\nu$ which is the number of frequencies and $\tau$, which is the constant appearing in the non-resonance conditions (see for instance (4.7), (8.9)). Starting from Section 3 , we omit to write the dependence on $k_{0}$ since it is fixed as $k_{0}:=11$ in (10.2). Hence, we write $\lesssim_{s, m, \alpha}$ instead of $\lesssim_{s, m, k_{0}, \alpha}$. We often write $u=\operatorname{even}(\varphi, x)$ if $u \in X$ and $u=\operatorname{odd}(\varphi, x)$ if $u \in Y$ (recall the Definition (1.12)).

### 2.1 Function spaces and pseudo differential operators

We denote by $|\cdot|$ the Euclidean norm of vectors and by $|\cdot|=\|\cdot\|_{\text {HS }}$ the Euclidean ("Hilbert-Schmidt") norm of matrices: if $v \in \mathbb{C}^{n}$ has components $v_{j}$, and $M \in \operatorname{Mat}_{n \times m}(\mathbb{C})$ has entries $M_{j, k}$, then

|v|^{2}:=\sum_{j=1}^{n}\left|v_{j}\right|^{2}, \quad\|M\|_{\mathrm{HS}}^{2}:=\sum_{\substack{1 \leq j \leq n \\ 1 \leq k \leq m}}\left|M_{j, k}\right|^{2} . \tag{2.1}

Let $a: \mathbb{T}^{\nu} \times \mathbb{T}^{3} \rightarrow E, a=a(\varphi, x)$, be a function taking values in the space of scalars, or vectors, or matrices, namely $E=\mathbb{C}^{n}$ or $E=\operatorname{Mat}_{n \times m}(\mathbb{C})$. Then, for $s \in \mathbb{R}$, its Sobolev norm $\|a\|_{s}$ is defined as

\|a\|_{s}^{2}:=\sum_{(\ell, j) \in \mathbb{Z}^{\nu} \times \mathbb{Z}^{3}}\langle\ell, j\rangle^{2 s}|\widehat{a}(\ell, j)|^{2}, \quad\langle\ell, j\rangle:=\max \{1,|\ell|,|j|\}, \tag{2.2}
\end{equation*}

where $\widehat{a}(\ell, j) \in E$ (which are scalars, or vectors, or matrices) are the Fourier coefficients of $a(\varphi, x)$, namely

\hat{a}(\ell, j):=\frac{1}{(2 \pi)^{\nu+3}} \int_{\mathbb{T}^{\nu+3}} a(\varphi, x) e^{-\mathrm{i}(\ell \cdot \varphi+j \cdot x)} d \varphi d x

and $|\hat{a}(\ell, j)|$ is their norm defined in (2.1). We denote

H^{s}:=H_{\varphi, x}^{s}:=H^{s}\left(\mathbb{T}^{\nu} \times \mathbb{T}^{3}\right):=H^{s}\left(\mathbb{T}^{\nu} \times \mathbb{T}^{3}, E\right):=\left\{u: \mathbb{T}^{\nu} \times \mathbb{T}^{3} \rightarrow E,\|u\|_{s}<\infty\right\}
$$

for $E=\mathbb{C}^{n}$ or $E=\operatorname{Mat}_{n \times m}(\mathbb{C})$; we write, in short, $H^{s}$ both for vectors and for matrices.
In the paper we use Sobolev norms for (real or complex, scalar- or vector- or matrix-valued) functions $u(\varphi, x ; \omega, \zeta),(\varphi, x) \in \mathbb{T}^{\nu} \times \mathbb{T}^{3}$, depending on parameters $(\omega, \zeta) \in \mathbb{R}^{\nu+3}$ in a Lipschitz way together with their derivatives. We use the compact notation $\lambda:=(\omega, \zeta)$ to collect the frequency $\omega$ and the depth $\zeta$ into one parameter vector.

Recall the standard multi-index notation: for $k=\left(k_{1}, \ldots, k_{n}\right) \in \mathbb{N}^{n}$, we denote $|k|:=k_{1}+\ldots+k_{n}$ and $k!:=k_{1}!\cdots k_{n}!$; for $\lambda=\left(\lambda_{1}, \ldots, \lambda_{n}\right) \in \mathbb{R}^{n}$, we denote the derivative $\partial_{\lambda}^{k}:=\partial_{\lambda_{1}}^{k_{1}} \ldots \partial_{\lambda_{n}}^{k_{n}}$ and the monomial $\lambda^{k}:=\lambda_{1}^{k_{1}} \cdots \lambda_{n}^{k_{n}}$. We fix

s_{0}>(\nu+3)+k_{0}+2 \tag{2.3}

once and for all, and define the weighted Sobolev norms in the following way.
Definition 2.1. (Weighted Sobolev norms) Let $k_{0} \geq 1$ be an integer, $\gamma \in(0,1]$, and $s \geq s_{0}$. Given a function $u: \mathbb{R}^{\nu+3} \rightarrow H^{s}\left(\mathbb{T}^{\nu} \times \mathbb{T}^{3}\right), \lambda \mapsto u(\lambda)=u(\varphi, x ; \lambda)$ that admits $k_{0}$ derivatives with respect to $\lambda$, we define its weighted Sobolev norm

\|u\|_{s}^{k_{0}, \gamma}:=\max _{\substack{\alpha \in \mathbb{N}^{\nu+3} \\|\alpha| \leq k_{0}}} \sup _{\lambda \in \mathbb{R}^{\nu+3}} \gamma^{|\alpha|}\left\|\partial_{\lambda}^{\alpha} u(\lambda)\right\|_{s-|\alpha|} .

For $u$ independent of $(\varphi, x)$, we simply denote by $|u|^{k_{0}, \gamma}$ the same norm.
For any $N>0$, we define the smoothing operators (Fourier truncation)

Lemma 2.3. (Product and composition) (i) For all $s \geq s_{0}$,

The function $\breve{\alpha}$, defined by the inverse diffeomorphism $y=x+\alpha(\varphi, x)$ if and only if $x=y+\breve{\alpha}(\varphi, y)$, satisfies

(iii) Assume that $\|\alpha\|_{s_{0}+1}^{k_{0}, \gamma} \leq \delta\left(s_{0}, k_{0}\right)$ small enough. Then

Similar estimates hold for the operators $\mathcal{A}^{-1},\left(\mathcal{A}^{-1}\right)^{*}$.
Proof. Items (i), (ii) follows as in [17, taking into account Definition 2.1 (here $\partial_{\lambda}^{\alpha} u,|\alpha| \leq k_{0}$, is estimated in $H^{s-|\alpha|}$, whereas in [17] and [3] they are estimated in $H^{s}$ ) and the definition of $s_{0}$ in (2.3). We only prove (iii). A direct calculation shows that

$$
(\mathcal{A}-\operatorname{Id}) h(\varphi, x)=\int_{0}^{1} \nabla h(\varphi, x+t \alpha(\varphi, x)) \cdot \alpha(\varphi, x) d t
$$

Then, the estimate on $\mathcal{A}$ - Id follows by applying the estimates (2.7), (2.9). The estimate for $\mathcal{A}^{-1}-\mathrm{Id}$ can be proved similarly. Now we estimate the operator $\mathcal{A}^{*}$ - Id. A direct calculation shows that

$$
\mathcal{A}^{*} h(\varphi, y)=\operatorname{det}(\operatorname{Id}+\nabla \breve{\alpha}(\varphi, y)) h(\varphi, y+\breve{\alpha}(\varphi, y)) .
$$

Note that for $\|\nabla \breve{\alpha}\|_{L^{\infty}}$ small enough one has $\operatorname{det}(\operatorname{Id}+\nabla \breve{\alpha}(\varphi, y)) \geq \frac{1}{2}$. This is guaranteed by the smallness assumption $\|\alpha\|_{s_{0}+1}^{k_{0}, \gamma} \leq \delta$, by the estimate (2.10) and by Sobolev embeddings. One writes

\left(\mathcal{A}^{*}-\mathrm{Id}\right) h(\varphi, y)=(\operatorname{det}(\operatorname{Id}+\nabla \breve{\alpha}(\varphi, y))-1) \mathcal{A}^{-1} h(\varphi, y)+\left(\mathcal{A}^{-1}-\mathrm{Id}\right) h(\varphi, y) \tag{2.13}
\end{equation*}
$$

By estimates (2.7), (2.10) together with the smallness assumption $\|\alpha\|_{s_{0}+1}^{k_{0}, \gamma} \leq \delta$ one deduces that

\|\operatorname{det}(\operatorname{Id}+\nabla \breve{\alpha}(\varphi, y))-1\|_{s}^{k_{0}, \gamma} \lesssim_{s, k_{0}}\|\alpha\|_{s+1}^{k_{0}, \gamma} .
$$

Therefore the claimed estimate for $\mathcal{A}^{*}-\mathrm{Id}$ follows by (2.13), (2.7), (2.11). The estimate for $\left(\mathcal{A}^{-1}\right)^{*}-\mathrm{Id}$ can be proved similarly.

Let $\mathrm{m}: \mathbb{R}^{\nu+3} \rightarrow \mathbb{R}^{3},(\omega, \zeta) \mapsto \mathrm{m}(\omega, \zeta)$, be a $k_{0}$ times differentiable function satisfying $|\mathrm{m}-\zeta|^{k_{0}, \gamma} \leq \frac{1}{2}$, and define the set

\mathcal{O}(\gamma, \tau):=\left\{(\omega, \zeta) \in \mathbb{R}^{\nu} \times \mathbb{R}^{3}:|\omega \cdot \ell+\mathrm{m}(\omega, \zeta) \cdot j| \geq \frac{\gamma}{\langle\ell, j\rangle^{\tau}} \forall(\ell, j) \in \mathbb{Z}^{\nu+3} \backslash\{(0,0)\}\right\} \tag{2.14}
\end{equation*}
$$

The equation $\left(\omega \cdot \partial_{\varphi}+\mathrm{m} \cdot \nabla\right) v=u$, where $u(\varphi, x)$ has zero average with respect to $(\varphi, x)$, has the periodic solution

\begin{equation*}
\left(\omega \cdot \partial_{\varphi}+\mathrm{m} \cdot \nabla\right)^{-1} u(\varphi, x):=\sum_{(\ell, j) \in \mathbb{Z}^{\nu+3} \backslash\{(0,0)\}} \frac{\widehat{u}(\ell, j)}{\mathrm{i}(\omega \cdot \ell+\mathrm{m} \cdot j)} e^{\mathrm{i}(\ell \cdot \varphi+j \cdot x)} \tag{2.15}
\end{equation*}
$$

We define its extension to all $(\omega, \zeta) \in \mathbb{R}^{\nu} \times \mathbb{R}^{3}$ as

$$
\begin{equation*}
\left(\omega \cdot \partial_{\varphi}+\mathrm{m} \cdot \nabla\right)_{e x t}^{-1} u(\varphi, x):=\sum_{(\ell, j) \in \mathbb{Z}^{\nu+3}} \frac{\chi\left((\omega \cdot \ell+\mathrm{m} \cdot j) \gamma^{-1}\langle\ell, j\rangle^{\tau}\right)}{\mathrm{i}(\omega \cdot \ell+\mathrm{m} \cdot j)} \widehat{u}(\ell, j) e^{\mathrm{i}(\ell \cdot \varphi+j \cdot x)}, \tag{2.16}
\end{equation*}
$$

where $\chi \in \mathcal{C}^{\infty}(\mathbb{R}, \mathbb{R})$ is an even and positive cut-off function such that

$$
\chi(\xi)=\left\{\begin{array}{lll}
0 & \text { if } & |\xi| \leq \frac{1}{3}  \tag{2.17}\\
1 & \text { if } & |\xi| \geq \frac{2}{3},
\end{array} \quad \partial_{\xi} \chi(\xi)>0 \quad \forall \xi \in\left(\frac{1}{3}, \frac{2}{3}\right) .\right.
$$

Note that $\left(\omega \cdot \partial_{\varphi}+\mathrm{m} \cdot \nabla\right)_{\text {ext }}^{-1} u=\left(\omega \cdot \partial_{\varphi}+\mathrm{m} \cdot \nabla\right)^{-1} u$ for all $(\omega, \zeta) \in \mathcal{O}(\gamma, \tau)$.
Lemma 2.4. (Diophantine equation) One has

\left\|\left(\omega \cdot \partial_{\varphi}+\mathrm{m} \cdot \nabla\right)_{e x t}^{-1} u\right\|_{s}^{k_{0}, \gamma} \lesssim_{k_{0}} \gamma^{-1}\|u\|_{s+\tau_{0}}^{k_{0}, \gamma}, \quad \tau_{0}:=k_{0}+\tau\left(k_{0}+1\right) \tag{2.18}
\end{equation*}
$$

Definition 2.5. (Pseudo-differential operators and symbols) Let $m \in \mathbb{R}, s \geq s_{0}, \beta \in \mathbb{N}, n \in \mathbb{N}$. We say that an operator $\mathcal{A}=\mathcal{A}(\varphi)$ is in the class $\mathcal{O P} \mathcal{S}_{s, \beta}^{m}$ if there exists a function $A: \mathbb{T}^{\nu} \times \mathbb{T}^{3} \times \mathbb{R}^{3} \rightarrow \operatorname{Mat}_{n \times n}(\mathbb{C})$, $A=A(\varphi, x, \xi)$, differentiable $\beta$ times in the variable $\xi$, such that

\mathcal{A} u(x)=\operatorname{Op}(A) u(x)=\sum_{\xi \in \mathbb{Z}^{3}} A(\varphi, x, \xi) \hat{u}(\xi) e^{\mathrm{i} x \cdot \xi} \quad \forall u \in \mathcal{C}^{\infty}\left(\mathbb{T}^{3}, \mathbb{C}^{n}\right)
$$

and

$$
\begin{equation*}
|\mathcal{A}|_{m, s, \beta}:=\sup _{|\alpha| \leq \beta} \sup _{\xi \in \mathbb{R}^{3}}\left\|\partial_{\xi}^{\alpha} A(\cdot, \xi)\right\|_{s}\langle\xi\rangle^{-m+|\alpha|}<\infty ; \tag{2.19}
\end{equation*}
$$

in that case, we also say that $A(\varphi, x, \xi)$ is in the class $\mathcal{S}_{s, \beta}^{m}$. The operator $\mathcal{A}$ is said to be a pseudo-differential operator of order $m$, and the function $A$ is its symbol.

If $\mathcal{A}=\mathcal{A}(\lambda)$ depends in a $k_{0}$ times differentiable way on the parameters $\lambda=(\omega, \zeta) \in \mathbb{R}^{\nu+3}$, we define

|\mathcal{A}|_{m, s, \beta}^{k_{0}, \gamma}:=\sup _{|\alpha| \leq \beta} \sup _{\xi \in \mathbb{R}^{3}}\left\|\partial_{\xi}^{\alpha} A(\cdot, \xi)\right\|_{s}^{k_{0}, \gamma}\langle\xi\rangle^{-m+|\alpha|}=\max _{|k| \leq k_{0}} \gamma^{|k|} \sup _{\lambda \in \mathbb{R}^{\nu+3}}\left|\partial_{\lambda}^{k} \mathcal{A}(\lambda)\right|_{m, s-|k|, \beta} \tag{2.20}
\end{equation*}
$$

The values of $n$ in Definition 2.5 that we need for our problem are $n=1$ (when both $u$ and $A$ are scalar functions) and $n=3$ (when the function $u$ takes values in $\mathbb{R}^{3}$ or $\mathbb{C}^{3}$, and the symbol $A(\varphi, x, \xi)$ is a $3 \times 3$ matrix). Recall that, when $A(\varphi, x, \xi)$ is a matrix, its Sobolev norm is given by (2.1)-(2.2).

In the rest of this section we assume, without explicitly writing it, that all functions and symbols depend in a $k_{0}$ times differentiable way on the parameter $\lambda \in \mathbb{R}^{\nu+3}$.

Given a symbol $A=A(\varphi, x, \xi) \in \mathcal{S}_{s, \beta}^{m}$, we define the averaged symbol $\langle A\rangle_{\varphi, x}$ as

\langle A\rangle_{\varphi, x}(\xi):=\frac{1}{(2 \pi)^{\nu+3}} \int_{\mathbb{T}^{\nu+3}} A(\varphi, x, \xi) d \varphi d x \tag{2.21}

One easily verifies that, for all $s \geq 0$,

\langle A\rangle_{\varphi, x} \in \mathcal{S}_{s, \beta}^{m} \quad \text { and } \quad\left|\operatorname{Op}\left(\langle A\rangle_{\varphi, x}\right)\right|_{m, s, \beta}^{k_{0}, \gamma}=\left|\operatorname{Op}\left(\langle A\rangle_{\varphi, x}\right)\right|_{m, s_{0}, \beta}^{k_{0}, \gamma} \leq|\operatorname{Op}(A)|_{m, s_{0}, \beta}^{k_{0}, \gamma} \tag{2.22}
\end{equation*}
$$

Moreover if a symbol $A=A(\varphi, x)$ is independent of $\xi$, then the corresponding operator $\operatorname{Op}(A) \in \mathcal{O} \mathcal{P} \mathcal{S}_{s, \beta}^{0}$ is a multiplication operator, and

\operatorname{Op}(A): h(\varphi, x) \mapsto A(\varphi, x) h(\varphi, x), \quad|\operatorname{Op}(A)|_{0, s, \beta}^{k_{0}, \gamma}=\|A\|_{s}^{k_{0}, \gamma} \tag{2.23}
\end{equation*}
$$

By the definition of the norm in (2.19), and using the interpolation estimate (2.7), it follows that if $\mathcal{A}=$ $\operatorname{Op}(A) \in \mathcal{O} \mathcal{P} \mathcal{S}_{s, \beta}^{m}, \mathcal{B}=\operatorname{Op}(B) \in \mathcal{O} \mathcal{P} \mathcal{S}_{s, \beta}^{m^{\prime}}, s \geq s_{0}$, then $\operatorname{Op}(A B) \in \mathcal{O} \mathcal{P} \mathcal{S}_{s, \beta}^{m+m^{\prime}}$ and

$$
\begin{equation*}
|\mathrm{Op}(A B)|_{m+m^{\prime}, s, \beta}^{k_{0}, \gamma} \lesssim_{s, k_{0}, \beta}|\mathcal{A}|_{m, s, \beta}^{k_{0}, \gamma}|\mathcal{B}|_{m^{\prime}, s_{0}, \beta}^{k_{0}, \gamma}+|\mathcal{A}|_{m, s_{0}, \beta}^{k_{0}, \gamma}|\mathcal{B}|_{m^{\prime}, s, \beta}^{k_{0}, \gamma} . \tag{2.24}
\end{equation*}
$$

Iterating estimate (2.24) one has that if $\operatorname{Op}(A) \in \mathcal{O P} \mathcal{S}_{s, \beta}^{0}, s \geq s_{0}, \beta \in \mathbb{N}$, then for any $n \geq 1, \operatorname{Op}\left(A^{n}\right) \in$ $\mathcal{O} \mathcal{P} \mathcal{S}_{s, \beta}^{0}$ and

$$
\begin{equation*}
\left|\mathrm{Op}\left(A^{n}\right)\right|_{0, s, \beta}^{k_{0}, \gamma} \leq\left(C(s, \beta)|\mathrm{Op}(A)|_{0, s_{0}, \beta}\right)^{n-1}|\operatorname{Op}(A)|_{0, s, \beta} \tag{2.25}
\end{equation*}
$$

for some constant $C(s, \beta)>0$.
Lemma 2.6. Let $s \geq s_{0}$ and $\mathcal{A}(\lambda) \in \mathcal{O P} \mathcal{S}_{s, 0}^{0}, u(\lambda) \in H^{s}\left(\mathbb{T}^{\nu+3}, \mathbb{R}^{3}\right)$ for all $\lambda \in \mathbb{R}^{\nu+3}$. Then

\|\mathcal{A} u\|_{s}^{k_{0}, \gamma} \lesssim_{s, k_{0}}|\mathcal{A}|_{0, s, 0}^{k_{0}, \gamma}\|u\|_{s_{0}}^{k_{0}, \gamma}+|\mathcal{A}|_{0, s_{0}, 0}^{k_{0}, \gamma}\|u\|_{s}^{k_{0}, \gamma} .
$$

Lemma 2.7. (Composition of pseudo-differential operators) Let $s \geq s_{0}, m, m^{\prime} \in \mathbb{R}, \beta \in \mathbb{N}$.
(i) Let $\mathcal{A}=\operatorname{Op}(A) \in \mathcal{O} \mathcal{P} \mathcal{S}_{s, \beta}^{m}, \mathcal{B}=\operatorname{Op}(B) \in \mathcal{O P} \mathcal{S}_{s+|m|+\beta, \beta}^{m^{\prime}}$. Then the composition $\mathcal{A B}$ belongs to $\mathcal{O} \mathcal{P} \mathcal{S}_{s, \beta}^{m+m^{\prime}}$, and

\begin{equation*}
|\mathcal{A B}|_{m+m^{\prime}, s, \beta}^{k_{0}, \gamma} \lesssim_{s, m, k_{0}, \beta}|\mathcal{A}|_{m, s, \beta}^{k_{0}, \gamma}|\mathcal{B}|_{m^{\prime}, s_{0}+|m|+\beta, \beta}^{k_{0}, \gamma}+|\mathcal{A}|_{m, s_{0}, \beta}^{k_{0}, \gamma}|\mathcal{B}|_{m^{\prime}, s+|m|+\beta, \beta}^{k_{0}, \gamma} . \tag{2.26}
\end{equation*}
$$

(ii) Let $\mathcal{A}=\operatorname{Op}(A) \in \mathcal{O} \mathcal{P} \mathcal{S}_{s, 1}^{m}, \mathcal{B}=\operatorname{Op}(B) \in \mathcal{O} \mathcal{P} \mathcal{S}_{s+|m|+2,0}^{m^{\prime}}$. Then

\mathcal{A B}=\operatorname{Op}(A(\varphi, x, \xi) B(\varphi, x, \xi))+\mathcal{R}_{A B}, \quad \mathcal{R}_{A B} \in \mathcal{O} \mathcal{P} \mathcal{S}_{s, 0}^{m+m^{\prime}-1}
$$

where the remainder $\mathcal{R}_{A B}$ satisfies

\left|\mathcal{R}_{A B}\right|_{m+m^{\prime}-1, s, 0}^{k_{0}, \gamma} \lesssim s, m, k_{0}|\mathcal{A}|_{m, s, 1}^{k_{0}, \gamma}|\mathcal{B}|_{m^{\prime}, s_{0}+|m|+2,0}^{k_{0}, \gamma}+|\mathcal{A}|_{m, s_{0}, 1}^{k_{0}, \gamma}|\mathcal{B}|_{m^{\prime}, s+|m|+2,0}^{k_{0}, \gamma}
$$

Proof. See Lemma 2.13 in [17]
For functions $u, v: \mathbb{T}^{3} \rightarrow \mathbb{R}^{n}, n=1$ or $n=3$, we consider the $L^{2}\left(\mathbb{T}^{3}, \mathbb{R}^{n}\right)$ scalar product

\langle u, v\rangle_{L^{2}\left(\mathbb{T}^{3}, \mathbb{R}^{n}\right)}:=\Pi_{0}(u \cdot v) \tag{2.27}
\end{equation*}

where $\Pi_{0}$ is the space average defined in (1.13) and "." is the standard scalar product in $\mathbb{R}^{n}$. The adjoint of an operator mapping $H^{s}\left(\mathbb{T}^{\nu} \times \mathbb{T}^{3}, \mathbb{R}^{n}\right)$ into itself is considered with respect to the scalar product (2.27).

Lemma 2.8 (Adjoint). Let $m \in \mathbb{R}, s \geq s_{0}$ and $\mathcal{A}=\operatorname{Op}(A) \in \mathcal{O P} \mathcal{S}_{s+s_{0}+|m|, 0}^{m}$. Then the adjoint operator $\mathrm{Op}(A)^{*} \in \mathcal{O P} \mathcal{S}_{s, 0}^{m}$ and $\left|\mathrm{Op}(A)^{*}\right|_{m, s, 0}^{k_{0}, \gamma} \lesssim_{m}|\mathrm{Op}(A)|_{m, s+s_{0}+|m|, 0}^{k_{0}, \gamma}$.
Proof. For a matrix symbol $A=\left(A_{i k}\right)_{i, k=1,2,3}$, one computes $\operatorname{Op}(A)^{*}=\left(\operatorname{Op}\left(A_{k i}\right)^{*}\right)_{i, k=1,2,3}$. Then we argue as in Lemma in 2.16 [17] to each operator $\operatorname{Op}\left(A_{k i}\right)^{*}$.

Lemma 2.9 (Neumann series). Let $s \geq s_{0}$ and $\Psi \in \mathcal{O P} \mathcal{S}_{s, 0}^{-m}, m \geq 0$. There exists $\delta=\delta\left(s_{0}, k_{0}\right) \in(0,1)$ small enough such that, if $|\Psi|_{-m, s_{0}, 0}^{k_{0}, \gamma} \leq \delta$, then $\Phi=\operatorname{Id}+\Psi$ is invertible and $\left|\Phi^{-1}-\mathrm{Id}\right|_{-m, s, 0}^{k_{0}, \gamma} \lesssim_{s, k_{0}}|\Psi|_{-m, s, 0}^{k_{0}, \gamma}$. Proof. See Lemma 2.17 in (17.

### 2.2 Some conjugations with changes of variables

In the next lemma we exploit some properties of some pseudo-differential operators conjugated by a change of variables. We will always assume the hypotheses of Lemma 2.3.
Lemma 2.10. Let $S>s_{0}, \alpha(\cdot ; \lambda) \in H^{S}, M(\cdot ; \lambda)=\left(a_{i j}(\cdot ; \lambda)\right)_{i, j=1,2,3} \in H^{S}$ and $\|\alpha\|_{s_{0}}^{k_{0}, \gamma} \leq \delta$ for some $\delta \in(0,1)$ small enough. Then $\mathcal{A}^{-1} \mathrm{Op}(M) \mathcal{A}$ is the multiplication operator by the $3 \times 3$ matrix $\widetilde{M}(\varphi, y)=$ $M(\varphi, y+\breve{\alpha}(\varphi, y))$. Moreover for any $s_{0} \leq s \leq S, \beta \in \mathbb{N}$

|\operatorname{Op}(\widetilde{M})|_{0, s, \beta}=\|\widetilde{M}\|_{s}^{k_{0}, \gamma} \lesssim_{s, k_{0}}\|M\|_{s}^{k_{0}, \gamma}+\|\alpha\|_{s}^{k_{0}, \gamma}\|M\|_{s_{0}}^{k_{0}, \gamma}
$$

Proof. The lemma is a straightforward consequence of Lemma 2.3 (ii) and the estimate (2.23).

Lemma 2.11. Let $S>s_{0}, \alpha(\cdot ; \lambda) \in H^{S+1}, a(\cdot ; \lambda) \in H^{S}$ and $\|\alpha\|_{s_{0}+1}^{k_{0}, \gamma} \leq \delta$ for some $\delta \in(0,1)$ small enough. Then for any $s_{0} \leq s \leq S, \beta \in \mathbb{N}, \mathcal{A}^{-1} a \cdot \nabla \mathcal{A}=\operatorname{Op}\left(M_{\nabla}\right) \in \mathcal{O} \mathcal{P} \mathcal{S}_{s, \beta}^{1}$ and $\mathcal{A}^{-1} \operatorname{curl} \mathcal{A}=\operatorname{Op}\left(M_{\text {curl }}\right) \in \mathcal{O P} \mathcal{S}_{s, \beta}^{1}$. The following estimates hold for any $s_{0} \leq s \leq S$ :

& \left|\mathcal{A}^{-1} a \cdot \nabla \mathcal{A}\right|_{1, s, \beta}^{k_{0}, \gamma} \lesssim_{s, k_{0}, \beta}\|a\|_{s}^{k_{0}, \gamma}+\|\alpha\|_{s+1}^{k_{0}, \gamma}\|a\|_{s_{0}}^{k_{0}, \gamma} \\
& \left|\mathcal{A}^{-1} \operatorname{curl} \mathcal{A}\right|_{1, s, \beta}^{k_{0}, \gamma} \lesssim_{s, k_{0}, \beta} 1+\|\alpha\|_{s+1}^{k_{0}, \gamma}
\end{aligned}
$$

Furthermore, the symbols $M_{\nabla}, M_{\text {curl }}$ satisfy the symmetry conditions

$$
M_{\nabla}(\varphi, x, \xi)=-M_{\nabla}(\varphi, x,-\xi), \quad M_{\mathrm{curl}}(\varphi, x, \xi)=-M_{\mathrm{curl}}(\varphi, x,-\xi)
$$

Proof. By recalling the definition of curl given in (1.9), it suffices only to analyze for any $i=1,2,3$ the operator $\mathcal{M}:=\mathcal{A}^{-1} \partial_{x_{i}} \mathcal{A}$. A direct calculation shows that $\mathcal{M}=\partial_{x_{i}}+\mathcal{A}^{-1}\left[\partial_{x_{i}} \alpha\right] \cdot \nabla$. This immediately implies that $\mathcal{M}=\operatorname{Op}(M) \in \mathcal{O P} \mathcal{S}_{s, k}^{1}$ for any $k \in \mathbb{N}$ and $M(\varphi, x, \xi)=-M(\varphi, x,-\xi)$. Moreover by applying the estimates (2.9), (2.10), (2.23) and the trivial fact that $\left|\partial_{x_{j}}\right|_{1, s, k} \lesssim 1$ for any $s, k$ one gets the estimate $|\mathcal{M}|_{1, s, \beta}^{k_{0}, \gamma} \lesssim_{s, \beta, k_{0}} 1+\|\alpha\|_{s+1}^{k_{0}, \gamma}$.

In the following we analyze the conjugation of the operator $\Lambda^{-1}$ by means of a change of variables, where we recall that $\Lambda:=\Pi_{0}-\Delta$. Note that the action of the operator $\Lambda$ on a function $u \in H^{2}\left(\mathbb{T}^{3}, \mathbb{R}\right)$ is given by

\Lambda u(x)=\widehat{u}(0)+\sum_{\xi \in \mathbb{Z}^{3} \backslash\{0\}}|\xi|^{2} \widehat{u}(\xi) e^{\mathrm{i} x \cdot \xi}

We identify the operator $\Lambda$ with $\operatorname{Op}(\lambda(\xi))$ where

\begin{align*}
& \lambda \in \mathcal{C}^{\infty}\left(\mathbb{R}^{3}, \mathbb{R}\right), \quad \lambda(\xi)=\lambda(-\xi), \quad \inf _{\xi \in \mathbb{R}^{3}} \lambda(\xi)>0  \tag{2.28}\\
& \lambda(\xi)=|\xi|^{2} \quad \text { if } \quad|\xi| \geq 1 \quad \text { and } \quad \lambda(0)=1
\end{align*}
$$

The inverse of $\Lambda$ is computed explicitly on periodic functions as

$$
\Lambda^{-1} u(x)=\widehat{u}(0)+\sum_{\xi \in \mathbb{Z}^{3} \backslash\{0\}} \frac{1}{|\xi|^{2}} \widehat{u}(\xi) e^{\mathrm{i} x \cdot \xi}
$$

Then for any $s, \beta \geq 0$

$$
\begin{equation*}
|\Lambda|_{2, s, \beta},\left|\Lambda^{-1}\right|_{-2, s, \beta} \lesssim_{\beta} 1 \tag{2.29}
\end{equation*}
$$

We also identify the projector $\Pi_{0}$ with $\operatorname{Op}\left(\chi_{0}(\xi)\right)$ where $\chi_{0} \in \mathcal{C}^{\infty}\left(\mathbb{R}^{3}, \mathbb{R}\right)$ satisfies

$$
\begin{align*}
& \chi_{0} \in \mathcal{C}^{\infty}\left(\mathbb{R}^{3}, \mathbb{R}\right), \quad \chi_{0}(\xi)=\chi_{0}(-\xi), \quad 0 \leq \chi_{0} \leq 1, \quad \chi_{0}(0)=1 \\
& \operatorname{supp}\left(\chi_{0}\right) \subset\left\{\xi \in \mathbb{R}^{3}:|\xi| \leq \frac{1}{2}\right\} \tag{2.30}
\end{align*}
$$

Hence for any $m, \alpha, s \geq 0$

$$
\begin{equation*}
\left|\Pi_{0}\right|_{-m, s, \alpha} \lesssim_{m, \alpha} 1 \tag{2.31}
\end{equation*}
$$

Lemma 2.12. $S>s_{0}, \alpha(\cdot ; \lambda) \in H^{S+2}$ and $\|\alpha\|_{s_{0}+2}^{k_{0}, \gamma} \leq \delta$ for some $\delta=\delta\left(k_{0}, \nu\right) \in(0,1)$ small enough. Then $\mathcal{P}_{\Lambda}:=\mathcal{A}^{-1} \Lambda \mathcal{A}=\Lambda+\mathcal{P}_{2}+\mathcal{P}_{1}$ where, for $s_{0} \leq s \leq S, \mathcal{P}_{2}=\operatorname{Op}\left(P_{2}\right) \in \mathcal{O} \mathcal{P} \mathcal{S}_{s, 1}^{2}, \mathcal{P}_{1} \in \mathcal{O} \mathcal{P} \mathcal{S}_{s, 0}^{1}$ satisfy the estimates

$$
\left|\mathcal{P}_{2}\right|_{2, s, 1}^{k_{0}, \gamma},\left|\mathcal{P}_{1}\right|_{1, s, 1}^{k_{0}, \gamma} \lesssim_{s, k_{0}}\|\alpha\|_{s+\mu}^{k_{0}, \gamma} .
$$

Furthermore, the symbol $P_{2}$ satisfies the symmetry condition $P_{2}(\varphi, x, \xi)=P_{2}(\varphi, x,-\xi)$.
Proof. The assumption of the lemma allows to apply Lemma 2.3 on the change of variables. A direct calculation shows that $-\mathcal{A}^{-1} \Delta \mathcal{A}$ is an elliptic operator of the form

$$
\begin{equation*}
-\mathcal{A}^{-1} \Delta \mathcal{A}=-\Delta-\sum_{i, j=1}^{3} a_{i j}(\varphi, x) \partial_{x_{i} x_{j}}+\sum_{i=1}^{3} b_{i}(\varphi, x) \partial_{x_{i}} \tag{2.32}
\end{equation*}
$$

with

$$
\begin{equation*}
\left\|a_{i j}\right\|_{s}^{k_{0}, \gamma},\left\|b_{i}\right\|_{s}^{k_{0}, \gamma} \lesssim_{s, k_{0}}\|\alpha\|_{s+2}^{k_{0}, \gamma}, \quad i, j=1,2,3 \tag{2.33}
\end{equation*}
$$

Recalling the definition of $\Pi_{0}$ given in (1.13) and using that $\mathcal{A}, \mathcal{A}^{-1}$ are of the form (2.8), one computes

$$
\begin{equation*}
\Pi_{0} \mathcal{A}=\Pi_{0}+\Pi_{0}(\mathcal{A}-\mathrm{Id}) \tag{2.34}
\end{equation*}
$$

and

$$
\Pi_{0}((\mathcal{A}-\mathrm{Id}) h)=\Pi_{0}\left(q_{0} h\right), \quad q_{0}(\varphi, x):=(\mathcal{A}-\mathrm{Id})^{*}[1]=\operatorname{det}(\mathrm{I}+D \breve{\alpha}(\varphi, x))-1 .
$$

Then using (2.23), Lemma 2.7 (iii) and the trivial facts that $\left|\Pi_{0}\right|_{0, s, 0} \leq 1$, one obtains that $\Pi_{0}(\mathcal{A}-\mathrm{Id}) \in$ $\mathcal{O} \mathcal{P} \mathcal{S}_{s, 1}^{0}$, with

$$
\begin{equation*}
\left|\Pi_{0}(\mathcal{A}-\mathrm{Id})\right|_{0, s, 1}^{k_{0}, \gamma} \lesssim_{s, k_{0}}\|\alpha\|_{s+1}^{k_{0}, \gamma} \tag{2.35}
\end{equation*}
$$

Since $\mathcal{A}^{-1} \Pi_{0}=\Pi_{0}$, by (2.32), (2.34), one gets that

$$
\begin{align*}
& \mathcal{A}^{-1} \Lambda \mathcal{A}=\Lambda+\mathcal{P}_{2}+\mathcal{P}_{1}, \\
& \mathcal{P}_{2}:=-\sum_{i, j=1}^{3} a_{i j}(\varphi, x) \partial_{x_{i} x_{j}}, \quad \mathcal{P}_{1}:=\sum_{i=1}^{3} b_{i}(\varphi, x) \partial_{x_{i}}+\Pi_{0}(\mathcal{A}-\mathrm{Id}) . \tag{2.36}
\end{align*}
$$

By (2.23), Lemma 2.7, using that $\left|\partial_{x_{i} x_{j}}\right|_{2, s, 1},\left|\partial_{x_{i}}\right|_{1, s, 1} \lesssim 1$ and the estimates (2.33), (2.35) one gets the claimed bounds on $\mathcal{P}_{1}$ and $\mathcal{P}_{2}$. Moreover by the formula (2.36), one deduces that the symbol of the operator $\mathcal{P}_{2}$ is $P_{2}(\varphi, x, \xi)=\sum_{i, j=1}^{3} a_{i j}(\varphi, x) \xi_{i} \xi_{j}$, which is even with respect to the variable $\xi$.

Lemma 2.13. Let $s>s_{0}, \alpha(\cdot ; \lambda) \in H^{s+\mu}$, and $\|\alpha\|_{s_{0}+\mu}^{k_{0}, \gamma} \leq \delta$ for some $\delta=\delta\left(s, k_{0}, \nu\right) \in(0,1)$ small enough and some $\mu=\mu\left(k_{0}, \nu\right)>0$ large enough. Then $\mathcal{P}_{\Lambda}:=\mathcal{A}^{-1} \Lambda \mathcal{A}$ defined in Lemma 2.12 is invertible and its inverse is of the form

$$
\mathcal{P}_{\Lambda}^{-1}=\mathcal{A}^{-1} \Lambda^{-1} \mathcal{A}=\mathcal{P}_{-2}+\mathcal{P}_{-3}
$$

where $\mathcal{P}_{-2}=\operatorname{Op}\left(P_{-2}\right) \in \mathcal{O} \mathcal{P}_{s, 1}^{-2}, \mathcal{P}_{-3} \in \mathcal{O} \mathcal{P}_{s, 0}^{-3}$ satisfy the estimates

$$
\left|\mathcal{P}_{-2}\right|_{-2, s, 1}^{k_{0}, \gamma},\left|\mathcal{P}_{-3}\right|_{-3, s, 0}^{k_{0}, \gamma} \lesssim_{s, k_{0}} 1+\|\alpha\|_{s+\mu}^{k_{0}, \gamma}
$$

Furthermore, the symbol $P_{-2}$ satisfies the symmetry condition $P_{-2}(\varphi, x, \xi)=P_{-2}(\varphi, x,-\xi)$.
Proof. By Lemma 2.12 we write the operator $\mathcal{P}_{\Lambda}=\Lambda+\mathcal{P}_{2}+\mathcal{P}_{1}$ as

$$
\begin{equation*}
\mathcal{P}_{\Lambda}=\Lambda(\operatorname{Id}+\mathcal{F}), \quad \mathcal{F}:=\Lambda^{-1} \mathcal{P}_{2}+\Lambda^{-1} \mathcal{P}_{1} . \tag{2.37}
\end{equation*}
$$

Note that $\Lambda^{-1} \mathcal{P}_{2}$ is of order 0 and $\Lambda^{-1} \mathcal{P}_{1}$ is of order -1 . Define

$$
\begin{equation*}
\mathcal{F}_{0}:=\operatorname{Op}\left(F_{0}(\varphi, x, \xi)\right), \quad F_{0}(\varphi, x, \xi):=\lambda(\xi)^{-1} P_{2}(\varphi, x, \xi), \quad \mathcal{F}_{-1}:=\mathcal{F}-\mathcal{F}_{0} \tag{2.38}
\end{equation*}
$$

(in fact, $\mathcal{F}_{0}=\mathcal{P}_{2} \Lambda^{-1}$ ). By applying Lemma 2.7 and the estimates of $\mathcal{P}_{1}, \mathcal{P}_{2}$ provided by Lemma 2.12 (recall also that $\Lambda \equiv \operatorname{Op}(\lambda)$, see (2.28) $)$ with $s$ replaced by $s+2$, one obtains the bounds

$$
\begin{equation*}
\left|\mathcal{F}_{0}\right|_{0, s+2,1}^{k_{0}, \gamma},\left|\mathcal{F}_{-1}\right|_{-1, s+2,1}^{k_{0}, \gamma} \lesssim_{s, k_{0}}\|\alpha\|_{s+\mu}^{k_{0}, \gamma} \tag{2.39}
\end{equation*}
$$

for some constant $\mu>0$. Moreover, since $\lambda(\xi)$ and the symbol $P_{2}(\varphi, x, \xi)$ are even functions of $\xi$, then also $F_{0}(\varphi, x, \xi)$ is even in $\xi$. By Lemma [2.9, using (2.39) and the hypothesis that $\|\alpha\|_{s_{0}+\mu}$ is small enough, we deduce that $\operatorname{Id}+\mathcal{F}$ is invertible, and its inverse satisfies the estimate

$$
\begin{equation*}
\left|(\operatorname{Id}-\mathcal{F})^{-1}\right|_{0, s, 0}^{k_{0}, \gamma} \lesssim s, k_{0} 1+\|\alpha\|_{s+\mu}^{k_{0}, \gamma} . \tag{2.40}
\end{equation*}
$$

By Lemma 2.7(ii) and (2.39) one has

$$
\begin{equation*}
\mathcal{F}_{0} \mathrm{Op}\left(\frac{1}{1+F_{0}}\right)=\mathrm{Op}\left(\frac{F_{0}}{1+F_{0}}\right)+\mathcal{R}_{F_{0}}, \quad\left|\mathcal{R}_{F_{0}}\right|_{-1, s, 0}^{k_{0}, \gamma} \lesssim s\|\alpha\|_{s+\mu}^{k_{0}, \gamma} \tag{2.41}
\end{equation*}
$$

Since $\mathcal{F}=\mathcal{F}_{0}+\mathcal{F}_{-1}$, one has

$$
\begin{aligned}
(\operatorname{Id}+\mathcal{F}) \operatorname{Op}\left(\frac{1}{1+F_{0}}\right) & =\operatorname{Op}\left(\frac{1}{1+F_{0}}\right)+\operatorname{Op}\left(\frac{F_{0}}{1+F_{0}}\right)+\mathcal{R}_{F_{0}}+\mathcal{F}_{-1} \mathrm{Op}\left(\frac{1}{1+F_{0}}\right) \\
& =\operatorname{Id}+\mathcal{R}_{F_{0}}+\mathcal{F}_{-1} \mathcal{G}, \quad \mathcal{G}:=\mathrm{Op}\left(\frac{1}{1+F_{0}}\right)
\end{aligned}
$$

whence, applying $(\operatorname{Id}+\mathcal{F})^{-1}$ from the left, we get

$$
\begin{equation*}
\mathcal{G}=(\operatorname{Id}+\mathcal{F})^{-1}-\mathcal{R}_{\mathcal{F}}, \quad \mathcal{R}_{\mathcal{F}}:=-(\operatorname{Id}+\mathcal{F})^{-1}\left(\mathcal{R}_{F_{0}}+\mathcal{F}_{-1} \mathcal{G}\right) \tag{2.42}
\end{equation*}
$$

Since $\frac{1}{1+F_{0}}=\sum_{n \geq 0}(-1)^{n} F_{0}^{n}$, by estimates (2.25), (2.39), using the assumption that $\|\alpha\|_{s_{0}+\mu}^{k_{0}, \gamma} \leq \delta$ is small enough, one gets

$$
\begin{equation*}
|\mathcal{G}|_{0, s, 1}^{k_{0}, \gamma} \lesssim s, k_{0} 1+\|\alpha\|_{s+\mu}^{k_{0}, \gamma} . \tag{2.43}
\end{equation*}
$$

Then, recalling (2.37) and using (2.42) to substitute $(\operatorname{Id}+\mathcal{F})^{-1}$, we get

$$
\mathcal{P}_{\Lambda}^{-1}=(\operatorname{Id}+\mathcal{F})^{-1} \Lambda^{-1}=\left(\mathcal{G}+\mathcal{R}_{\mathcal{F}}\right) \Lambda^{-1}=\mathcal{P}_{-2}+\mathcal{P}_{-3}
$$

with

$$
\mathcal{P}_{-2}=\mathcal{G} \Lambda^{-1}=\mathrm{Op}\left(P_{-2}\right), \quad P_{-2}(\varphi, x, \xi):=\frac{1}{\lambda(\xi)\left(1+F_{0}(\varphi, x, \xi)\right)}, \quad \mathcal{P}_{-3}:=\mathcal{R}_{\mathcal{F}} \Lambda^{-1}
$$

Since $F_{0}$ and $\lambda$ are even in $\xi$, then $P_{-2}$ is also even in $\xi$.
By (2.40), (2.41), (2.42), (2.43) we get $\left|\mathcal{R}_{\mathcal{F}}\right|_{-1, s, 0}^{k_{0}, \gamma} \lesssim s, k_{0}\|\alpha\|_{s+\mu}^{k_{0}, \gamma}$. Thus the estimates for $\mathcal{P}_{-2}, \mathcal{P}_{-3}$ follow by the composition estimates of Lemma 2.7 and by using (2.29).

### 2.3 Matrix representation of linear operators

Let us consider a linear matrix operator $\mathcal{R}=\left(\mathcal{R}_{i k}\right)_{i, k=1,2,3}: L^{2}\left(\mathbb{T}^{3}, \mathbb{R}^{3}\right) \rightarrow L^{2}\left(\mathbb{T}^{3}, \mathbb{R}^{3}\right)$ where $\mathcal{R}_{i k}$ : $L^{2}\left(\mathbb{T}^{3}, \mathbb{R}\right) \rightarrow L^{2}\left(\mathbb{T}^{3}, \mathbb{R}\right)$ for any $i, k=1,2,3$. Such an operator can be represented as

$$
\begin{equation*}
\mathcal{R} u(x):=\sum_{j, j^{\prime} \in \mathbb{Z}^{3}} \mathcal{R}_{j}^{j^{\prime}}\left[\widehat{u}\left(j^{\prime}\right)\right] e^{\mathrm{i} j \cdot x}, \quad \text { for } u(x)=\sum_{j \in \mathbb{Z}^{3}} \widehat{u}(j) e^{\mathrm{i} \cdot x} \tag{2.44}
\end{equation*}
$$

where, for $j, j^{\prime} \in \mathbb{Z}^{3}, \mathcal{R}_{j}^{j^{\prime}}$ is the $3 \times 3$ matrix defined by

$$
\begin{equation*}
\mathcal{R}_{j}^{j^{\prime}}:=\left(\left(\mathcal{R}_{i k}\right)_{j}^{j^{\prime}}\right)_{i, k=1,2,3}, \quad\left(\mathcal{R}_{i k}\right)_{j}^{j^{\prime}}:=\frac{1}{(2 \pi)^{3}} \int_{\mathbb{T}^{3}} \mathcal{R}_{i k}\left[e^{\mathrm{i} j^{\prime} \cdot x}\right] e^{-\mathrm{i} j \cdot x} d x \tag{2.45}
\end{equation*}
$$

It is immediate to check that the matrix representation (2.44) of the operator $\mathcal{R}$ is equivalent to the pseudodifferential representation $\mathcal{R}=\operatorname{Op}(r)$, namely $\mathcal{R} u(x)=\sum_{\xi \in \mathbb{Z}^{3}} r(x, \xi) \hat{u}(\xi) e^{\mathrm{i} \xi \cdot x}$, where the symbol $r(x, \xi)$, for $\xi=j^{\prime} \in \mathbb{Z}^{3}$, is the $3 \times 3$ matrix given by

$$
\begin{equation*}
r\left(x, j^{\prime}\right)=\sum_{j \in \mathbb{Z}^{3}} R_{j}^{j^{\prime}} e^{\mathrm{i}\left(j-j^{\prime}\right) \cdot x} \tag{2.46}
\end{equation*}
$$

Thus $R_{j}^{j^{\prime}}$ is the Fourier coefficient $\hat{r}\left(j-j^{\prime}, j^{\prime}\right)$ of frequency $j-j^{\prime}$ of the function $x \mapsto r\left(x, j^{\prime}\right)$.
Definition 2.14 (Block-diagonal operator). We say that an operator $\mathcal{R}$ as in (2.44)-(2.45) is a $3 \times 3$ block-diagonal operator if $\mathcal{R}_{j}^{j^{\prime}}=0$ for all $j, j^{\prime} \in \mathbb{Z}^{3}$ with $j \neq j^{\prime}$.

By (2.46), $\mathcal{R}$ is a block-diagonal operator if and only if the symbol $r\left(x, j^{\prime}\right)$ does not depend on $x$.
We also consider smooth $\varphi$-dependent families of linear operators $\mathbb{T}^{\nu} \rightarrow \mathcal{B}\left(L^{2}\left(\mathbb{T}^{3}, \mathbb{R}^{3}\right)\right), \varphi \mapsto \mathcal{R}(\varphi)$, which we write in Fourier series with respect to $\varphi$ as

$$
\mathcal{R}(\varphi)=\sum_{\ell \in \mathbb{Z}^{\nu}} \widehat{\mathcal{R}}(\ell) e^{\mathrm{i} \ell \cdot \varphi}, \quad \widehat{\mathcal{R}}(\ell):=\frac{1}{(2 \pi)^{\nu}} \int_{\mathbb{T}^{\nu}} \mathcal{R}(\varphi) e^{-\mathrm{i} \ell \cdot \varphi} d \varphi, \quad \ell \in \mathbb{Z}^{\nu}
$$

According to (2.45), for any $\ell \in \mathbb{Z}^{\nu}$, the linear operator $\widehat{\mathcal{R}}(\ell) \in \mathcal{B}\left(L^{2}\left(\mathbb{T}^{3}, \mathbb{R}^{3}\right)\right)$ is identified with the matrix $\left(\widehat{\mathcal{R}}(\ell)_{j}^{j^{\prime}}\right)_{j, j^{\prime} \in \mathbb{Z}^{3}}$ where each entry $\widehat{\mathcal{R}}(\ell)_{j}^{j^{\prime}}$ belongs to $\operatorname{Mat}_{3 \times 3}(\mathbb{C})$. A map $\mathbb{T}^{\nu} \rightarrow \mathcal{B}\left(L^{2}\left(\mathbb{T}^{3}, \mathbb{R}^{3}\right)\right), \varphi \mapsto \mathcal{R}(\varphi)$ can be also regarded as a linear operator $L^{2}\left(\mathbb{T}^{\nu+3}, \mathbb{R}^{3}\right) \rightarrow L^{2}\left(\mathbb{T}^{\nu+3}, \mathbb{R}^{3}\right)$ by

$$
\begin{equation*}
\mathcal{R} u(\varphi, x):=\sum_{\substack{\ell, \ell^{\prime} \in \mathbb{Z}^{\nu} \\ j, j^{\prime} \in \mathbb{Z}^{3}}} \widehat{\mathcal{R}}\left(\ell-\ell^{\prime}\right)_{j}^{j^{\prime}} \widehat{u}\left(\ell^{\prime}, j^{\prime}\right) e^{\mathrm{i}(\ell \cdot \varphi+j \cdot x)}, \quad \forall u \in L^{2}\left(\mathbb{T}^{\nu+3}, \mathbb{R}^{3}\right) \tag{2.47}
\end{equation*}
$$

The representation (2.47) of the operator $\mathcal{R}$ is also equivalent to the pseudo-differential representation $\mathcal{R}=\mathrm{Op}(r)$, where the symbol $r(\varphi, x, \xi)$, for $\xi=j^{\prime} \in \mathbb{Z}^{3}$, is

$$
\begin{equation*}
r\left(\varphi, x, j^{\prime}\right)=\sum_{j \in \mathbb{Z}^{3}} R_{j}^{j^{\prime}}(\varphi) e^{\mathrm{i}\left(j-j^{\prime}\right) \cdot x} \tag{2.48}
\end{equation*}
$$

which is, in fact, (2.46) with, in addition, the dependence on $\varphi$. Similarly as above, $R_{j}^{j^{\prime}}(\varphi)$ is the Fourier coefficient $\hat{r}\left(\varphi, j-j^{\prime}, j^{\prime}\right)$ of frequency $j-j^{\prime}$ of the function $x \mapsto r\left(\varphi, x, j^{\prime}\right)$. If we expand both $\hat{u}\left(\varphi, j^{\prime}\right)$ and $\hat{r}\left(\varphi, j-j^{\prime}, j^{\prime}\right)$ in Fourier series also in the $\varphi$ variable, we deduce that $\widehat{\mathcal{R}}\left(\ell-\ell^{\prime}\right)_{j}^{j^{\prime}}$ appearing in (2.47) is the Fourier coefficient of frequency $\left(\ell-\ell^{\prime}, j-j^{\prime}\right)$ of the function $(\varphi, x) \mapsto r\left(\varphi, x, j^{\prime}\right)$.
Definition 2.15. (Matrix decay norm) Let $\mathcal{R}$ be an operator represented by the matrix in (2.47). For $s \geq 0$, we define its matrix decay norm

$$
\begin{equation*}
|\mathcal{R}|_{s}:=\sup _{j^{\prime} \in \mathbb{Z}^{3}}\left(\sum_{(\ell, j) \in \mathbb{Z}^{\nu+3}}\left\langle\ell, j-j^{\prime}\right\rangle^{2 s}\left\|\widehat{\mathcal{R}}(\ell)_{j}^{j^{\prime}}\right\|_{\mathrm{HS}}^{2}\right)^{\frac{1}{2}} \tag{2.49}
\end{equation*}
$$

If the operator $\mathcal{R}=\mathcal{R}(\lambda)$ is $k_{0}$ times differentiable in $\mathbb{R}^{\nu+3}$, we define for $s \geq s_{0}$

$$
\begin{equation*}
|\mathcal{R}|_{s}^{k_{0}, \gamma}:=\sup _{|k| \leq k_{0}} \gamma^{|k|} \sup _{\lambda \in \mathbb{R}^{\nu+3}}\left|\partial_{\lambda}^{k} \mathcal{R}(\lambda)\right|_{s-|k|} \tag{2.50}
\end{equation*}
$$

Remark 2.16. The definition of the norm $|\mathcal{R}|_{s}$ in (2.49) is very similar to the one of the norm $|\mathcal{R}|_{0, s, 0}$ in (2.19) : the only difference is that the sup in (2.49) is over $j^{\prime} \in \mathbb{Z}^{3}$ (which is the natural choice when using matrices with row and column indices in $\mathbb{Z}^{3}$ ), while the sup in (2.19) is over $\xi \in \mathbb{R}^{3}$ (which is the natural choice when derivatives of symbols with respect to $\xi$ have to be considered to prove composition formulas like in Lemma 2.7-(ii)). In fact, the norms $|\cdot|_{s}$ and $|\cdot|_{0, s, 0}$ are equivalent for operators acting on periodic functions.

The norm $\left.|\cdot|\right|_{s} ^{k_{0}, \gamma}$ is increasing, namely $|\mathcal{R}|_{s}^{k_{0}, \gamma} \leq|\mathcal{R}|_{s^{\prime}}^{k_{0}, \gamma}$ for all $s \leq s^{\prime}$. Moreover $|\mathcal{R}|_{s}^{k_{0}, \gamma} \leq\left|\mathcal{R}\langle D\rangle^{m}\right|_{s}^{k_{0}, \gamma}$ for all $m \geq 0$. We now state some standard properties of the decay norms that are needed for the reducibiity scheme of Section 8 .
Lemma 2.17. (i) Let $s \geq s_{0},|\mathcal{R}|_{s}^{k_{0}, \gamma},\|u\|_{s}^{k_{0}, \gamma}<\infty$. Then

$$
\|\mathcal{R} u\|_{s}^{k_{0}, \gamma} \lesssim_{s, k_{0}}|\mathcal{R}|_{s_{0}}^{k_{0}, \gamma}\|u\|_{s}^{k_{0}, \gamma}+|\mathcal{R}|_{s}^{k_{0}, \gamma}\|u\|_{s_{0}}^{k_{0}, \gamma}
$$

(ii) Let $s \geq s_{0},|\mathcal{R}|_{s}^{k_{0}, \gamma},|\mathcal{Q}|_{s}^{k_{0}, \gamma}<\infty$. Then

$$
|\mathcal{R} \mathcal{Q}|_{s}^{k_{0}, \gamma} \lesssim_{s, k_{0}}|\mathcal{R}|_{s}^{k_{0}, \gamma}|\mathcal{Q}|_{s_{0}}^{k_{0}, \gamma}+|\mathcal{R}|_{s_{0}}^{k_{0}, \gamma}|\mathcal{Q}|_{s}^{k_{0}, \gamma}
$$

(iii) Let $s \geq s_{0},|\mathcal{R}|_{s}^{k_{0}, \gamma}<\infty$. Then there exists a constant $C\left(s, k_{0}\right)>0$ such that, for any integer $n \geq 1$,

\left|\mathcal{R}^{n}\right|_{s}^{k_{0}, \gamma} \leq C(s, k)^{n-1}\left(|\mathcal{R}|_{s_{0}}^{k_{0}, \gamma}\right)^{n-1}|\mathcal{R}|_{s}^{k_{0}, \gamma}
$$

(iv) Let $s \geq s_{0},|\mathcal{R}|_{s}^{k_{0}, \gamma}<\infty$. Then there exists $\delta\left(s, k_{0}\right) \in(0,1)$ small enough such that, if $|\mathcal{R}|_{s_{0}}^{k_{0}, \gamma} \leq \delta\left(s, k_{0}\right)$, then the map $\Phi=\operatorname{Id}+\mathcal{R}$ is invertible and the inverse satisfies the estimate

\left|\Phi^{-1}-\mathrm{Id}\right|_{s}^{k_{0}, \gamma} \lesssim_{s, k_{0}}|\mathcal{R}|_{s}^{k_{0}, \gamma}
$$

(v) Let $s \geq s_{0},|\mathcal{R}|_{s}^{k_{0}, \gamma}<\infty$ and let $\mathcal{Z}$ be the $3 \times 3$ block-diagonal operator defined by $\mathcal{Z}=\operatorname{diag}_{j \in \mathbb{Z}^{3}} \widehat{\mathcal{R}}_{j}^{j}(0)$. Then $|\mathcal{Z}|_{s}^{k_{0}, \gamma} \lesssim|\mathcal{R}|_{s}^{k_{0}, \gamma}$. As a consequence,

$$
\left\|\widehat{\mathcal{R}}_{j}^{j}(0)\right\|_{\mathrm{HS}}^{k_{0}, \gamma} \lesssim|\mathcal{R}|_{s_{0}}^{k_{0}, \gamma}
$$

For $N>0$, we define the operator $\Pi_{N} \mathcal{R}$ by means of its $3 \times 3$ block representation in the following way:

$$
\left(\widehat{\Pi_{N} \mathcal{R}}\right)_{j}^{j^{\prime}}(\ell):=\left\{\begin{array}{ll}
\widehat{\mathcal{R}}_{j}^{j^{\prime}}(\ell) & \text { if }|\ell|,\left|j-j^{\prime}\right| \leq N,  \tag{2.51}\\
0 & \text { otherwise. }
\end{array} \quad \quad \text { Moreover, } \Pi_{N}^{\perp} \mathcal{R}:=\mathcal{R}-\Pi_{N} \mathcal{R}\right.
$$

Lemma 2.18. For all $s, \alpha \geq 0$, one has $\left|\Pi_{N} \mathcal{R}\right|_{s+\alpha}^{k_{0}, \gamma} \leq N^{\alpha}|\mathcal{R}|_{s}^{k_{0}, \gamma}$ and $\left|\Pi_{N}^{\perp} \mathcal{R}\right|_{s}^{k_{0}, \gamma} \leq N^{-\alpha}|\mathcal{R}|_{s+\alpha}^{k_{0}, \gamma}$.
By (2.47), (2.48), as observed in Remark 2.16, the decay norms 2.15 and the pseudo-differential norms 2.5 are strictly related; in the next lemma (whose proof is a simple check) we state a link between these norms.

Lemma 2.19. Let $s \geq s_{0}, \mathcal{R} \in \mathcal{O} \mathcal{P} \mathcal{S}_{s, 0}^{0}$. Then $|\mathcal{R}|_{s}^{k_{0}, \gamma} \lesssim|\mathcal{R}|_{0, s, 0}^{k_{0}, \gamma}$.

### 2.4 Real and reversible operators

Remember that, for any function $u(\varphi, x), u \in X$ means $u=\operatorname{even}(\varphi, x)$, and $u \in Y$ means $u=\operatorname{odd}(\varphi, x)$.
Definition 2.20. (i) We say that a linear operator $\Phi$ is reversible if $\Phi: X \rightarrow Y$ and $\Phi: Y \rightarrow X$. We say that $\Phi$ is reversibility preserving if $\Phi: X \rightarrow X$ and $\Phi: Y \rightarrow Y$.
(i) We say that an operator $\Phi: L^{2}\left(\mathbb{T}^{3}, \mathbb{C}^{3}\right) \rightarrow L^{2}\left(\mathbb{T}^{3}, \mathbb{C}^{3}\right)$ is real if $\Phi(u) \in L^{2}\left(\mathbb{T}^{3}, \mathbb{R}^{3}\right)$ for any $u \in L^{2}\left(\mathbb{T}^{3}, \mathbb{R}^{3}\right)$.

Lemma 2.21. Let $A=\operatorname{Op}(a) \in \mathcal{O} \mathcal{P} \mathcal{S}_{s, \alpha}^{m}$. Then the following holds:
(i) $A$ is reversible if and only if $a(\varphi, x, \xi)=-a(-\varphi,-x,-\xi)$, namely $a=\operatorname{odd}(\varphi, x, \xi)$;
(ii) $A$ is reversibility preserving if and only if $a(\varphi, x, \xi)=a(-\varphi,-x,-\xi)$, namely $a=$ even $(\varphi, x, \xi)$.
(iii) $A$ is real if and only if $a(\varphi, x, \xi)=\overline{a(\varphi, x,-\xi)}$.

It can be convenient to reformulate real and reversibility properties of linear operators in terms of matrix representation provided in Section 2.3 .

Lemma 2.22. A linear operator $\mathcal{R}$ is (i) real if and only if $\widehat{\mathcal{R}}_{j}^{j^{\prime}}(\ell)=\widehat{\mathcal{R}}_{-j}^{-j^{\prime}}(-\ell)$ for all $\ell \in \mathbb{Z}^{\nu}, j, j^{\prime} \in \mathbb{Z}^{3}$;
(ii) reversible if and only if $\widehat{\mathcal{R}}_{j}^{j^{\prime}}(\ell)=-\widehat{\mathcal{R}}_{-j}^{-j^{\prime}}(-\ell)$ for all $\ell \in \mathbb{Z}^{\nu}, j, j^{\prime} \in \mathbb{Z}^{3}$;
(iii) reversibility-preserving if and only if $\widehat{\mathcal{R}}_{j}^{j^{\prime}}(\ell)=\widehat{\mathcal{R}}_{-j}^{-j^{\prime}}(-\ell)$ for all $\ell \in \mathbb{Z}^{\nu}, j, j^{\prime} \in \mathbb{Z}^{3}$.

## 3 The linearized operator

In sections 348 we assume the following ansatz, which will be recursively verified along the Nash-Moser iteration. We assume that $v \in \mathcal{C}^{\infty}\left(\mathbb{T}^{\nu} \times \mathbb{T}^{3}, \mathbb{R}^{3}\right), v=\operatorname{odd}(\varphi, x)$, and

\begin{equation*}
\|v\|_{\mu_{0}}^{k_{0}, \gamma} \leq 1 \tag{3.1}
\end{equation*}
$$

where $\mu_{0}=\mu_{0}\left(\nu, \tau, k_{0}\right)>0$ is large enough.
As we explained at the beginning of Section 2 from now on we omit to write the dependence on $k_{0}$ when we write $\lesssim$, namely we write $\lesssim_{s, m}, \lesssim_{s} \ldots$ instead of $\lesssim_{s, m, k_{0}}, \lesssim_{s, k_{0}} \ldots$
Given a function $f$ depending on $u$, we denote by

$$
\begin{equation*}
\Delta_{12} f:=f\left(u_{1}\right)-f\left(u_{2}\right) \tag{3.2}
\end{equation*}
$$

We want to study the linearized operator $\mathcal{L}:=\mathcal{F}^{\prime}(v)$, where $\mathcal{F}(v)$ is defined in (1.17). Using the identity $\Pi_{0}^{\perp}=\operatorname{Id}-\Pi_{0}$, for all $s \geq s_{0}$ one has

$$
\begin{equation*}
\mathcal{L}: H_{0}^{s+1} \rightarrow H_{0}^{s}, \quad \mathcal{L}=\Pi_{0}^{\perp}\left(\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla+\varepsilon a(\varphi, x) \cdot \nabla+\varepsilon \mathcal{R}(\varphi)\right) \Pi_{0}^{\perp} \tag{3.3}
\end{equation*}
$$

where $a(\varphi, x)$ is the vector field

$$
\begin{equation*}
a(\varphi, x):=(\mathcal{U} v)(\varphi, x)=\operatorname{curl} \Lambda^{-1} v \tag{3.4}
\end{equation*}
$$

$\mathcal{U}:=\operatorname{curl} \Lambda^{-1}$ is defined in (1.17), (1.15) (see also (2.28)), and $\mathcal{R}(\varphi)$ is a matrix-valued linear pseudodifferential operator of order zero, given by

$$
\begin{align*}
& \mathcal{R}:=\mathcal{R}_{0}+\mathcal{R}_{-1}, \\
& \mathcal{R}_{0} h:=M_{\mathcal{U}}(\varphi, x) h-v \cdot \nabla \mathcal{U}(h), \quad \mathcal{R}_{-1} h:=M_{v}(\varphi, x) \mathcal{U}(h),  \tag{3.5}\\
& M_{\mathcal{U}}(\varphi, x):=-D \mathcal{U}(v)(\varphi, x), \quad M_{v}(\varphi, x):=D v(\varphi, x)
\end{align*}
$$

where $D \mathcal{U}(v)$ is the jacobian matrix of $\mathcal{U}(v)=\operatorname{curl} \Lambda^{-1} v$ and $D v$ is the jacobian matrix of $v$. Note that $\mathcal{R}_{0}$ is an operator of order 0 and $\mathcal{R}_{-1}$ is an operator of order -1 . Note that since $v=\operatorname{odd}(\varphi, x)$, then

\begin{align*}
& M_{\mathcal{U}}=\operatorname{odd}(\varphi, x), \quad M_{v}=\operatorname{even}(\varphi, x),  \tag{3.6}\\
& \mathcal{R}_{0}, \mathcal{R}_{-1} \text { are reversible operators }
\end{align*}
$$

We first analyze the operator $\mathcal{L}$ without the projector $\Pi_{0}^{\perp}$, namely we consider the operator

$$
\begin{equation*}
\mathcal{L}^{(0)}:=\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla+\varepsilon a(\varphi, x) \cdot \nabla+\varepsilon \mathcal{R}(\varphi) . \tag{3.7}
\end{equation*}
$$

By the definitions (3.5) and using the product estimates (2.7), for $\|v\|_{s_{0}+1}^{k_{0}, \gamma} \leq 1$ the following tame estimates hold for any $s \geq s_{0}$ :

\|\varepsilon a(\varphi, x) \cdot \nabla h+\varepsilon \mathcal{R}(\varphi) h\|_{s}^{k_{0}, \gamma} \lesssim_{s} \varepsilon\left(\|h\|_{s+1}^{k_{0}, \gamma}+\|v\|_{s+1}^{k_{0}, \gamma}\|h\|_{s_{0}+1}^{k_{0}, \gamma}\right) . \tag{3.8}
\end{equation*}
$$

## 4 Reduction to constant coefficients of the highest order term

First we state a Proposition which allows to reduce to constant coefficients the operator

\mathcal{T}:=\omega \cdot \partial_{\varphi}+(\zeta+\varepsilon a(\varphi, x)) \cdot \nabla \tag{4.1}
\end{equation*}
$$

where we recall that, by (3.4), one has that

\Pi_{0} a=0 \quad \text { and } \quad \operatorname{div}(a)=0 . \tag{4.2}
\end{equation*}
$$

Proposition 4.1. For any $\gamma \in(0,1), \mathfrak{C}_{0}>0, S>s_{0}, \tau>0$ there exist $\delta=\delta\left(S, k_{0}, \tau, \nu\right), \mu_{0}=\mu_{0}\left(k_{0}, \tau, \nu\right)>$ 0 and $\tau_{1}=\tau_{1}\left(k_{0}, \tau, \nu\right)>0$ such that if (3.1) holds and

$$
\begin{equation*}
N_{0}^{\tau_{1}} \varepsilon \gamma^{-1} \leq \delta, \tag{4.3}
\end{equation*}
$$

then the following holds. There exists an invertible diffeomorphism $\mathbb{T}^{3} \rightarrow \mathbb{T}^{3}, x \mapsto x+\alpha(\varphi, x ; \omega, \zeta)$ with inverse $y \mapsto y+\breve{\alpha}(\varphi, y ; \omega, \zeta)$, defined for all $(\omega, \zeta) \in \mathbb{R}^{\nu+3}$, satisfying

$$
\begin{equation*}
\|\alpha\|_{s}^{k_{0}, \gamma},\|\breve{\alpha}\|_{s}^{k_{0}, \gamma} \lesssim s N_{0}^{\tau_{0}} \varepsilon \gamma^{-1}\|v\|_{s+\mu}^{k_{0}, \gamma}, \quad \forall s_{0} \leq s \leq S \tag{4.4}
\end{equation*}
$$

(with $\tau_{0}$ defined in (2.18)) such that, defining

$$
\begin{equation*}
\mathcal{A} h(\varphi, x):=h(\varphi, x+\alpha(\varphi, x)) \quad \text { with inverse } \quad \mathcal{A}^{-1} h(\varphi, y)=h(\varphi, y+\breve{\alpha}(\varphi, y)), \tag{4.5}
\end{equation*}
$$

one gets the conjugation

$$
\begin{equation*}
\mathcal{A}^{-1} \mathcal{T} \mathcal{A}=\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla \tag{4.6}
\end{equation*}
$$

for all $(\omega, \zeta) \in D C(\gamma, \tau)$, where

$$
\begin{equation*}
D C(\gamma, \tau):=\left\{\lambda=(\omega, \zeta) \in \mathbb{R}^{\nu+3}:|\omega \cdot \ell+\zeta \cdot j| \geq \frac{\mathfrak{C}_{0} \gamma}{\langle\ell, j\rangle^{\tau}} \quad \forall(\ell, j) \in \mathbb{Z}^{\nu+3} \backslash\{(0,0)\}\right\} . \tag{4.7}
\end{equation*}
$$

Furthermore $\alpha, \breve{\alpha}$ are $\operatorname{odd}(\varphi, x)$, and therefore $\mathcal{A}, \mathcal{A}^{-1}$ are reversibility preserving maps. Such maps satisfy the tame estimates

\begin{align*}
& \left\|\mathcal{A}^{ \pm 1} h\right\|_{s}^{k_{0}, \gamma} \lesssim_{s}\|h\|_{s}^{k_{0}, \gamma}+\|v\|_{s+\mu}^{k_{0}, \gamma}\|h\|_{s_{0}}^{k_{0}, \gamma}, \quad \forall s_{0} \leq s \leq S \\
& \left\|\left(\mathcal{A}^{ \pm 1}-\mathrm{Id}\right) h\right\|_{s}^{k_{0}, \gamma},\left\|\left(\mathcal{A}^{*}-\mathrm{Id}\right) h\right\|_{s}^{k_{0}, \gamma} \lesssim_{s} N_{0}^{\tau_{0}} \varepsilon \gamma^{-1}\left(\|v\|_{s_{0}+\mu}^{k_{0}, \gamma}\|h\|_{s+1}^{k_{0}, \gamma}+\|v\|_{s+\mu}^{k_{0}, \gamma}\|h\|_{s_{0}+1}^{k_{0}, \gamma}\right), \quad \forall s_{0} \leq s \leq S . \tag{4.8}
\end{align*}
$$

Let $s_{1} \geq s_{0}$ and assume that $v_{1}, v_{2}$ satisfy (3.1) with $\mu_{0} \geq s_{1}+\mu$. Then for any $\lambda=(\omega, \zeta) \in D C(\gamma, \tau)$ one has

$$
\begin{align*}
& \left\|\Delta_{12} \alpha\right\|_{s_{1}},\left\|\Delta_{12} \breve{\alpha}\right\|_{s_{1}} \lesssim s_{1} N_{0}^{\tau_{0}} \varepsilon \gamma^{-1}\left\|v_{1}-v_{2}\right\|_{s_{1}+\mu} \\
& \left\|\Delta_{12} \mathcal{A}^{ \pm 1} h\right\|_{s_{1}},\left\|\Delta_{12} \mathcal{A}^{*} h\right\|_{s_{1}} \lesssim s_{1} N_{0}^{\tau_{0}} \varepsilon \gamma^{-1}\left\|v_{1}-v_{2}\right\|_{s_{1}+\mu}\|h\|_{s_{1}+1} \tag{4.9}
\end{align*}
$$

Remark 4.2. In this section we only need that the constant $\mathfrak{C}_{0}$ in (4.7) is strictly bigger than one (see Lemma 4.5). In Lemma 10.4, we shall take the constant $\mathfrak{C}_{0} \geq C(\tau)$ large enough.

In order to prove Proposition 4.1, we closely follow [29]. First we show the following iterative Lemma. We fix the constants

\end{align*}
$$

and recall that $\tau_{0}$ is defined in Lemma 2.4 ,
Lemma 4.3. Let $\gamma \in(0,1), S>s_{0}, \tau>0$. Then there exist $\delta=\delta\left(S, k_{0}, \tau, \nu\right) \in(0,1), N_{0}=N_{0}\left(S, k_{0}, \tau, \nu\right)>$ $0, \mu=\mu\left(k_{0}, \tau, \nu\right)>0$ such that if (3.1), (4.3) are fullfilled with $\mu_{0} \geq s_{0}+\mu$, then the following statements hold for all $n \geq 0$.
There exists a linear operator

$$
\begin{equation*}
\mathcal{T}_{n}:=\omega \cdot \partial_{\varphi}+\mathrm{m}_{n} \cdot \nabla+a_{n}(\varphi, x) \cdot \nabla \tag{4.11}
\end{equation*}
$$

defined for any $\lambda=(\omega, \zeta) \in \mathbb{R}^{\nu+3}$ such that

\begin{array}{ll}
\left\|a_{n}\right\|_{s}^{k_{0}, \gamma} \leq C_{*}(s) \varepsilon N_{n-1}^{-\mathfrak{a}}\|v\|_{s+\mu}^{k_{0}, \gamma}, & \left\|a_{n}\right\|_{s+\mathfrak{b}}^{k_{0}, \gamma} \leq C_{*}(s) N_{n-1} \varepsilon\|v\|_{s+\mu}^{k_{0}, \gamma} \quad \forall s_{0} \leq s \leq S,  \tag{4.12}\\
\left|\mathrm{~m}_{n}-\zeta\right|^{k_{0}, \gamma} \lesssim \varepsilon & \text { and, if } n \geq 1,\left|\mathrm{~m}_{n}-\mathrm{m}_{n-1}\right|^{k_{0}, \gamma} \lesssim\left\|a_{n-1}\right\|_{s_{0}}^{k_{0}, \gamma}
\end{array}
$$

for some constant $C_{*}(s)=C_{*}\left(s, k_{0}, \tau\right)>0$. If $n=0$, define $\mathcal{O}_{0}^{\gamma}:=\mathbb{R}^{\nu+3}$; if $n \geq 1$, define

$$
\begin{equation*}
\mathcal{O}_{n}^{\gamma}:=\left\{(\omega, \zeta) \in \mathcal{O}_{n-1}^{\gamma}:\left|\omega \cdot \ell+\mathrm{m}_{n-1} \cdot j\right| \geq \frac{\gamma}{\langle\ell, j\rangle^{\tau}} \quad \forall(\ell, j) \in \mathbb{Z}^{\nu+3} \backslash\{0,0\}, \quad|(\ell, j)| \leq N_{n-1}\right\} \tag{4.13}
\end{equation*}
$$

For $n \geq 1$, there exists an invertible diffeomorphism of the torus $\mathbb{T}^{3} \rightarrow \mathbb{T}^{3}, x \mapsto x+\alpha_{n-1}(\varphi, x)$ with inverse $\mathbb{T}^{3} \rightarrow \underset{\mathbb{T}^{3}}{ }, y \mapsto y+\widetilde{\alpha}_{n-1}(\varphi, y)$ such that

\begin{array}{ll}
\left\|\alpha_{n-1}\right\|_{s}^{k_{0}, \gamma},\left\|\breve{\alpha}_{n-1}\right\|_{s}^{k_{0}, \gamma} \lesssim_{s} N_{n-1}^{\tau_{0}} N_{n-2}^{-\mathfrak{a}} \varepsilon \gamma^{-1}\|v\|_{s+\mu}^{k_{0}, \gamma}, & \forall s_{0} \leq s \leq S \\
\left\|\alpha_{n-1}\right\|_{s+\mathfrak{b}}^{k_{0}, \gamma},\left\|\breve{\alpha}_{n-1}\right\|_{s+\mathfrak{b}}^{k_{0}, \gamma} \lesssim s^{N_{n-1}} N_{n-2}^{\tau_{0}} \varepsilon \gamma^{-1}\|v\|_{s+\mu}^{k_{0}, \gamma}, & \forall s_{0} \leq s \leq S \tag{4.14}
\end{array}
$$

(with $\tau_{0}$ defined in (2.18)). The operator

$$
\mathcal{A}_{n-1}: h(\varphi, x) \mapsto h\left(\varphi, x+\alpha_{n-1}(\varphi, x)\right)
$$

with inverse

$$
\mathcal{A}_{n-1}^{-1}: h(\varphi, x) \mapsto h\left(\varphi, y+\breve{\alpha}_{n-1}(\varphi, y)\right)
$$

satisfy, for any $\lambda=(\omega, \zeta) \in \mathcal{O}_{n}^{\gamma}$, the conjugation

Furthermore, $a_{n}=\operatorname{even}(\varphi, x), \alpha_{n-1}, \breve{\alpha}_{n-1}=\operatorname{odd}(\varphi, x)$, implying that $\mathcal{T}_{n}$ is a reversible operator and $\mathcal{A}_{n-1}, \mathcal{A}_{n-1}^{-1}$ are reversibility preserving operators.
Proof. Proof of the statement for $n=0$. The claimed statements for $n=0$ follows directly by defining $a_{0}:=\varepsilon a=\varepsilon \operatorname{curl} \Lambda^{-1} v$, see (3.4).
Proof of the induction step. Now assume that the claimed properties hold for some $n \geq 0$ and let us prove them at the step $n+1$. We look for a diffeomorphism of the torus $\mathbb{T}^{3} \rightarrow \mathbb{T}^{3}, x \mapsto x+\alpha_{n}(\varphi, x)$, wih inverse given by $y \mapsto y+\breve{\alpha}_{n}(\varphi, y)$ such that defining

and the projectors $\Pi_{N_{n}}, \Pi_{N_{n}}^{\perp}$ are defined by (2.4). For any $(\omega, \zeta) \in \mathcal{O}_{n+1}^{\gamma}$, we solve the homological equation

Clearly $\alpha_{n}(\varphi, x ; \omega, \zeta)$ is $\mathcal{C}^{\infty}$ in $(\varphi, x)$ and $k_{0}$ times differentiable in $(\omega, \zeta) \in \mathbb{R}^{\nu+3}$. Using that $\widetilde{\mathcal{A}}_{n+1}:=\widetilde{\mathcal{A}}_{n} \circ \mathcal{A}_{n+1}$, one computes that

\mathrm{m}_{n}-\zeta=-\left\langle\widetilde{\mathcal{A}}_{n-1} a_{n}\right\rangle_{\varphi, x} \quad \forall(\omega, \zeta) \in \mathcal{O}_{n}^{\gamma} \tag{4.40}
\end{equation*}
$$

The claimed estimate then follows by Lemma (2.3, applying (4.12), (4.31), (3.1), (4.3).
Proof of (ii). We prove the claimed inclusion by induction, i.e. we show that $D C(\gamma, \tau) \subseteq \mathcal{O}_{n}^{\gamma}$ for any $n \geq 0$. For $n=0$, the inclusion holds since $\mathcal{O}_{0}^{\gamma}:=\mathbb{R}^{\nu+3}$ and $D C(\gamma, \tau) \subseteq \mathbb{R}^{\nu+3}$ (see (4.7)). Now assume that $D \bar{C}(\gamma, \tau) \subseteq \mathcal{O}_{n}^{\gamma}$ for some $n \geq 0$ and let us prove that $D C(\gamma, \tau) \subseteq \mathcal{O}_{n+1}^{\gamma}$. Let $(\omega, \zeta) \in D C(\gamma, \tau)$. By the induction hypothesis, $(\omega, \zeta)$ belongs to $\mathcal{O}_{n}^{\gamma}$. Therefore, by item $(i)$, one has $\left|\mathrm{m}_{n}(\omega, \zeta)-\zeta\right| \lesssim \varepsilon N_{n-1}^{-\mathfrak{a}}$. Hence, for all $(\ell, j) \in \mathbb{Z}^{\nu+3} \backslash\{(0,0)\},|(\ell, j)| \leq N_{n}$, one has

\end{aligned}

provided $C N_{n}^{1+\tau} N_{n-1}^{-\mathfrak{a}} \varepsilon \gamma^{-1} \leq \mathfrak{C}_{0}-1$. This holds for all $n \geq 0$ provided

Condition (4.41) is fullfilled by taking $\mathfrak{C}_{0} \geq 2$, using (4.10) and the smallness condition (4.3). Thus, by the definition of $\mathcal{O}_{n+1}^{\gamma}$ (see (4.13)), one has that $(\omega, \zeta) \in \mathcal{O}_{n+1}^{\gamma}$, and the proof is concluded.
Proof of Proposition 4.1. For any $(\omega, \zeta) \in D C(\gamma, \tau)$, by Lemma 4.5, $\mathrm{m}_{n} \rightarrow \zeta$ as $n \rightarrow \infty$. By (4.31), (4.12) and Lemma 2.3, one has $\left\|\widetilde{\mathcal{A}}_{n-1} a_{n}\right\|_{s_{0}} \lesssim\left\|a_{n}\right\|_{s_{0}} \rightarrow 0$ Also,

Hence, passing to the limit in norm $\left\|\|_{s_{0}}\right.$ in the identity (4.38), we obtain the identity

for all $(\omega, \zeta) \in D C(\gamma, \tau)$, which is (4.6). The estimates (4.4), (4.8) follow from the estimates (4.32) and by Lemma 2.3 .

It remains only to prove the estimate (4.9). Let $a_{i}:=a_{i}\left(v_{i}\right), i=1,2$ satisfy (4.2) and assume that, for $s_{1}>s_{0}, v_{1}, v_{2}$ satisfy (3.1) with $\mu_{0} \geq s_{1}+\mu$. Let $\alpha_{i}$ and $\mathcal{A}_{i}, i=1,2$, be the corresponding function and operator given by Lemma 4.4( $(i i)$, (iiii). Then, by (4.42) and (4.6), for $i=1,2$ one has

Since $\left\langle\mathcal{A}_{1}^{-1}(f)\right\rangle_{\varphi, x}=-\left\langle L_{0} \mathcal{A}_{1}^{-1}\left(\alpha_{1}-\alpha_{2}\right)\right\rangle_{\varphi, x}=0,(\omega, \zeta) \in D C(\gamma, \tau)$ and $\alpha_{1}-\alpha_{2}, \mathcal{A}_{1}^{-1}\left(\alpha_{1}-\alpha_{2}\right)=\operatorname{odd}(\varphi, x)$ (the operator $L_{0}$ has only the trivial kernel, restricted to the space of odd functions in $(\varphi, x)$ ), one has

Then, using that $\left\|v_{i}\right\|_{s_{1}+\mu} \leq 1$, by applying (4.8), (4.4) and the product estimate (2.7), recalling also that by (3.4), $a_{i}=\operatorname{curl} \Lambda^{-1} v_{i}, i=1,2$, one gets the estimate (4.9) for $\Delta_{12} \alpha$. The corresponding estimate for $\Delta_{12} \breve{\alpha}$ can be done by using that $\breve{\alpha}_{i}=-\mathcal{A}_{i}^{-1}\left(\alpha_{i}\right)$ and using the mean value theorem. Finally, the estimate for $\Delta_{12} \mathcal{A}^{ \pm 1}, \Delta_{12} \mathcal{A}^{*}$ follow by using the estimate for $\Delta_{12} \alpha$ and $\Delta_{12} \breve{\alpha}$, using the mean value theorem and Lemma 2.3

In the next Lemma we exploit the conjugation of the operator $\mathcal{L}^{(0)}$ defined in (3.7) by means of the map $\mathcal{A}$ constructed in Proposition 4.1. With a slight abuse of notations we denote with the same letter $\mathcal{A}$ the operator acting on $H^{s}\left(\mathbb{T}^{\nu} \times \mathbb{T}^{3}, \mathbb{R}\right)$ and acting on $H^{s}\left(\mathbb{T}^{\nu} \times \mathbb{T}^{3}, \mathbb{R}^{3}\right)$. The action on the spaces $H^{s}\left(\mathbb{T}^{\nu} \times \mathbb{T}^{3}, \mathbb{R}^{3}\right)$ is given by

Lemma 4.6. For any $S>s_{0}, \gamma \in(0,1), \tau>0$ there exists $\delta=\delta\left(S, k_{0}, \tau, \nu\right) \in(0,1), \mu=\mu\left(k_{0}, \tau, \nu\right)>0$ such that if (3.1) holds and $N_{0}^{\tau_{1}} \varepsilon \gamma^{-1} \leq \delta$, for any $(\omega, \zeta) \in D C(\gamma, \tau)$ (see (4.7)) one has

where $\mathcal{R}_{0}^{(1)}=\operatorname{Op}\left(R_{0}^{(1)}\right) \in \mathcal{O} \mathcal{P} \mathcal{S}_{S, 1}^{0}, \mathcal{R}_{-1}^{(1)}=\operatorname{Op}\left(R_{-1}^{(1)}\right) \in \mathcal{O} \mathcal{P} \mathcal{S}_{S, 0}^{-1}$ and

\left|\mathcal{R}_{0}^{(1)}\right|_{0, s, 1}^{k_{0}, \gamma},\left|\mathcal{R}_{-1}^{(1)}\right|_{-1, s, 0}^{k_{0}, \gamma} \lesssim s^{\varepsilon}\|v\|_{s+\mu}^{k_{0}, \gamma}, \quad \forall s_{0} \leq s \leq S . \tag{4.45}
\end{equation*}

Moreover $\mathcal{L}^{(1)}, \mathcal{R}_{0}^{(1)}, \mathcal{R}_{-1}^{(1)}$ are real and reversible operators and the symbol of the zero-th order operator $\mathcal{R}_{0}^{(1)}$ satisfies the symmetry condition

Analysis of $\mathcal{A}^{-1} \mathcal{R}_{0} \mathcal{A}$. By the formula (3.5), we recall that

& M_{\nabla}, M_{\text {curl }} \in \mathcal{S}_{S, 1}^{1}, \quad \mathcal{P}_{-2} \in \mathcal{O} \mathcal{P} \mathcal{S}_{S, 1}^{-2}, \quad \mathcal{P}_{-3} \in \mathcal{O} \mathcal{P} \mathcal{S}_{S, 1}^{-3} \\
& \left|\operatorname{Op}\left(M_{\nabla}\right)\right|_{1, s, 1}^{k_{0}, \gamma} \lesssim_{s}\|v\|_{s+\mu}^{k_{0}, \gamma}  \tag{4.53}\\
& \left|\operatorname{Op}\left(M_{\text {curl }}\right)\right|_{1, s, 1}^{k_{0}, \gamma},\left|\mathcal{P}_{-2}\right|_{-2, s, 1}^{k_{0}, \gamma},\left|\mathcal{P}_{-3}\right|_{-3, s, 0}^{k_{0}, \gamma} \lesssim_{\infty} 1+\|v\|_{s+\mu}^{k_{0}, \gamma}
\end{align*}
$$

for any $s_{0} \leq s \leq S$. Hence, by (4.48), (4.50), (4.52), (4.53), by applying also (2.23), (2.24), Lemma 2.7 and the ansatz (3.1) with $\mu_{0}>0$ large enough, one obtains that

& R_{0,0}(\varphi, x, \xi):=\widetilde{M}_{\mathcal{U}}(\varphi, x)-M_{\nabla}(\varphi, x, \xi) M_{\text {curl }}(\varphi, x, \xi) P_{-2}(\varphi, x, \xi)  \tag{4.54}\\
& \left|\operatorname{Op}\left(R_{0,0}\right)\right|_{0, s, 1}^{k_{0}, \gamma},\left|\operatorname{Op}\left(R_{0,-1}\right)\right|_{-1, s, 0}^{k_{0}, \gamma} \lesssim s\|v\|_{s+\mu}^{k_{0}, \gamma}, \quad \forall s_{0} \leq s \leq S
\end{align*}

Moreover (4.52) implies that

Analysis of $\mathcal{A}^{-1} \mathcal{R}_{-1} \mathcal{A}$. By (3.5), one writes

Then using that $\left\|M_{v}\right\|_{s}^{k_{0}, \gamma} \lesssim\|v\|_{s+1}^{k_{0}, \gamma}$, by applying Lemmata 2.10, 2.11, 2.13, the composition Lemma 2.7, the estimate (4.4), the ansatz (3.1) and $N_{0}^{\tau_{0}} \varepsilon \gamma^{-1} \leq 1$, one gets that

Moreover, since $\mathcal{R}_{-1}$ is reversible and $\mathcal{A}$ is reversibility preserving, then $\mathcal{A}^{-1} \mathcal{R}_{-1} \mathcal{A}$ is reversible.
The claimed properties (4.45), (4.46), then follow by setting

## 5 Elimination of the zero-th order term via a variable coefficients homological equation

In this section, our aim is to construct a transformation of the form $\mathcal{B}=\operatorname{Id}+\mathcal{M}$, with $\mathcal{M}=\operatorname{Op}(M(\varphi, x, \xi))$ of order 0 , in such a way that the transformed operator $\mathcal{B}^{-1} \mathcal{L}^{(1)} \mathcal{B}$ is a one-smoothing perturbation of the operator $\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla$. This means that we look for $\mathcal{M}$ that completely eliminates the zero-th order term $\mathcal{R}_{0}^{(1)}$ from the operator $\mathcal{L}^{(1)}$ in (4.44). The main technical issue here is that we deal with matrix-valued pseudodifferential operators, therefore the commutator $\left[\mathcal{R}_{0}^{(1)}, \mathcal{M}\right]$ does not gain derivatives (unlike commutators of scalar pseudo-differential operators do), so that $\left[\mathcal{R}_{0}^{(1)}, \mathcal{M}\right]$ is still an operator of order 0 . This implies that, in order to remove the zero-th order term, we have to solve a variable coefficients homological equation, which is an equation in the unknown $M(\varphi, x, \xi)$ of the form

$$
\begin{equation*}
\left(\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla+R_{0}^{(1)}(\varphi, x, \xi)\right) M(\varphi, x, \xi)+R_{0}^{(1)}(\varphi, x, \xi)=0 \tag{5.1}
\end{equation*}
$$

### 5.1 The homological equation at the zero-th order term

In order to simplify notations in this section, we set $V(\varphi, x, \xi):=R_{0}^{(1)}(\varphi, x, \xi)$. To deal with the equation (5.1), the first step is to diagonalize the linear operator

acting on the space of matrix symbols $\mathcal{S}_{s+1,0}^{0}$ for any $s_{0} \leq s \leq S$. The action of the operator $\mathcal{P}$ is given by

& A(\varphi, x, \xi) \mapsto \omega \cdot \partial_{\varphi} A(\varphi, x, \xi)+\zeta \cdot \nabla A(\varphi, x, \xi)+V(\varphi, x, \xi) A(\varphi, x, \xi)
\end{align*}
$$

To develop the reducibility scheme, we use the pseudo differential norm

\mathcal{B}=\operatorname{Id}+\mathcal{M}, \quad \mathcal{M}=\operatorname{Op}(M(\varphi, x, \xi)) \in \mathcal{O} \mathcal{P} \mathcal{S}_{S, 0}^{0} \tag{5.25}
\end{equation*}
$$

where the symbol $M(\varphi, x, \xi)$ has to be determined. By Lemma 2.7, one has

\begin{equation*}
\mathcal{R}_{0}^{(1)} \mathcal{M}=\operatorname{Op}\left(R_{0}^{(1)}(\varphi, x, \xi) M(\varphi, x, \xi)\right)+\mathcal{R}_{R_{0}^{(1)} M} \tag{5.26}
\end{equation*}
$$

where the remainder $\mathcal{R}_{R_{0}^{(1)} M}$ is an operator of order -1 . Hence

\begin{equation*}
\mathcal{L}^{(1)} \mathcal{B}=\mathcal{B}\left(\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla\right)+\operatorname{Op}\left(\left(\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla\right) M+R_{0}^{(1)} M+R_{0}^{(1)}\right)+\mathcal{R}_{R_{0}^{(1)} M}+\mathcal{R}_{-1}^{(1)} \mathcal{B} \tag{5.27}
\end{equation*}
$$

Note that $\mathcal{R}_{-1}^{(1)} \mathcal{B}$ is also an operator of order -1 . By Proposition 5.2 applied with $V:=R_{0}^{(1)}$, there exists a symbol $M=M(\varphi, x, \xi) \in \mathcal{S}_{S, 0}^{0}, \operatorname{even}(\varphi, x, \xi)$, that solves the equation (5.1) and satisfies the bounds (5.21). By (5.27), (5.1) one deduces formula (5.22) with

The bounds for $\mathcal{M}^{*}$ and $\mathcal{B}^{-1}-\mathrm{Id}$ follow by Lemmata 2.8, 2.9. The estimate of $\left|\mathcal{R}^{(2)}\right|_{-1, s, 0}^{k_{0}, \gamma}$ then follows by Lemma 2.7 and by estimates (4.45), (5.21), (3.1), (4.3). Since $M=\operatorname{even}(\varphi, x, \xi)$, the maps $\mathcal{B}^{ \pm 1}$ are reversibility preserving maps, hence since $\mathcal{L}^{(1)}$ is reversible then also $\mathcal{L}^{(2)}$ is reversible. The estimates (5.24) can be proved arguing similarly.

## 6 Reduction to constant coefficients of the lower order terms

In this section we reduce the operator $\mathcal{L}^{(2)}$ in (5.22) to constant coefficients up to an arbitarily regularizing remainder. More precisely, we prove the following Proposition.

Proposition 6.1. Let $S>s_{0}, M \in \mathbb{N}, \gamma \in(0,1), \tau>0$. Then there exists $\mu=\mu\left(M, k_{0}, \tau, \nu\right)>0$, $\delta=\delta\left(S, M, k_{0}, \tau, \nu\right) \in(0,1)$ such that if (3.1), (4.3) are fullfilled with $\mu_{0} \geq s_{0}+\mu$, then the following holds. There exists a real and reversibility preserving, invertible map $\mathcal{V}$ satisfying

\left|\mathcal{V}^{ \pm 1}-\operatorname{Id}\right|_{0, s, 0}^{k_{0}, \gamma},\left|\mathcal{V}^{*}-\operatorname{Id}\right|_{0, s, 0}^{k_{0}, \gamma} \lesssim_{s, M} \varepsilon \gamma^{-1}\|v\|_{s+\mu}^{k_{0}, \gamma}, \quad \forall s_{0} \leq s \leq S \tag{6.1}
\end{equation*}
$$

and a linear operator $\mathcal{L}^{(3)}$ defined by

\mathcal{L}^{(3)}:=\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla+\mathcal{Q}+\mathcal{R}^{(3)} \tag{6.2}
\end{equation*}
$$

where $\mathcal{Q}=\operatorname{Op}(Q(\xi)) \in \mathcal{O} \mathcal{P} \mathcal{S}_{S, 0}^{-1}$ is an operator whose $3 \times 3$ matrix symbol is independent of $(\varphi, x)$, $\mathcal{R}^{(3)}$ belongs to $\mathcal{O P S} \mathcal{S}_{S, 0}^{-M}$, and

|\mathcal{Q}|_{-1, s, 0}^{k_{0}, \gamma},\left|\mathcal{R}^{(3)}\right|_{-M, s, 0}^{k_{0}, \gamma} \lesssim_{s, M} \varepsilon\|v\|_{s+\mu}^{k_{0}, \gamma} \quad \forall s_{0} \leq s \leq S \tag{6.3}
\end{equation*}
$$

The operators $\mathcal{L}^{(3)}, \mathcal{Q}, \mathcal{R}^{(3)}$ are real and reversible operators defined for all the values of the parameters $(\omega, \zeta) \in \mathbb{R}^{\nu+3}$. For any $(\omega, \zeta) \in D C(\gamma, \tau)$, one has $\mathcal{V}^{-1} \mathcal{L}^{(2)} \mathcal{V}=\mathcal{L}^{(3)}$.

Let $s_{1} \geq s_{0}$ and let $v_{1}, v_{2}$ satisfy (3.1) with $\mu_{0} \geq s_{1}+\mu$. Then for any $(\omega, \zeta) \in D C(\gamma, \tau)$ one has

& \left|\Delta_{12} \mathcal{V}^{ \pm 1}\right|_{0, s_{1}, 0},\left|\Delta_{12} \mathcal{V}^{*}\right|_{0, s_{1}, 0} \lesssim_{s_{1}, M} \varepsilon \gamma^{-1}\left\|v_{1}-v_{2}\right\|_{s_{1}+\mu} \\
& \left|\Delta_{12} \mathcal{Q}\right|_{-1, s_{1}, 0},\left|\Delta_{12} \mathcal{R}^{(3)}\right|_{-M, s_{1}, 0} \lesssim_{s_{1}, M} \varepsilon\left\|v_{1}-v_{2}\right\|_{s_{1}+\mu} \tag{6.4}
\end{align*}
$$

Proposition 6.1 follows by the following iterative lemma.

Lemma 6.2. Let $S>s_{0}, M \in \mathbb{N}, \gamma \in(0,1), \tau>0$. Then there exists $\mu_{M}=\mu\left(M, k_{0}, \tau, \nu\right)>0$, $\delta=\delta\left(S, M, k_{0}, \tau, \nu\right) \in(0,1)$ and $\mu_{1}<\mu_{2}<\ldots<\mu_{M}$ such that if (3.1), (4.3) are fullfilled with $\mu_{0} \geq s_{0}+\mu_{M}$, then the following holds. For any $n=0, \ldots, M-1$, there exists a linear operator $\mathcal{L}_{n}^{(2)}$ of the form

\mathcal{L}_{n}^{(2)}:=\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla+\mathcal{Z}_{n}+\mathcal{R}_{n}^{(2)} \tag{6.5}
\end{equation*}
$$

where $\mathcal{Z}_{n}=\operatorname{Op}\left(Z_{n}(\xi)\right) \in \mathcal{O} \mathcal{P} \mathcal{S}_{S, 0}^{-1}$ and $\mathcal{R}_{n}^{(2)}=\operatorname{Op}\left(R_{n}^{(2)}(\varphi, x, \xi)\right) \in \mathcal{O} \mathcal{P} \mathcal{S}_{S, 0}^{-(n+1)}$ are defined for all the values of the parameters $(\omega, \zeta) \in \mathbb{R}^{\nu+3}$ and satisfy

\begin{align*}
& \left|\mathcal{Z}_{n}\right|_{-1, s, 0}^{k_{0}, \gamma} \lesssim s, n \varepsilon\|v\|_{s_{0}+\mu_{n}}^{k_{0}, \gamma} \quad \forall s_{0} \leq s \leq S \\
& \left|\mathcal{R}_{n}^{(2)}\right|_{-(n+1), s, 0}^{k_{0}, \gamma} \lesssim s, n^{\|v v\|_{s+\mu_{n}}^{k_{0}, \gamma} \quad \forall s_{0} \leq s \leq S} . \tag{6.6}
\end{align*}
$$

The operators $\mathcal{L}_{n}^{(2)}, \mathcal{Z}_{n}, \mathcal{R}_{n}^{(2)}$ are real and reversible. For any $n=1, \ldots, M$ there exists a reversibility preserving, invertible map $\mathcal{T}_{n}$ defined for any $(\omega, \zeta) \in \mathbb{R}^{\nu+3}$, satisfying the estimate

\end{equation*}

and

\mathcal{L}_{n}^{(2)}=\mathcal{T}_{n}^{-1} \mathcal{L}_{n-1}^{(2)} \mathcal{T}_{n} \quad \forall(\omega, \zeta) \in D C(\gamma, \tau) \tag{6.8}
\end{equation*}
$$

Let $s_{1} \geq s_{0}$ and assume that $v_{1}, v_{2}$ satisfy (3.1) with $\mu_{0} \geq s_{1}+\mu_{M}$. Then, for any $\lambda=(\omega, \zeta) \in D C(\gamma, \tau)$,

& \left|\Delta_{12} \mathcal{T}_{n}^{ \pm 1}\right|_{-n, s_{1}, 0} \lesssim_{s_{1}, n} \varepsilon \gamma^{-1}\left\|v_{1}-v_{2}\right\|_{s_{1}+\mu_{n}} \\
& \left|\Delta_{12} \mathcal{Z}_{n}\right|_{-1, s_{1}, 0},\left|\Delta_{12} \mathcal{R}_{n}^{(2)}\right|_{-n, s_{1}, 0} \lesssim_{s_{1}, n} \varepsilon\left\|v_{1}-v_{2}\right\|_{s_{1}+\mu_{n}} \tag{6.9}
\end{align*}
$$

Proof. We prove the lemma arguing by induction. For $n=0$ the claimed statement follows by Lemma 5.5, by defining $\mathcal{L}_{0}^{(2)}:=\mathcal{L}^{(2)}, \mathcal{Z}_{0}=0, \mathcal{R}_{0}^{(2)}:=\mathcal{R}^{(2)}$.

We assume that the claimed statement holds for some $n \in\{0, \ldots, M-1\}$ and we prove it at the step $n+1$. Let us consider a transformation $\mathcal{T}_{n+1}=\operatorname{Id}+\mathcal{M}_{n+1}$ where $\mathcal{M}_{n+1}=\operatorname{Op}\left(M_{n+1}(\varphi, x, \xi)\right)$ is an operator of order $-(n+1)$ which has to be determined. One computes

\mathcal{L}_{n}^{(2)} \mathcal{T}_{n+1}=\mathcal{T}_{n+1}\left(\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla\right)+\mathcal{Z}_{n}+\operatorname{Op}\left(\left(\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla\right) M_{n+1}+R_{n}^{(2)}\right)+\mathcal{Z}_{n} \mathcal{M}_{n+1}+\mathcal{R}_{n}^{(2)} \mathcal{M}_{n+1} \tag{6.10}
\end{equation*}
$$

We define the symbol $M_{n+1}(\varphi, x, \xi)$ as

M_{n+1}:=\left(\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla\right)_{e x t}^{-1}\left[\left\langle R_{n}^{(2)}\right\rangle_{\varphi, x}-R_{n}^{(2)}\right] \tag{6.11}
\end{equation*}
$$

which is defined for any $(\omega, \zeta) \in \mathbb{R}^{\nu+3}$ (recall (2.16)). Clearly $\mathcal{M}_{n+1}$ is an operator of the same order as $\mathcal{R}_{n}^{(2)}$, namely $\mathcal{M}_{n+1} \in \mathcal{O} \mathcal{P} \mathcal{S}_{S, 0}^{-(n+1)}$, and, by Lemma 2.4 and the induction estimate (6.6), one verifies that

\end{equation*}
$$

Furthermore, for any $(\omega, \zeta) \in D C(\gamma, \tau), M_{n+1}(\varphi, x, \xi)$ solves the homological equation

\left(\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla\right) M_{n+1}+R_{n}^{(2)}=\left\langle R_{n}^{(2)}\right\rangle_{\varphi, x} \tag{6.13}
\end{equation*}
$$

Using the ansatz (3.1) with $\mu_{0} \geq s_{0}+\mu_{n}+\tau_{0}$, one gets $\left|\mathcal{M}_{n+1}\right|_{-(n+1), s_{0}, 0}^{k_{0}, \gamma} \lesssim \varepsilon \gamma^{-1}$, hence by taking $\varepsilon \gamma^{-1}$ small enough, one can apply Lemma 2.9, obtaining that $\mathcal{T}_{n+1}=\operatorname{Id}+\mathcal{M}_{n+1}$ is invertible with inverse $\mathcal{T}_{n+1}^{-1}$ satisfying the estimate

Hence the estimate (6.7) at the step $n+1$ holds by taking $\mu_{n+1} \geq \mu_{n}+\tau_{0}$. By (6.10), (6.13) we then get, for any $(\omega, \zeta) \in D C(\gamma, \tau)$, the conjugation (6.8) at the step $n+1$ where $\mathcal{L}_{n+1}^{(2)}$ has the form (6.5), with

\mathcal{R}_{n+1}^{(2)} & :=\left(\mathcal{T}_{n+1}^{-1}-\mathrm{Id}\right) \mathcal{Z}_{n+1}+\mathcal{T}_{n+1}^{-1}\left(\mathcal{Z}_{n} \mathcal{M}_{n+1}+\mathcal{R}_{n}^{(2)} \mathcal{M}_{n+1}\right) \tag{6.15}
\end{align*}
$$

Since $\mathcal{M}_{n+1}, \mathcal{T}_{n+1}^{ \pm 1}, \mathcal{R}_{n}^{(2)}$ are defined for all $(\omega, \zeta) \in \mathbb{R}^{\nu+3}$, then also $\mathcal{R}_{n+1}^{(2)}$ is defined for all $(\omega, \zeta) \in \mathbb{R}^{\nu+3}$. Since $\mathcal{Z}_{n}$ is of order -1 and $\mathcal{R}_{n}^{(2)}, \mathcal{M}_{n+1}$ are of order $-(n+1)$, one gets that $\mathcal{Z}_{n} \mathcal{M}_{n+1}+\mathcal{R}_{n}^{(2)} \mathcal{M}_{n+1}$ is of order $-(n+2)$. The estimate (6.6) at the step $n+1$ for the operator $\mathcal{Z}_{n+1}$ follows by the induction estimate on $\mathcal{Z}_{n}, \mathcal{R}_{n}^{(2)}$ and by the property (2.22). The estimate for the operator $\mathcal{R}_{n+1}^{(2)}$ follows by (6.12), (6.14), the estimates for $\mathcal{Z}_{n+1}$ and $\mathcal{Z}_{n}, \mathcal{R}_{n}^{(2)}$ and using Lemma 2.7+ $(i)$. Furthermore, since $\mathcal{R}_{n}^{(2)}$ and $\mathcal{Z}_{n}$ are reversible, then by (6.13) one verifies that $\mathcal{M}_{n+1}=\operatorname{Op}\left(M_{n+1}\right)$ is reversibility preserving and therefore, by (6.15), $\mathcal{Z}_{n+1}$ and $\mathcal{R}_{n+1}^{(2)}$ are reversible operators. The estimates (6.9) can be proved by similar arguments.

Proof of Proposition 6.1. We define

\mathcal{L}^{(3)}:=\mathcal{L}_{M-1}^{(2)}, \quad \mathcal{Q}:=\mathcal{Z}_{M-1}, \quad \mathcal{R}^{(3)}:=\mathcal{R}_{M-1}^{(2)}, \quad \mathcal{V}:=\mathcal{T}_{1} \circ \ldots \circ \mathcal{T}_{M-1}

Then, in order to deduce the claimed properties of $\mathcal{Z}$ and $\mathcal{R}^{(3)}$, it suffices to apply Lemma 6.2 for $n=M-1$. The estimate (6.1) then follows by the estimate (6.7) on $\mathcal{T}_{n}, n=1, \ldots, M-1$, using the composition Lemma 2.7 $(i)$ and Lemma 2.8 (to estimate the adjoint operator $\mathcal{V}^{*}$ ). The estimates (6.4) follow similarly.

## 7 Conjugation of the operator $\mathcal{L}$

In this section we go back to the operator $\mathcal{L}$ in (3.3) which contains the projector $\Pi_{0}^{\perp}$, see (1.13). We define

\mathcal{E}:=\mathcal{A B} \mathcal{V} \quad \text { and } \quad \mathcal{E}_{\perp}:=\Pi_{0}^{\perp} \mathcal{E} \Pi_{0}^{\perp} \tag{7.1}

We also recall that $H_{0}^{s}$ is defined in (1.6).
Lemma 7.1. Let $S>s_{0}, M \in \mathbb{N}, \tau>0, \gamma \in(0,1)$. Then there exists $\delta=\delta\left(S, M, k_{0}, \tau\right) \in(0,1)$ small enough and $\mu_{M}:=\mu\left(M, k_{0}, \tau, \nu\right)>0$ such that if (3.1), (4.3) are fullfilled with $\mu_{0} \geq s_{0}+\mu_{M}$, the following properties hold.
(i) For any $s_{0} \leq s \leq S$, the map $\mathcal{E}_{\perp}: H_{0}^{s} \rightarrow H_{0}^{s}$ is invertible and satisfies the tame estimates

\end{equation*}

Furthermore $\mathcal{E}_{\perp}$ and $\mathcal{E}_{\perp}^{-1}$ are real and reversibility preserving.
(ii) For any $(\omega, \zeta) \in D C(\gamma, \tau)$, the map $\mathcal{E}_{\perp}$ conjugates the operator $\mathcal{L}$ in (3.3) to an operator $\mathcal{L}_{0}: H_{0}^{s+1} \rightarrow H_{0}^{s}$ for any $s_{0} \leq s \leq S$, defined by

\mathcal{L}_{0}:=\mathcal{E}_{\perp}^{-1} \mathcal{L} \mathcal{E}_{\perp}=\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla+\mathcal{Q}_{0}+\mathcal{R}_{0} \tag{7.3}
\end{equation*}
$$

where $\mathcal{Q}_{0}$ is a $3 \times 3$ time independent block-diagonal operator (see Definition 2.14) defined for any $(\omega, \zeta) \in$ $\mathbb{R}^{\nu+3}$, represented by the matrix $\mathcal{Q}_{0}=\operatorname{diag}_{j \in \mathbb{Z}^{3} \backslash\{0\}}\left(\mathcal{Q}_{0}\right)_{j}^{j}$, satisfying

\sup _{j \in \mathbb{Z}^{3} \backslash\{0\}}\left\|\left(\mathcal{Q}_{0}\right)_{j}^{j}\right\|_{\mathrm{HS}}^{k_{0}, \gamma}|j| \lesssim M\| \| v \|_{s_{0}+\mu_{M}}^{k_{0}, \gamma} \tag{7.4}
\end{equation*}
$$

and $\mathcal{R}_{0}$ is a linear operator defined for any $(\omega, \zeta) \in \mathbb{R}^{\nu+3}$ satisfying the estimate

\left|\mathcal{R}_{0}\langle D\rangle^{M}\right|_{s}^{k_{0}, \gamma} \lesssim_{s, M} \varepsilon\|v\|_{s+\mu_{M}}^{k_{0}, \gamma}, \quad \forall s_{0} \leq s \leq S \tag{7.5}
\end{equation*}
$$

where the decay norm $|\cdot|_{s}^{k_{0}, \gamma}$ is defined in Definition 2.15 and $\langle D\rangle^{M}$ is the Fourier multiplier of symbol $\langle\xi\rangle^{M}=\left(1+|\xi|^{2}\right)^{M / 2}$. Furthermore, $\mathcal{L}_{0}, \mathcal{Q}_{0}, \mathcal{R}_{0}$ are real and reversible.
(iii) Let $s_{1} \geq s_{0}$ and assume that $v_{1}, v_{2}$ satisfy (3.1) with $\mu_{0} \geq s_{1}+\mu_{M}$. Then for any $(\omega, \zeta) \in D C(\gamma, \tau)$, one has

& \left\|\Delta_{12} \mathcal{E}_{\perp}^{ \pm 1} h\right\|_{s_{1}} \lesssim_{s_{1}, M} \varepsilon \gamma^{-1}\left\|v_{1}-v_{2}\right\|_{s_{1}+\mu_{M}}\|h\|_{s_{1}+1} \\
& \left|\Delta_{12} \mathcal{R}_{0}\langle D\rangle^{M}\right|_{s_{1}}^{k_{0}, \gamma} \lesssim_{s_{1}, M} \varepsilon\left\|v_{1}-v_{2}\right\|_{s_{1}+\mu_{M}}, \sup _{j \in \mathbb{Z}^{3} \backslash\{0\}}\left\|\left(\Delta_{12} \mathcal{Q}_{0}\right)_{j}^{j}\right\|_{\mathrm{HS}}|j| \lesssim_{M} \varepsilon\left\|v_{1}-v_{2}\right\|_{s_{1}+\mu_{M}} \tag{7.6}
\end{align*}
$$

Proof. To simplify notations, in this proof we write $\|\cdot\|_{s}$ instead of $\|\cdot\|_{s}^{k_{0}, \gamma}$. Also, given any operator $A$ mapping $H^{s}\left(\mathbb{T}^{\nu+3}, \mathbb{R}^{3}\right)$ into itself, we denote by $A[1]=A[1](\varphi, x)$ the $3 \times 3$ matrix of entries

\end{equation*}

where $e_{j}$ is the $j$-th vector of the canonical basis of $\mathbb{R}^{3}$; we denote by $\Pi_{0} A[1]=\left(\Pi_{0} A[1]\right)(\varphi)$ the $3 \times 3$ matrix of entries $\Pi_{0}\left(A_{j, k}[1]\right)(\varphi)$. Note that, if $A=\mathrm{Op}(a(\varphi, x, \xi))$, then $A[1]=a(\varphi, x, 0)$.
Proof of $(i)$. By Proposition 4.1. Lemmata 4.6, 5.5, Proposition 6.1, using also Lemma 2.6. the operator $\mathcal{E}$ is invertible, $\mathcal{E}, \mathcal{E}^{-1}$ are real and reversibility preserving and, for $s_{0} \leq s \leq S$,

& \left\|\left(\mathcal{E}^{ \pm 1}-\mathrm{Id}\right) h\right\|_{s},\left\|\left(\mathcal{E}^{*}-\mathrm{Id}\right) h\right\|_{s} \lesssim_{s, M} N_{0}^{\tau_{0}} \varepsilon \gamma^{-1}\left(\|v\|_{s_{0}+\mu_{M}}\|h\|_{s+1}+\|v\|_{s+\mu_{M}}\|h\|_{s_{0}+1}\right), \tag{7.8}
\end{align*}
$$

for some $\mu_{M}>0$. For any $u \in H^{s}\left(\mathbb{T}^{\nu+3}, \mathbb{R}^{3}\right)$, we split $u=\Pi_{0}^{\perp} u+\Pi_{0} u$, where $\Pi_{0}^{\perp} u \in H_{0}^{s}=H_{0}^{s}\left(\mathbb{T}^{\nu+3}, \mathbb{R}^{3}\right)$ and $\Pi_{0} u \in H_{\varphi}^{s}:=H^{s}\left(\mathbb{T}^{\nu}, \mathbb{R}^{3}\right)$ (recall that $\left(\Pi_{0} u\right)(\varphi)$ is the space average of $u$; it is a function of $\varphi$, independent of $x$ ). Hence the operator $\mathcal{E}$ is decomposed accordingly into

Step 1: Invertibility of $\Pi_{0} \mathcal{E} \Pi_{0}$. We write $\Pi_{0} \mathcal{E} \Pi_{0}=\Pi_{0}+\mathcal{R}_{\mathcal{E}}$ with $\mathcal{R}_{\mathcal{E}}:=\Pi_{0}(\mathcal{E}-\mathrm{Id}) \Pi_{0}$. For any $f \in$ $H_{\varphi}^{s}\left(\mathbb{T}^{\nu}, \mathbb{R}^{3}\right)$, namely $f=f(\varphi)$ independent of $x$, one has

where "." is the matrix product of the matrix $\mathcal{E}[1]$ by the vector $f$. In fact, $\mathcal{B V}$ is a pseudo-differential operator of matrix symbol, say, $P(\varphi, x, \xi)$; therefore $\mathcal{B} \mathcal{V} f=P(\varphi, x, 0) f(\varphi)=(\mathcal{B} \mathcal{V})[1](\varphi, x) f(\varphi)$; and then $\mathcal{A}\{(\mathcal{B V})[1](\varphi, x) f(\varphi)\}=(\mathcal{B V})[1](\varphi, x+\alpha(\varphi, x)) f(\varphi)$ because $\mathcal{A}$ is a change of the $x$ variable. Hence

because $\left(\Pi_{0} h\right)(\varphi)$ is independent of $x$. Therefore, by the estimate (7.8), using the ansatz (3.1) and the product estimate (2.7), one obtains that

By Neumann series, using the smallness condition (4.3), one then gets that $\Pi_{0} \mathcal{E} \Pi_{0}: H_{\varphi}^{s} \rightarrow H_{\varphi}^{s}$ is invertible and

\end{equation*}

Step 2: The operator

M:=\Pi_{0}^{\perp} \mathcal{E} \Pi_{0}^{\perp}-\left(\Pi_{0}^{\perp} \mathcal{E} \Pi_{0}\right)\left(\Pi_{0} \mathcal{E} \Pi_{0}\right)^{-1}\left(\Pi_{0} \mathcal{E} \Pi_{0}^{\perp}\right) \tag{7.12}
\end{equation*}
$$

is invertible, and

\begin{equation*}
\left\|M^{-1} z\right\|_{s} \lesssim_{s, M}\|z\|_{s}+\|v\|_{s+\mu_{M}}\|z\|_{s_{0}}, \quad \forall s_{0} \leq s \leq S, \quad \forall z \in H_{0}^{s} \tag{7.13}
\end{equation*}
$$

Let us prove the invertibility of $M$. Since $\mathcal{E}: H^{s} \rightarrow H^{s}$ is invertible, given any $z \in H_{0}^{s}$ there exists a unique $h \in H^{s}$ such that $\mathcal{E} h=z$. Since $\left(\Pi_{0} \mathcal{E} \Pi_{0}\right): H_{\varphi}^{s} \rightarrow H_{\varphi}^{s}$ is invertible, one has $\mathcal{E} h=z$ if and only if

\end{array}\right)\binom{\Pi_{0} h}{\Pi_{0}^{\perp} h}=\binom{0}{z} \quad \Longleftrightarrow \quad M \Pi_{0}^{\perp} h=z
$$

Using (7.8),

\left\|M^{-1} z\right\|_{s}=\left\|\Pi_{0}^{\perp} h\right\|_{s} \leq\|h\|_{s}=\left\|\mathcal{E}^{-1} z\right\|_{s} \lesssim_{s, M}\|z\|_{s}+\|v\|_{s+\mu_{M}}\|z\|_{s_{0}}
$$

and (7.13) is proved.
Step 3: Estimates of $\Pi_{0}^{\perp} \mathcal{E} \Pi_{0}, \Pi_{0} \mathcal{E} \Pi_{0}^{\perp}$. By (7.9), since $\left(\Pi_{0} h\right)(\varphi)$ is independent of $x$, one has

$$

Also, by an explicit calculation,

\Pi_{0} \mathcal{E} \Pi_{0}^{\perp} h=\Pi_{0}(\mathcal{E}-\mathrm{Id}) \Pi_{0}^{\perp} h=\Pi_{0}\left(G \cdot \Pi_{0}^{\perp} h\right)

where "." is the "row by column" product, and $G=G(\varphi, x)$ is the matrix with entries

\begin{equation*}
G_{j, k}(\varphi, x)=\left(\mathcal{E}_{j, k}-\operatorname{Id}_{j, k}\right)^{*}[1](\varphi, x)=\left(\mathcal{E}^{*}-\operatorname{Id}\right)_{k, j}[1](\varphi, x), \quad j, k=1,2,3 . \tag{7.14}
\end{equation*}
$$

The estimate (7.8), the ansatz (3.1), and the product estimate (2.7) imply that

\left\|\Pi_{0}^{\perp} \mathcal{E} \Pi_{0} h\right\|_{s},\left\|\Pi_{0} \mathcal{E} \Pi_{0}^{\perp} h\right\|_{s} \lesssim_{s, M} N_{0}^{\tau_{0}} \varepsilon \gamma^{-1}\left(\|v\|_{s_{0}+\mu_{M}}\|h\|_{s}+\|v\|_{s+\mu_{M}}\|h\|_{s_{0}}\right), \quad \forall s_{0} \leq s \leq S \tag{7.15}
\end{equation*}
$$

for some $\mu_{M}>0$ large enough.
STEP 4: Invertibility of $\Pi_{0}^{\perp} \mathcal{E} \Pi_{0}^{\perp}$. By (7.12) we have

& \mathcal{S}:=M^{-1}\left(\Pi_{0}^{\perp} \mathcal{E} \Pi_{0}\right)\left(\Pi_{0} \mathcal{E} \Pi_{0}\right)^{-1}\left(\Pi_{0} \mathcal{E} \Pi_{0}^{\perp}\right) .
\end{aligned}
$$

By (7.11), (7.13), (7.15), we deduce that

Therefore, by Neumann series, $\Pi_{0}^{\perp} \mathcal{E} \Pi_{0}^{\perp}: H_{0}^{s} \rightarrow H_{0}^{s}, s_{0} \leq s \leq S$ is invertible and it satisfies (7.2).
Proof of (ii). By Proposition 4.1, Lemmata 4.6, 5.5, Proposition 6.1) and recalling (3.3), (3.7), using that $\Pi_{0} \mathcal{E} \Pi_{0}^{\perp}=\Pi_{0}(\mathcal{E}-\mathrm{Id}) \Pi_{0}^{\perp}$ and $\Pi_{0}^{\perp} \mathcal{E} \Pi_{0}=\Pi_{0}^{\perp}(\mathcal{E}-\mathrm{Id}) \Pi_{0}$, one obtains

& =\Pi_{0}^{\perp} \mathcal{E} \mathcal{L}^{(3)} \Pi_{0}^{\perp}-\Pi_{0}^{\perp} \mathcal{L}^{(0)} \Pi_{0}(\mathcal{E}-\mathrm{Id}) \Pi_{0}^{\perp}  \tag{7.16}\\
& =\mathcal{E}_{\perp}\left(\Pi_{0}^{\perp} \mathcal{L}^{(3)} \Pi_{0}^{\perp}\right)+\Pi_{0}^{\perp}(\mathcal{E}-\mathrm{Id}) \Pi_{0} \mathcal{L}^{(3)} \Pi_{0}^{\perp}-\Pi_{0}^{\perp} \mathcal{L}^{(0)} \Pi_{0}(\mathcal{E}-\mathrm{Id}) \Pi_{0}^{\perp}
\end{align*}
$$

Hence, recalling (6.2), one obtains the conjugation (7.3) with

& A_{1}:=\mathcal{E}_{\perp}^{-1} \Pi_{0}^{\perp}(\mathcal{E}-\mathrm{Id}) \Pi_{0} \mathcal{L}^{(3)} \Pi_{0}^{\perp}, \quad A_{2}:=\mathcal{E}_{\perp}^{-1} \Pi_{0}^{\perp} \mathcal{L}^{(0)} \Pi_{0}(\mathcal{E}-\mathrm{Id}) \Pi_{0}^{\perp} . \tag{7.17}
\end{align*}
$$

Since $\mathcal{Q}=\operatorname{Op}(Q)$ has a symbol independent of $(\varphi, x)$, the operator $\mathcal{Q}_{0}=\Pi_{0}^{\perp} \mathcal{Q}_{0}^{\perp}=\operatorname{diag}_{j \in \mathbb{Z}^{3} \backslash\{0\}}\left(\mathcal{Q}_{0}\right)_{j}^{j}$ is a $3 \times 3$ block diagonal operator (see Definition (2.14) with $\left(\mathcal{Q}_{0}\right)_{j}^{j}=(\mathcal{Q})_{j}^{j} \in \operatorname{Mat}_{3 \times 3}(\mathbb{C})$ for any $j \in \mathbb{Z}^{3} \backslash\{0\}$. The estimate (7.4) holds by (6.3), by Remark 2.16 and Lemma 2.17- $(v)$.

It only remains to prove the estimate (7.5). First, we estimate the term $\Pi_{0}^{\perp} \mathcal{R}^{(3)} \Pi_{0}^{\perp}$ in (7.17). For any $s_{0} \leq s \leq S$, using Lemma 2.19 and (6.3), one has

\left|\Pi_{0}^{\perp} \mathcal{R}^{(3)} \Pi_{0}^{\perp}\langle D\rangle^{M}\right|_{s}^{k_{0}, \gamma} \lesssim\left|\mathcal{R}^{(3)}\langle D\rangle^{M}\right|_{s}^{k_{0}, \gamma} \lesssim\left|\mathcal{R}^{(3)}\langle D\rangle^{M}\right|_{0, s, 0}^{k_{0}, \gamma} \lesssim\left|\mathcal{R}^{(3)}\right|_{-M, s, 0}^{k_{0}, \gamma} \lesssim s, M \varepsilon\|v\|_{s+\mu_{M}}^{k_{0}, \gamma} \tag{7.18}
\end{equation*}
$$

Since $\Pi_{0} \omega \cdot \partial_{\varphi} \Pi_{0}^{\perp}, \Pi_{0} \zeta \cdot \nabla$ and $\Pi_{0} \mathcal{Q} \Pi_{0}^{\perp}$ are all zero, recalling (6.2) one has $\Pi_{0} \mathcal{L}^{(3)} \Pi_{0}^{\perp}=\Pi_{0} \mathcal{R}^{(3)} \Pi_{0}^{\perp}$. By (7.9), we get

Note that $\mathcal{R}^{(3)}\langle D\rangle^{M}$ is estimated in (7.18). Also,

\Pi_{0}(\mathcal{E}-\mathrm{Id}) \Pi_{0}^{\perp}\langle D\rangle^{M} h=\Pi_{0}\left(G \cdot \Pi_{0}^{\perp}\langle D\rangle^{M} h\right)=\Pi_{0}\left[\left(\langle D\rangle^{M} G\right) \cdot \Pi_{0}^{\perp} h\right]
$$

with $G$ defined in (7.14). Recalling (3.3), (3.5), since $\mathcal{U} \Pi_{0}=0$, one has $\Pi_{0}^{\perp} \mathcal{L}^{(0)} \Pi_{0}=\varepsilon M_{\mathcal{U}}(\varphi, x) \Pi_{0}$. Hence

Applying Lemma 2.19 (to bound $\left.\left|\left.\right|_{s}\right.$ with $\left.|\right|_{0, s, 0}\right)$, Lemmata 2.6 and 2.7 $(i)$ (to estimate composition of operators and their action on functions), bounds (2.23) (for the $\left|\left.\right|_{0, s, 0}\right.$ norm of any multiplicative matrix), (7.18) (for $\left|\mathcal{R}^{(3)}\langle D\rangle^{M}\right|_{0, s, 0}$ ), (4.49) (for $\left\|M_{\mathcal{U}}\right\|_{s}$ ), (7.8) (for $\mathcal{E}, \mathcal{E}^{*}$ ), (7.2) (for $\mathcal{E}_{\perp}^{-1}$ ), together with the assumptions (3.1), (4.3) and the trivial estimates $\left|\Pi_{0}\right|_{0, s, 0},\left|\Pi_{0}^{\perp}\right|_{0, s, 0} \leq 1$, we obtain that

This proves (7.5). The proof of the item (iii) follows by similar arguments.

## 8 Reducibility and inversion

In this section we perform a reducibility scheme for the operator $\mathcal{L}_{0}$ given in Lemma 7.1. We recall, as observed in Section 2.3. that any linear operator can be described both by a matrix representation and by a pseudo-differential representation with symbol, see (2.44)-(2.48). In this section we consider transformations of $H_{0}^{s}$, the space of functions in $H^{s}$ having zero average in the space variable $x$ (see (1.6)).

We introduce some further notations. Given a matrix $A \in \operatorname{Mat}_{3 \times 3}(\mathbb{C})$, we define the linear operators

M_{L}(A): \operatorname{Mat}_{3 \times 3}(\mathbb{C}) \rightarrow \operatorname{Mat}_{3 \times 3}(\mathbb{C}), & B \mapsto A B \\
M_{R}(A): \operatorname{Mat}_{3 \times 3}(\mathbb{C}) \rightarrow \operatorname{Mat}_{3 \times 3}(\mathbb{C}), & B \mapsto B A \tag{8.1}
\end{array}
$$

Since $\|A B\|_{\mathrm{HS}},\|B A\|_{\mathrm{HS}} \leq\|A\|_{\mathrm{HS}}\|B\|_{\mathrm{HS}}$, one has

\left\|M_{L}(A)\right\|_{\mathrm{op}},\left\|M_{R}(A)\right\|_{\mathrm{op}} \leq\|A\|_{\mathrm{HS}} \tag{8.2}
\end{equation*}
$$

where $\left\|\|_{\text {op }}\right.$ denotes the standard operator norm $\left(\left\|\|_{\text {HS }}\right.\right.$ is defined in (2.1)). Given $\tau, k_{0}, N_{0}>0$, we fix the constants

& \tau_{0}:=\left(k_{0}+1\right) \tau+k_{0}, \quad M:=\left[2 \tau_{0}\right]+1, \quad \mathrm{a}:=\max \left\{6 \tau_{0}+1, \frac{3}{2}\left(\tau+2 \tau^{2}\right)+1\right\}, \quad \mathrm{b}:=\mathrm{a}+1  \tag{8.3}\\
& \mu(\mathrm{~b}):=\mu_{M}+\mathrm{b}, \quad N_{-1}:=1, \quad N_{n}:=N_{0}^{\chi^{n}}, \quad n \geq 0, \quad \chi:=3 / 2
\end{align*}
$$

where [ $2 \tau_{0}$ ] is the integer part of $2 \tau_{0}$ and $\mu_{M}$ is the constant appearing in Lemma 7.1. Note that Lemma 7.1 holds for any $M \in \mathbb{N}$; in (8.3) we fix its value so that $M \geq 2 \tau_{0}$.

Remark 8.1 (Choice of the constants). The conditions $\mathrm{a} \geq 6 \tau_{0}+1, \mathrm{~b} \geq \mathrm{a}+1$ in (8.3) are used to show the convergence in the iterative estimates (8.32). We also require that $\mathrm{a} \geq \frac{3}{2}\left(\tau+2 \tau^{2}\right)+1$, for the measure estimates of Section 10, see Lemma 10.5

Proposition 8.2 (Reducibility). Let $\gamma \in(0,1), \tau>0, S>s_{0}$ and assume (3.1) with $\mu_{0} \geq s_{0}+\mu(\mathrm{b})$. Then there exists $N_{0}=N_{0}\left(S, k_{0}, \tau\right)>0, \tau_{2}=\tau_{2}\left(k_{0}, \tau, \nu\right)>0$ large enough and $\delta=\delta\left(S, k_{0}, \tau\right) \in(0,1)$ small enough such that if

\end{equation*}
$$

then for any integer $n \geq 0$ the following statements hold.
$(\mathbf{S 1})_{\mathbf{n}}$ There exists a real and reversible operator

\mathcal{L}_{n}:=\omega \cdot \partial_{\varphi}+\mathcal{N}_{n}+\mathcal{R}_{n}: H_{0}^{s+1} \rightarrow H_{0}^{s}, \quad \forall s_{0} \leq s \leq S
$$

defined for any $\lambda=(\omega, \zeta) \in \mathbb{R}^{\nu+3}$ and $k_{0}$ times differentiable in $\lambda=(\omega, \zeta) \in \mathbb{R}^{\nu+3}$ with the following properties. The operator $\mathcal{N}_{n}$ is a $3 \times 3$ block-diagonal operator (see Definition 2.14) defined by

for some constant $C_{*}(s)=C_{*}\left(s, k_{0}, \tau\right)>0$ large enough. Assume the the claimed properties $(\mathbf{S 1})_{\mathbf{n}}$ holds for some $n \geq 0$ and let us prove them at the step $n+1$. Let $\Phi_{n}=\operatorname{Id}+\Psi_{n}$ where $\Psi_{n}$ is an operator to determine. We compute

Since $\operatorname{Mat}_{3 \times 3}(\mathbb{C})$ is a vector space over $\mathbb{C}$ of dimension $9, L\left(\ell, j, j^{\prime}\right)$ can be represented by a matrix in $\operatorname{Mat}_{9 \times 9}(\mathbb{C})$. By (8.5) and (3.1), one has

By induction, it is not difficult to prove that, for any multi-index $\beta$ of positive length, the derivative $\partial_{\lambda}^{\beta}\left(L\left(\ell, j, j^{\prime} ; \lambda\right)^{-1}\right)$ is a sum of terms of the form $L^{-1}\left(\partial_{\lambda}^{\beta_{1}} L\right) L^{-1} \cdots L^{-1}\left(\partial_{\lambda}^{\beta_{m}} L\right) L^{-1}$ where $1 \leq m \leq|\beta|$ and $\beta_{1}, \ldots, \beta_{m}$ are nonzero multi-indices with $\beta_{1}+\ldots+\beta_{m}=\beta$ ( $L$ briefly denotes
$L\left(\ell, j, j^{\prime} ; \lambda\right)$ ). Hence, for all $\lambda \in \mathcal{K}\left(\ell, j, j^{\prime}\right)$, using the bound (8.21) and the definition of $\tau_{0}$ in (8.3), for $1 \leq|\beta| \leq k_{0}$ one has

where the implicit constant in (8.24) does not depend on $\left(\ell, j, j^{\prime}\right)$. The extension $L\left(\ell, j, j^{\prime} ; \lambda\right)_{\text {ext }}^{-1}$ coincides with $L\left(\ell, j, j^{\prime} ; \lambda\right)^{-1}$ for $\lambda \in \mathcal{K}\left(\ell, j, j^{\prime}\right)$.

Consider the set $\Omega_{+}^{\gamma}$. By construction, $L\left(\ell, j, j^{\prime} ; \lambda\right)_{\text {ext }}^{-1}=L\left(\ell, j, j^{\prime} ; \lambda\right)^{-1}$ for all $\lambda \in \Omega_{+}^{\gamma}$ because $\Omega_{+}^{\gamma} \subseteq$ $\mathcal{K}\left(\ell, j, j^{\prime}\right)$. For every $\lambda=(\omega, \zeta) \in \mathbb{R}^{\nu+3}$ we define $\Psi(\lambda)$ as

& \lesssim \gamma^{-1}\langle\ell\rangle^{\tau_{0}}|j|^{\tau_{0}}\left|j^{\prime}\right|^{\tau_{0}} \sum_{\left|\beta_{2}\right| \leq|\beta|} \gamma^{\left|\beta_{2}\right|}\left\|\partial_{\lambda}^{\beta_{2}} \widehat{\mathcal{R}}_{j}^{j^{\prime}}(\ell)\right\|_{\mathrm{HS}} \tag{8.26}

To estimate the decay norm of the operator $\langle D\rangle^{-M} \Psi\langle D\rangle^{M}$ we need to estimate $\langle j\rangle^{-M}\left\|\partial_{\lambda}^{\beta} \widehat{\Psi}_{j}^{j^{\prime}}(\ell)\right\|_{\mathrm{HS}}\left\langle j^{\prime}\right\rangle^{M}$. By triangular inequality, since $\left|j-j^{\prime}\right| \leq N$, one has

Let $\lambda \in \Omega_{\infty}^{\gamma}, \ell \in \mathbb{Z}^{\nu}, j, j^{\prime} \in \mathbb{Z}^{3} \backslash\{0\},\left(\ell, j, j^{\prime}\right) \neq(0, j, j)$ and $|\ell|,\left|j-j^{\prime}\right| \leq N_{n}$. By using (8.5), (8.8), (8.46), we write

& \mathcal{S}_{n}\left(\ell, j, j^{\prime}\right):=L_{\infty}\left(\ell, j, j^{\prime}\right)^{-1}\left(M_{L}\left(\left(\mathcal{Q}_{n}-\mathcal{Q}_{\infty}\right)_{j}^{j}\right)-M_{R}\left(\left(\mathcal{Q}_{n}-\mathcal{Q}_{\infty}\right)_{j^{\prime}}^{j^{\prime}}\right)\right) \tag{8.48}
\end{align*}

By (8.2), (8.44), (8.47), using (3.1), one obtains that

By the triangular inequality, using that $|\ell|,\left|j-j^{\prime}\right| \leq N_{n}$ and recalling that by (8.3), $M>2 \tau$, one obtains the bound

In the next Lemma we construct a right inverse for the operator $\mathcal{L}_{\infty}$.

Furthermore, the inverse operator admits an extension to the whole parameter space $\mathbb{R}^{\nu+3}$ (which we denote in the same way) satisfying the tame estimate

Arguing as in the proof of Lemma 8.3 (see in particular (8.23)-8.24)) one constructs an extension of $B(\ell, j ; \lambda)$ that we denote by $(B(\ell, j ; \lambda))_{\text {ext }}$ defined for any $\lambda \in \mathbb{R}^{\nu+3}$ and satisfying the estimate

Proposition 8.10. Let $S>s_{0}, \tau>0, \gamma \in(0,1)$. Then there exists $\bar{\mu}=\bar{\mu}\left(k_{0}, \tau, \nu\right)>\mu(\mathrm{b})$ (see (8.3)), $\delta=\delta\left(S, k_{0}, \tau\right) \in(0,1)$ such that if (3.1) holds with $\mu_{0} \geq s_{0}+\bar{\mu}$ and $\varepsilon \gamma^{-1} \leq \delta$, for any $\lambda=(\omega, \zeta) \in \Omega_{\infty}^{\gamma} \cap \Lambda_{\infty}^{\gamma}$, any $s_{0} \leq s \leq S$, any $h(\lambda) \in H_{0}^{s+\bar{\mu}} \cap X$ there exists a solution $g:=\mathcal{L}^{-1} h \in H_{0}^{s} \cap Y$ of the equation $\mathcal{L} g=h$. Moreover $\mathcal{L}^{-1}$ admits an extension to the whole parameter space $\mathbb{R}^{\nu+3}$ (which we denote in the same way) that satisfies the tame estimates

## 9 The Nash-Moser iteration

In this section we construct the solution of the equation $\mathcal{F}(v)=0$ (see (1.17)) by means of a Nash Moser nonlinear iteration. We denote by $\Pi_{n}$ the orthogonal projector $\Pi_{N_{n}}$ (see (2.4)) on the finite dimensional space

\end{equation*}

where $\bar{\mu}:=\bar{\mu}\left(k_{0}, \tau, \nu\right)>0$ is given in Proposition 8.10 and $\tau_{0}$ is defined in 8.3). For $N_{0}>0$ we define $N_{n}:=N_{0}^{\chi^{n}}, \chi:=3 / 2$, and $N_{-1}:=1$. We also fix the regularity of the forcing term $f$ in (1.3) as

Remark 9.1 (Choice of the constants). The conditions $\kappa \geq 6 \bar{\mu}+7, \mathrm{a}_{1} \geq 6 \bar{\mu}+13, \mathrm{~b}_{1} \geq 2 \bar{\mu}+\kappa+\mathrm{a}_{1}+3$ in (9.2) allow to prove the induction estimates in $(\mathcal{P} 2)_{n},(\mathcal{P} 3)_{n}$ in Proposition 9.2. The extra conditions $\mathrm{a}_{1} \geq \max \left\{3\left(\bar{\mu}+\tau+2 \tau^{2}\right)+1,3 \bar{\mu}+2 \tau_{0}+2\right\}$ are used in Section 10 for the measure estimates (Lemma 10.5).

If $n \geq 1$, the difference $h_{n}:=v_{n}-v_{n-1}$ satisfies $\left\|h_{1}\right\|_{s_{0}+\bar{\mu}}^{k_{0}, \gamma} \lesssim \varepsilon \gamma^{-1}$ and

Assume that $(\mathcal{P} 1,2,3)_{n}$ hold for some $n \geq 0$, and prove $(\mathcal{P} 1,2,3)_{n+1}$. By $(\mathcal{P} 1)_{n}$, one has $\left\|v_{n}\right\|_{s_{0}+\bar{\mu}}^{k_{0}, \gamma} \leq 1$, and the assumption (9.4) implies the smallness condition $\varepsilon \gamma^{-1} \leq \delta$ of Proposition 8.10 by taking $\bar{\tau}\left(k_{0}, \tau, \nu\right)$ large enough and $S=s_{0}+\mathrm{b}_{1}$. Thus, by the definition of $\mathcal{F}$ in (1.17), the product estimate (2.7), the smoothing property (9.1) (since $v_{n} \in \mathcal{H}_{n-1}$ ), the induction estimate (9.6) (since $\left\|v_{n}\right\|_{s_{0}+1}^{k_{0}, \gamma} \leq\left\|v_{n}\right\|_{s_{0}+\bar{\mu}}^{k_{0}, \gamma} \leq 1$ ), and the assumption $\|F\|_{s_{0}+\mathrm{b}_{1}} \lesssim 1$, one has

&\left\|\Pi_{n}^{\perp} \mathcal{F}\left(v_{n}\right)\right\|_{s_{0}}^{k_{0}, \gamma} \lesssim \varepsilon N_{n}^{-\left(\mathrm{b}_{1}-1\right)}\left\|v_{n}\right\|_{s_{0}+\mathrm{b}_{1}}^{k_{0}, \gamma}\left\|v_{n}\right\|_{s_{0}+1}^{k_{0}, \gamma}+\varepsilon N_{n}^{-\mathrm{b}_{1}}\|F\|_{s_{0}+\mathrm{b}_{1}} \lesssim \varepsilon N_{n}^{1-\mathrm{b}_{1}}\left(\left\|v_{n}\right\|_{s_{0}+\mathrm{b}_{1}}^{k_{0}, \gamma}+1\right) .

By (3.3), (9.9), (3.8), and using the bound $\left\|v_{n}\right\|_{s_{0}+1}^{k_{0}, \gamma} \leq\left\|v_{n}\right\|_{s_{0}+\bar{\mu}}^{k_{0}, \gamma} \leq 1$, for any $h$ one has

& \lesssim N_{n}^{2+2 \bar{\mu}-\mathrm{b}_{1}}\left(\left\|y_{n}\right\|_{s_{0}+\mathrm{b}_{1}}^{k_{0}}+\left\|v_{n}\right\|_{s_{0}+\mathrm{b}_{1}}^{k_{0}}\left\|y_{n}\right\|_{s_{0}}^{k_{0}, \gamma}\right), \\
\left\|\rho \mathcal{L}_{n} \Pi_{n}^{\perp} \mathcal{L}_{n}^{-1} \Pi_{n} y_{n}\right\|_{s_{0}+\mathrm{b}_{1}}^{k_{0}, \gamma} & \lesssim\left\|\mathcal{L}_{n}^{-1} \Pi_{n} y_{n}\right\|_{s_{0}+\mathrm{b}_{1}+1}^{k_{0}, \gamma}+\left\|v_{n}\right\|_{s_{0}, \gamma \mathrm{~b}_{1}+1}^{k_{0}}\left\|\mathcal{L}_{n}^{-1} \Pi_{n} y_{n}\right\|_{s_{0}+1}^{k_{0}, \gamma}  \tag{9.18}\\
& \lesssim N_{n}^{2+2 \bar{\mu}}\left(\left\|y_{n}\right\|_{s_{0}+\mathrm{b}_{1}}^{k_{0}}+\left\|v_{n}\right\|_{s_{0}+\gamma}^{k_{0}+\mathrm{b}_{1}}\left\|y_{n}\right\|_{s_{0}}^{k_{0}, \gamma}\right) .

Since the non linear part of $\mathcal{F}$ is quadratic (see (1.17)), $Q_{n}$ is a quadratic operator of $h_{n+1}$, independent of $v_{n}$, with

\end{equation*}

By the definition (9.15) of $y_{n+1}$, the first property in (9.9), the estimates (9.16), (9.18), (9.21), and the bound $\left\|y_{n}\right\|_{s_{0}}^{k_{0}, \gamma} \lesssim \varepsilon$ (which follows from (9.6)), we obtain

where $q_{n}$ is defined in $(\mathcal{P} 3)_{n}$.
Proof of $(\mathcal{P} 3)_{n+1}$. By the inductive assumption $(\mathcal{P} 3)_{n}, \varepsilon\left\|v_{n}\right\|_{s_{0}+\mathrm{b}_{1}}^{k_{0}, \gamma} \leq q_{n}$. Hence, by (9.13), (9.20), and $\varepsilon \gamma^{-1} \leq 1$, one has

for some constant $C$. The estimate (9.24) and $(\mathcal{P} 3)_{n}$ imply $(\mathcal{P} 3)_{n+1}$ for $\kappa>6+6 \bar{\mu}$ and $N_{0}$ sufficiently large (depending on $\kappa, \bar{\mu}$ and $C$ in (9.24)).
Proof of $(\mathcal{P} 1)_{n+1}$. The estimate (9.22) and the inductive assumption (9.5) imply (9.5) at the step $n+1$ for $\mathrm{b}_{1}>2+2 \bar{\mu}+\kappa+\mathrm{a}_{1}, \mathrm{a}_{1} \geq 9+6 \bar{\mu}, N_{0}$ sufficiently large (depending on $\mathrm{a}_{1}, \mathrm{~b}_{1}, \bar{\mu}, \kappa$ and on the implicit constant in (9.22)) and $\varepsilon$ sufficiently small (depending also on $N_{0}$ ). By (9.20), (9.1), (9.5) we deduce (9.7) at the step $n+1$ and, by telescoping series, (9.6) at the step $n+1$. The estimate for $h_{1}$ follows from (9.13) using that $v_{0}=0, y_{0}=\mathcal{F}\left(v_{0}\right)=\varepsilon F(\varphi, x)$, and $\|F\|_{s_{0}+2 \bar{\mu}} \leq\|F\|_{s_{0}+\mathrm{b}_{1}} \lesssim 1$.
Proof of $(\mathcal{P} 2)_{n+1}$. For $\lambda \in \mathcal{G}_{n+1}$ one has $\rho(\lambda)=1, \mathcal{L}_{n} \mathcal{L}_{n}^{-1}=\operatorname{Id}$ and, by inductive assumption, $\mathcal{F}\left(v_{n}\right)=y_{n}$. Hence $z_{n+1}$ in (9.15) is zero, and, by (9.14), $\mathcal{F}\left(v_{n+1}\right)=y_{n+1}$.

## 10 Measure estimate

In this section we prove that the set

$$
\begin{equation*}
\mathcal{G}_{\infty}:=\cap_{n \geq 0} \mathcal{G}_{n} \tag{10.1}
\end{equation*}
$$

has large Lebesgue measure. We estimate the measure of its complement $\Omega \backslash \mathcal{G}_{\infty}$. The main result of this section is the following proposition.

## Proposition 10.1. Let

\tau:=9 \max \{\nu, 3\}+1, \quad k_{0}:=11 \tag{10.2}
\end{equation*}
$$

Then $\left|\Omega \backslash \mathcal{G}_{\infty}\right| \lesssim \gamma$.
The rest of this section is devoted to the proof of Proposition 10.1. By the definition (10.1), one has

\Omega \backslash \mathcal{G}_{\infty} \subseteq \cup_{n \geq 0}\left(\mathcal{G}_{n} \backslash \mathcal{G}_{n+1}\right) \tag{10.3}

hence it is enough to estimate the measure of $\mathcal{G}_{n} \backslash \mathcal{G}_{n+1}$. By (9.8) and using elementary properties of set theory, one has that

\end{equation*}

Note that $\mathcal{G}_{n+1} \subseteq D C\left(\gamma_{n}, \tau\right)$ for any $n \geq 0$ because $\mathcal{G}_{n+1} \subseteq \Omega_{\infty}^{\gamma_{n}}\left(v_{n}\right) \subseteq D C\left(\gamma_{n}, \tau\right)$ by (9.8), (8.47).
Proposition 10.2. For any $n \geq 0$, the following estimates hold.
(i) $\mathcal{G}_{0} \backslash \Omega_{\infty}^{\gamma_{0}}\left(v_{0}\right) \lesssim \gamma$ and, for any $n \geq 1,\left|\mathcal{G}_{n} \backslash \Omega_{\infty}^{\gamma_{n}}\left(v_{n}\right)\right| \lesssim \gamma N_{n}^{-\frac{1}{9}}$.
(ii) $\mathcal{G}_{0} \backslash \Lambda_{\infty}^{\gamma_{0}}\left(v_{0}\right) \lesssim \gamma$ and for any $n \geq 1,\left|\mathcal{G}_{n} \backslash \Lambda_{\infty}^{\gamma_{n}}\left(v_{n}\right)\right| \lesssim \gamma N_{n}^{-\frac{1}{9}}$.

As a consequence $\left|\mathcal{G}_{0} \backslash \mathcal{G}_{1}\right| \lesssim \gamma$ and for any $n \geq 1,\left|\mathcal{G}_{n} \backslash \mathcal{G}_{n+1}\right| \lesssim \gamma N_{n}^{-\frac{1}{9}}$.
Propositions 10.1 and 10.2 are proved at the end of this section. Now we estimate the measure of the set $\mathcal{G}_{n} \backslash \Omega_{\infty}^{\gamma_{n}}\left(v_{n}\right)$. The estimate of the measure of $\mathcal{G}_{n} \backslash \Lambda_{\infty}^{\gamma_{n}}\left(v_{n}\right)$ can be done arguing similarly (it is actually even easier). By the definitions (9.8), (8.47), one gets that

\mathcal{G}_{n} \backslash \Omega_{\infty}^{\gamma_{n}}\left(v_{n}\right) \subseteq \bigcup_{\left(\ell, j, j^{\prime}\right) \in \mathcal{I}} \mathcal{R}_{\ell j j^{\prime}}\left(v_{n}\right) \tag{10.5}
\end{equation*}

where

\mathcal{I}:=\left\{\left(\ell, j, j^{\prime}\right) \in \mathbb{Z}^{\nu} \times\left(\mathbb{Z}^{3} \backslash\{0\}\right) \times\left(\mathbb{Z}^{3} \backslash\{0\}\right):\left(\ell, j, j^{\prime}\right) \neq(0, j, j)\right\} \tag{10.6}
\end{equation*}
$$

and

& \mathcal{R}_{\ell j j^{\prime}}\left(v_{n}\right):=\left\{\lambda=(\omega, \zeta) \in \mathcal{G}_{n}: L_{\infty}\left(\ell, j, j^{\prime} ; \lambda, v_{n}(\lambda)\right)\right. \text { is not invertible, or it is invertible and } \\
& \left.\qquad\left\|L_{\infty}\left(\ell, j, j^{\prime} ; \lambda, v_{n}(\lambda)\right)^{-1}\right\|_{\mathrm{op}}>\frac{\langle\ell\rangle^{\tau}|j|^{\tau}\left|j^{\prime}\right|^{\tau}}{2 \gamma_{n}}\right\} \tag{10.7}
\end{align*}
$$

In the next lemma, we estimate the measure of the resonant sets $\mathcal{R}_{\ell j j^{\prime}}\left(v_{n}\right)$.

Lemma 10.3. For any $n \geq 0$, one has that $\left|\mathcal{R}_{\ell j j^{\prime}}\left(v_{n}\right)\right| \lesssim \gamma^{\frac{1}{9}}\left\langle\ell, j-j^{\prime}\right\rangle^{-\frac{1}{9}}\langle\ell\rangle^{-\frac{\tau}{9}}|j|^{-\frac{\tau}{9}}\left|j^{\prime}\right|^{-\frac{\tau}{9}}$.
Proof. Recalling (8.43), (8.46), for $\left(\ell, j, j^{\prime}\right) \in \mathcal{I}$ (see (10.6)), we write $L_{\infty}\left(\ell, j, j^{\prime} ; \lambda\right) \equiv L_{\infty}\left(\ell, j, j^{\prime} ; \lambda, v_{n}(\lambda)\right)$, $\lambda=(\omega, \zeta) \in \Omega$ as

k:=\left(\ell, j-j^{\prime}\right), \quad \lambda=(\omega, \zeta) \in \Omega, \quad Q(\lambda):=M_{L}\left(\left(\mathcal{Q}_{\infty}\left(\lambda, v_{n}(\lambda)\right)\right)_{j}^{j}\right)-M_{R}\left(\left(\mathcal{Q}_{\infty}\left(\lambda, v_{n}(\lambda)\right)\right)_{j^{\prime}}^{j^{\prime}}\right) \tag{10.8}
\end{equation*}
$$

Since $\left(\ell, j, j^{\prime}\right) \in \mathcal{I}$, one has $k=\left(\ell, j-j^{\prime}\right) \neq(0,0)$. Recalling the definition (10.7), the resonant set $\mathcal{R}_{\ell j j^{\prime}}\left(v_{n}\right)$ is equal to the set $\mathcal{R}_{A}$ defined in (A.2), with $d:=9, A:=L_{\infty}\left(\ell, j, j^{\prime}\right), \eta=\frac{\langle\ell\rangle^{\tau}|j|^{\tau}\left|j^{\prime}\right|^{\tau}}{2 \gamma_{n}}$, and $k_{0}:=d+2=11$. By the definitions (10.8) and by the estimates (8.2), (8.44), (9.6), one obtains that $\|Q\|_{00}^{k_{0}, \gamma} \lesssim \varepsilon$, hence, by the smallness condition (9.4) (by choosing $\bar{\tau}$ large enough) one can apply Lemma A.1 obtaining that $\left|\mathcal{R}_{\ell j j^{\prime}}\left(v_{n}\right)\right| \lesssim \gamma_{n}^{\frac{1}{9}}\left\langle\ell, j-j^{\prime}\right\rangle^{-\frac{1}{9}}\langle\ell\rangle^{-\frac{\tau}{9}}|j|^{-\frac{\tau}{9}}\left|j^{\prime}\right|^{-\frac{\tau}{9}}$, then $\gamma_{n} \lesssim \gamma$, and we get the claimed estimate.
Lemma 10.4. Let $\left(\ell, j, j^{\prime}\right) \in \mathcal{I},\left\langle\ell, j-j^{\prime}\right\rangle \leq N_{n}, \min \left\{|j|,\left|j^{\prime}\right|\right\} \geq N_{n}^{\tau}$. Then $\mathcal{R}_{\ell j j^{\prime}}\left(v_{n}\right)=\emptyset$.
Proof. Let $\lambda=(\omega, \zeta) \in \mathcal{G}_{n}$. Recalling (8.43), (8.46), one writes

\Delta_{n}\left(\ell, j, j^{\prime}\right) & :=\Omega\left(\ell, j, j^{\prime}\right)^{-1}\left(M_{L}\left(\mathcal{Q}_{\infty}\left(v_{n}\right)_{j}^{j}\right)-M_{R}\left(\mathcal{Q}_{\infty}\left(v_{n}\right)_{j^{\prime}}^{j^{\prime}}\right)\right)
\end{aligned}
$$

Note that since $\lambda \in D C\left(\gamma_{n}, \tau\right)$ (see (4.7)) one has that $\Omega\left(\ell, j, j^{\prime}\right)$ is invertible and

The latter estimate, together with (8.2), (8.44), (9.6), since $\min \left\{|j|,\left|j^{\prime}\right|\right\} \geq N_{n}^{\tau}$ and $\gamma_{n}=\gamma\left(1+2^{-n}\right)$, implies that

$$

by choosing $\mathfrak{C}_{0}=\mathfrak{C}_{0}(\tau)>0$ large enough. This implies that $\mathcal{R}_{\ell j j^{\prime}}\left(v_{n}\right)=\emptyset$.
Lemma 10.5. Let $\left(\ell, j, j^{\prime}\right) \in \mathcal{I},\left\langle\ell, j-j^{\prime}\right\rangle \leq N_{n}, \min \left\{|j|,\left|j^{\prime}\right|\right\} \leq N_{n}^{\tau}, n \geq 1$. Then

$$

Proof. We split the proof in two steps.
Step 1. We show that for $\left(\ell, j, j^{\prime}\right) \in \mathcal{I},|\ell|,\left|j-j^{\prime}\right| \leq N_{n}$, for any $\lambda \in \mathcal{G}_{n}$ one has

\left\|L_{\infty}\left(\ell, j, j^{\prime} ; v_{n}\right)-L_{\infty}\left(\ell, j, j^{\prime} ; v_{n-1}\right)\right\|_{\mathrm{op}} \lesssim N_{n-1}^{2 \bar{\mu}} N_{n-2}^{-\mathrm{a}_{1}} \varepsilon^{2} \gamma^{-1}+\varepsilon N_{n-1}^{-\mathrm{a}} \tag{10.11}
\end{equation*}
$$

(the constant a is defined in (8.3)). By (8.43), (8.46), by the property (8.2), one computes

\left\|L_{\infty}\left(\ell, j, j^{\prime} ; v_{n}\right)-L_{\infty}\left(\ell, j, j^{\prime} ; v_{n-1}\right)\right\|_{\mathrm{op}} \lesssim \sup _{j \in \mathbb{Z}^{3} \backslash\{0\}}\left\|\left(\mathcal{Q}_{\infty}\left(v_{n}\right)-\mathcal{Q}_{\infty}\left(v_{n-1}\right)\right)_{j}^{j}\right\|_{\mathrm{HS}} \tag{10.12}
\end{equation*}
$$

By the inductive definition of the sets $\mathcal{G}_{n}$ in (9.8), recalling the definitions (8.9), (8.47) and Lemma 8.6, one gets the inclusion

\mathcal{G}_{n} \subseteq \Omega_{n}^{\gamma_{n-1}}\left(v_{n-1}\right) \tag{10.13}
\end{equation*}
$$

We apply Proposition 8.2-(S3 $)_{\mathbf{n}}$ with $v_{1} \equiv v_{n-1}, v_{2} \equiv v_{n}, \rho \equiv \gamma_{n-1}-\gamma_{n}=\gamma 2^{-n}$. By (9.7), one has

N_{n-1}^{\tau_{0}} \varepsilon\left\|v_{n}-v_{n-1}\right\|_{s_{0}+\bar{\mu}} \leq C N_{n-1}^{\tau_{0}+2 \bar{\mu}} N_{n-2}^{-\mathrm{a}_{1}} \varepsilon^{2} \gamma^{-1} \leq \gamma_{n-1}-\gamma_{n} \tag{10.14}
\end{equation*}
$$

for some constant $C>0$, since

C 2^{n} N_{n-1}^{\tau_{0}+2 \bar{\mu}} N_{n-2}^{-\mathrm{a}_{1}} \varepsilon^{2} \gamma^{-2} \leq 1, \quad n \geq 1
$$

by recalling that $\bar{\mu}>\mu(\mathrm{b}), \mathrm{a}_{1}>3 \bar{\mu}+\frac{3}{2}\left(\tau_{0}+1\right)$ (see (8.3), Proposition 8.10, and (9.2)) and by the smallness condition (9.4), by choosing $\bar{\tau}$ large enough. The estimate (10.14) implies that Proposition $8.2(\mathbf{S 3})_{\mathbf{n}}$ applies, implying that $\mathcal{G}_{n} \subseteq \Omega_{n}^{\gamma_{n-1}}\left(v_{n-1}\right) \subseteq \Omega_{n}^{\gamma_{n}}\left(v_{n}\right)$ (recall also (10.13)). Then, we can apply the estimate (8.13) of Proposition $8.2-(\overline{\mathbf{S 2}})_{\mathbf{n}}$ (with $v_{1} \equiv v_{n-1}, v_{2} \equiv v_{n}, \gamma_{1} \equiv \gamma_{n}, \gamma_{2} \equiv \gamma_{n-1}$ ), implying that

\sup _{j \in \mathbb{Z}^{3} \backslash\{0\}}\left\|\left(\mathcal{Q}_{n}\left(v_{n}\right)-\mathcal{Q}_{n}\left(v_{n-1}\right)\right)_{j}^{j}\right\|_{\mathrm{HS}} \lesssim \varepsilon\left\|v_{n}-v_{n-1}\right\|_{s_{0}+\bar{\mu}} \stackrel{(9.7)}{\lesssim} N_{n-1}^{2 \bar{\mu}} N_{n-2}^{-\mathbf{a}_{1}} \varepsilon^{2} \gamma^{-1}, \quad \lambda \in \mathcal{G}_{n} \tag{10.15}
\end{equation*}
$$

Hence, by triangular inequality and by (8.44), (10.15), (9.6), one has

\sup _{j \in \mathbb{Z}^{3} \backslash\{0\}}\left\|\left(\mathcal{Q}_{\infty}\left(v_{n}\right)-\mathcal{Q}_{\infty}\left(v_{n-1}\right)\right)_{j}^{j}\right\|_{\mathrm{HS}} \leq & \sup _{j \in \mathbb{Z}^{3} \backslash\{0\}}\left\|\left(\mathcal{Q}_{\infty}\left(v_{n}\right)-\mathcal{Q}_{n}\left(v_{n}\right)\right)_{j}^{j}\right\|_{\mathrm{HS}} \\
& +\sup _{j \in \mathbb{Z}^{3} \backslash\{0\}}\left\|\left(\mathcal{Q}_{n}\left(v_{n}\right)-\mathcal{Q}_{n}\left(v_{n-1}\right)\right)_{j}^{j}\right\|_{\mathrm{HS}}  \tag{10.16}\\
& +\sup _{j \in \mathbb{Z}^{3} \backslash\{0\}}\left\|\left(\mathcal{Q}_{n}\left(v_{n-1}\right)-\mathcal{Q}_{\infty}\left(v_{n-1}\right)\right)_{j}^{j}\right\|_{\mathrm{HS}} \\
\lesssim & N_{n-1}^{2 \bar{\mu}} N_{n-2}^{-a_{1}} \varepsilon^{2} \gamma^{-1}+\varepsilon N_{n-1}^{-\mathrm{a}}
\end{align*}
$$

The estimate (10.11) then follows by (10.12), (10.16).
Step 2. Let $\lambda \in \mathcal{G}_{n}$ and $\left\langle\ell, j-j^{\prime}\right\rangle \leq N_{n}, \min \left\{|j|,\left|j^{\prime}\right|\right\} \leq N_{n}^{\tau}, n \geq 1$. We write

\Delta_{n}\left(\ell, j, j^{\prime}\right) & :=L_{\infty}\left(\ell, j, j^{\prime} ; v_{n-1}\right)^{-1}\left(L_{\infty}\left(\ell, j, j^{\prime} ; v_{n}\right)-L_{\infty}\left(\ell, j, j^{\prime} ; v_{n-1}\right)\right) \tag{10.17}
\end{align*}

Since $\left|j-j^{\prime}\right| \leq N_{n}$ and $\min \left\{|j|,\left|j^{\prime}\right|\right\} \leq N_{n}^{\tau}$, by triangular inequality one has $\max \left\{|j|,\left|j^{\prime}\right|\right\} \lesssim N_{n}^{\tau}$. Therefore, using that $\lambda \in \mathcal{G}_{n}$ and the estimate (10.11), one gets

\end{equation*}

Hence, by the smallness condition (9.4), using that $\mathrm{a}_{1}>3 \bar{\mu}+\frac{9}{4}\left(\tau+2 \tau^{2}\right)$ (see (9.2)), a $>\frac{3}{2}\left(\tau+2 \tau^{2}\right)$ (see (8.3)), by (10.17), (10.18), one gets that $\left\|\Delta_{n}\left(\ell, j, j^{\prime}\right)\right\|_{\mathrm{op}} \leq 2^{-n}$, so that $L_{\infty}\left(\ell, j, j^{\prime} ; v_{n}\right)$ is invertible and $\left\|L_{\infty}\left(\ell, j, j^{\prime} ; v_{n}\right)^{-1}\right\|_{\text {op }} \leq\langle\ell\rangle^{\tau}|j|^{\tau}\left|j^{\prime}\right|^{\tau} \frac{1}{2 \gamma_{n}}$, implying the claimed inclusion.
Lemma 10.6. For any $n \geq 1$, the following inclusion holds:

Proof. Let $n \geq 1$. By the definition (10.7), $\mathcal{R}_{\ell j j^{\prime}}\left(v_{n}\right) \subseteq \mathcal{G}_{n}$. By Lemmata 10.4 10.5 for any $\left(\ell, j, j^{\prime}\right) \in \mathcal{I}$, $\left\langle\ell, j-j^{\prime}\right\rangle \leq N_{n}$, if $\min \left\{|j|,\left|j^{\prime}\right|\right\} \geq N_{n}^{\tau}$ then $\mathcal{R}_{\ell, j j^{\prime}}\left(v_{n}\right)=\emptyset$ and if $\min \left\{|j|,\left|j^{\prime}\right|\right\} \leq N_{n}^{\tau}$ then $\mathcal{R}_{\ell j j^{\prime}}\left(v_{n}\right) \subseteq$ $\mathcal{R}_{\ell j j^{\prime}}\left(v_{n-1}\right)$. On the other hand $\mathcal{G}_{n} \cap \mathcal{R}_{\ell j j^{\prime}}\left(v_{n-1}\right)=\emptyset$ (see (9.8)), therefore (10.19) holds.

By the inclusion (10.5) and by Lemma 10.3 one gets that

\left|\mathcal{G}_{0} \backslash \Omega_{\infty}^{\gamma_{0}}\left(v_{0}\right)\right| \lesssim \sum_{\left(\ell, j, j^{\prime}\right) \in \mathcal{I}}\left|\mathcal{R}_{\ell j j^{\prime}}\left(v_{0}\right)\right| \lesssim \gamma \sum_{\left(\ell, j, j^{\prime}\right) \in \mathbb{Z}^{\nu} \times\left(\mathbb{Z}^{3} \backslash\{0\}\right) \times\left(\mathbb{Z}^{3} \backslash\{0\}\right)} \frac{1}{\langle\ell\rangle^{\frac{\tau}{9}}|j|^{\frac{\tau}{9}}\left|j^{\prime}\right|^{\frac{\tau}{9}}} \frac{\left(\frac{10.2)}{\lesssim}\right.}{\lesssim} \gamma \tag{10.20}
\end{equation*}
$$

Now let $n \geq 1$. By the inclusion (10.19) and by Lemma 10.3) one has

\left|\mathcal{G}_{n} \backslash \Omega_{\infty}^{\gamma_{n}}\left(v_{n}\right)\right| \lesssim \sum_{\substack{\left(\ell, j, j^{\prime}\right) \in \mathcal{I} \\\left\langle\ell, j-j^{\prime}\right\rangle \geq N_{n}}}\left|\mathcal{R}_{\ell j j^{\prime}}\left(v_{n}\right)\right| \lesssim \gamma \sum_{\substack{\left(\ell, j, j^{\prime}\right) \in \mathcal{I} \\\left\langle\ell, j-j^{\prime}\right\rangle \geq N_{n}}} \frac{1}{\left\langle\ell, j-j^{\prime}\right\rangle^{\frac{1}{9}}\langle\ell\rangle^{\frac{\tau}{9}}|j|^{\frac{\tau}{9}}\left|j^{\prime}\right|^{\frac{\tau}{9}}} \stackrel{\frac{10.2}{\lesssim}}{\lesssim} \gamma N_{n}^{-\frac{1}{9}} \tag{10.21}
\end{equation*}
$$

Proof of Propositions 10.1, 10.2. Proposition 10.2 ( $(i)$ follows by recalling formula (10.5) and by applying the estimates (10.20), (10.21). Item (ii) can be proved by similar arguments. The estimates on $\mathcal{G}_{n} \backslash \mathcal{G}_{n+1}$ follows by recalling formula (10.4) and by applying items (i), (ii).

Proposition 10.1 follows by applying Proposition 10.2, using the inclusion (10.3) and the fact that the series $\sum_{n \geq 1} N_{n}^{-1 / 9}$ converges.

## 11 Proof of Theorems 1.2, 1.1

Proof of Theorem 1.2. Fix $\gamma:=\varepsilon^{c}$ with $0<c<\frac{1}{\tau}$ where $\bar{\tau}$ is the constant appearing in the smallness condition (9.4). Note that, since $k_{0}$ and $\tau$ have been fixed in (10.2), the constant $\bar{\tau}=\bar{\tau}(\nu)$ only depends on the number of frequencies $\nu$. Then $N_{0}^{\bar{\tau}} \varepsilon=\gamma^{-\bar{\tau}} \varepsilon=\varepsilon^{1-c \bar{\tau}}$, therefore the smallness condition (9.4) is fullfilled for $\varepsilon$ small enough. By Proposition 9.2, $(\mathcal{P} 1)_{n}$, using a telescoping argument, the sequence $\left(v_{n}\right)_{n \geq 0}$ converges to $v_{\infty} \in H^{s_{0}+\bar{\mu}} \cap Y$ with respect to the norm $\left\|\|_{s_{0}+\bar{\mu}}^{k_{0},}\right.$, and

$$
\begin{equation*}
\left\|v_{\infty}\right\|_{s_{0}+\bar{\mu}}^{k_{0}, \gamma} \lesssim \varepsilon \gamma^{-1}, \quad\left\|v_{\infty}-v_{n}\right\|_{s_{0}+\bar{\mu}}^{k_{0}, \gamma} \lesssim \varepsilon \gamma^{-1} N_{n-1}^{-\mathrm{a}_{1}}, \quad \forall n \geq 1 \tag{11.1}
\end{equation*}
$$

 (11.1) implies that $\mathcal{F}\left(v_{\infty}\right)=0$ for any $\lambda \in \mathcal{G}_{\infty}$. By setting $\Omega_{\varepsilon}:=\mathcal{G}_{\infty}$, by applying Proposition 10.1 and using that $\gamma=\varepsilon^{c}$, one gets that $\lim _{\varepsilon \rightarrow 0}\left|\Omega_{\varepsilon}\right|=|\Omega|$ and hence the proof is concluded.

Proof of Theorem 1.1, Let $v \in H_{0}^{s}$ be the solution of the equation $\mathcal{F}(v)=0$ provided by Theorem 1.2 , where $\mathcal{F}$ is defined in (1.17). Let $u:=\mathcal{U}(v)=\operatorname{curl}\left(\Lambda^{-1} v\right)$. One has $\operatorname{div} u=0, \operatorname{div} F=\operatorname{div}(\operatorname{curl} f)=0$ (the divergence of any curl is zero). Since $\operatorname{div} u=0$, one directly calculates $\operatorname{div}(u \cdot \nabla v-v \cdot \nabla u)=u \cdot \nabla(\operatorname{div} v)$. Moreover div $\Pi_{0}^{\perp}=\operatorname{div}$ because div $\Pi_{0}=0$. Hence, taking the divergence of the identity $\mathcal{F}(v)=0$, we get

$$
\begin{equation*}
\left(\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla+\varepsilon u \cdot \nabla\right)(\operatorname{div} v)=0 \tag{11.2}
\end{equation*}
$$

Since $u=\operatorname{curl}\left(\Lambda^{-1} v\right) \in H^{s_{0}+\bar{\mu}} \cap X$ and $\|u\|_{s_{0}+\bar{\mu}} \lesssim 1$, for $\varepsilon$ small enough we can apply Proposition 4.1 to the transport operator

$$
\mathcal{T}=\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla+\varepsilon u(\varphi, x) \cdot \nabla
$$

and obtain that there exists a reversibility preserving, invertible map $\mathcal{A}$ of the form (4.5) such that

\mathcal{A}^{-1}\left(\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla+\varepsilon u \cdot \nabla\right) \mathcal{A}=\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla, \quad \forall(\omega, \zeta) \in \Omega_{\varepsilon} \subseteq D C(\gamma, \tau)
$$

Hence, by (11.2), $\left(\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla\right) \mathcal{A}^{-1}(\operatorname{div} v)=0$. Since $(\omega, \zeta)$ is Diophantine, the kernel of $\omega \cdot \partial_{\varphi}+\zeta \cdot \nabla$ is given by the constants, so that $\mathcal{A}^{-1}(\operatorname{div} v)$ is a constant, say $\mathcal{A}^{-1}(\operatorname{div} v)=c$. This implies that $\operatorname{div} v=c$, because $\mathcal{A}^{-1}$ is a change of variable. By periodicity, the space average of any divergence is zero, and therefore $\operatorname{div} v=c=0$.

Since $\operatorname{div} u=0, \operatorname{div} v=0$, integrating by parts one deduces that $u \cdot \nabla v$ and $v \cdot \nabla u$ have both zero average in the space variable $x \in \mathbb{T}^{3}$. Also $F$ has zero average in $x$ (because $F$ is a curl). This implies that $\Pi_{0}^{\perp}(u \cdot \nabla v-v \cdot \nabla u-F)=u \cdot \nabla v-v \cdot \nabla u-F$, and then from the equation $\mathcal{F}(v)=0$ we deduce that

$$
\omega \cdot \partial_{\varphi} v+\zeta \cdot \nabla v+\varepsilon(u \cdot \nabla v-v \cdot \nabla u-F)=0
$$

Moreover, by Theorem [1.2, $v \in H_{0}^{s}$ has zero space average, therefore $\Lambda^{-1} v=(-\Delta)^{-1} v$ (see (1.15)) and $u=\operatorname{curl}(-\Delta)^{-1} v$. Restore the tilde that have been removed when passing from (1.16) to (1.17), and consider $v=\tilde{\varepsilon} \tilde{v}$. Then $v$ solves (1.10) and $\|v\|_{s}=\tilde{\varepsilon}\|\tilde{v}\|_{s} \leq C \tilde{\varepsilon}^{1+a}=C \varepsilon^{b}, b:=(1+a) / 2$.

Now we show that there exists a pressure $p(\varphi, x)$ such that $(u, p)$ solves (1.3). Recall the general formula $\operatorname{curl}(\operatorname{curl} w)=-\Delta w+\nabla(\operatorname{div} w)$. Then $\operatorname{curl} u=\operatorname{curl}\left(\operatorname{curl}(-\Delta)^{-1} v\right)=v$ because $\operatorname{div} v=0$ and $\Pi_{0} v=0$. Then a direct computation shows that

$$
\operatorname{curl}(u \cdot \nabla u)=u \cdot \nabla v-v \cdot \nabla u
$$

Since $\operatorname{curl}\left(\omega \cdot \partial_{\varphi} u\right)=\omega \cdot \partial_{\varphi} v, \operatorname{curl}(\zeta \cdot \nabla u)=\zeta \cdot \nabla v$ and $F=\operatorname{curl} f$, the equation (1.10) can be rewritten as

$$
\operatorname{curl}(\Gamma)=0 \quad \text { where } \quad \Gamma:=\omega \cdot \partial_{\varphi} u+\zeta \cdot \nabla u+\varepsilon u \cdot \nabla u-\varepsilon f .
$$

Then $\Gamma$ is a smooth irrotational vector field. We observe that $\Gamma$ has zero average. Indeed $\Pi_{0} u=0$ (because $u$ is a curl), $\Pi_{0} f=0$ (by assumption), and, integrating by parts, $\Pi_{0}(u \cdot \nabla u)=-\Pi_{0}((\operatorname{div} u) u)=0$ (because $\operatorname{div} u=0$ ), whence we deduce that $\Pi_{0} \Gamma=0$. Then $p:=(-\Delta)^{-1} \operatorname{div} \Gamma$ satisfies $\nabla p=\Gamma$, namely

\omega \cdot \partial_{\varphi} u+\zeta \cdot \nabla u+\varepsilon u \cdot \nabla u-\varepsilon f=-\nabla p
$$

Hence $u, p$ solve the equation (1.2) and $\|u\|_{s},\|p\|_{s} \lesssim_{s} \varepsilon^{b}$.

## A Appendix

In this appendix we prove a lemma which allows to provide the measure estimate of the resonant sets defined in (10.7). Let $\mathcal{H}$ be a Hilbert space of dimension $d$ with scalar product $\langle\cdot, \cdot\rangle_{\mathcal{H}}$ and let $\left\{\varphi_{1}, \ldots, \varphi_{d}\right\}$ be an orthonormal basis of $\mathcal{H}$. We consider the set $\mathcal{B}(\mathcal{H})$ of linear maps $B: \mathcal{H} \rightarrow \mathcal{H}$ with the operator norm $\left\|\|_{\mathrm{op}}\right.$. Given $B \in \mathcal{B}(\mathcal{H})$, we identify it with its matrix representation $\left(B_{j}^{i}\right)_{j, i=1, \ldots, d}$ where $B_{j}^{i}:=\left\langle B \varphi_{i}, \varphi_{j}\right\rangle_{\mathcal{H}}$. Let

$$
\begin{equation*}
A(\lambda)=\lambda \cdot k \operatorname{Id}_{\mathcal{H}}+Q(\lambda) \quad \text { with } \quad k \in \mathbb{Z}^{p} \backslash\{0\} \tag{A.1}
\end{equation*}
$$

where the map $\mathbb{R}^{p} \rightarrow \mathcal{B}(\mathcal{H}), \lambda \mapsto Q(\lambda)$ is $k_{0}$ times differentiable. Let $\Omega \subseteq \mathbb{R}^{p}$ be a bounded, open set and $\eta>0$. In the lemma below, we provide a measure estimate of the set

\begin{equation*}
\mathcal{R}_{A}:=\left\{\lambda \in \Omega: A(\lambda) \text { is not invertible or it is invertible and }\left\|A(\lambda)^{-1}\right\|_{\mathrm{op}}>\eta\right\} . \tag{A.2}
\end{equation*}

A similar version of the following Lemma can be found in 43. For sake of completeness we insert our own proof.
Lemma A.1. Let $k_{0}, d \in \mathbb{N}$ with $k_{0} \geq d+2, \gamma \in(0,1)$. Then there exists $\delta_{0} \in(0,1)$ such that if

Proof. First, if $A$ is invertible, one has the elementary inequality $\left\|A^{-1}\right\|_{\mathcal{B}(\mathcal{H})} \leq C_{0}(d)\|A\|_{\mathcal{B}(\mathcal{H})}^{d-1}|\operatorname{det} A|^{-1}$, for some $C_{0}(d)>0$. By (A.1), (A.3), since $\delta \leq 1 \leq|k|$, one has $\|A\|_{\mathcal{B}(\mathcal{H})}^{d-1} \leq C_{1}|k|^{d-1}$ for some $C_{1}$ depending on $d, \Omega$. Then $\left\|A^{-1}\right\|_{\mathcal{B}(\mathcal{H})} \leq C_{2}|k|^{d-1}|\operatorname{det} A|^{-1}$ for some $C_{2}>0$. Hence

$$
\begin{equation*}
\mathcal{R}_{A} \subseteq \widetilde{\mathcal{R}}_{A} \quad \text { where } \quad \widetilde{\mathcal{R}}_{A}:=\left\{\lambda \in \Omega:|\operatorname{det} A(\lambda)|<\frac{C_{2}|k|^{d-1}}{\eta}\right\} \tag{A.4}
\end{equation*}
$$

By using (A.1), (A.3), a direct calculation shows that

$$
\begin{equation*}
\operatorname{det} A(\lambda)=(\lambda \cdot k)^{d}+r_{d-1}(\lambda)(\lambda \cdot k)^{d-1}+\ldots+r_{1}(\lambda)(\lambda \cdot k)+r_{0}(\lambda) \tag{A.5}
\end{equation*}
$$

where for any $n=0, \ldots, d-1$ the maps $\lambda \mapsto r_{n}(\lambda)$ are $k_{0}$ times differentiable and

$$
\begin{equation*}
\left|r_{n}\right|^{k_{0}, \gamma} \lesssim_{k_{0}, d} \delta, \quad \forall n=0, \ldots, d-1 \tag{A.6}
\end{equation*}
$$

Now let

$$
\begin{align*}
& \lambda=\frac{k}{|k|} s+v, \quad v \cdot k=0, \quad \Gamma(s):=\operatorname{det}\left(A\left(\frac{k}{|k|} s+v\right)\right),  \tag{A.7}\\
& q_{n}(s):=r_{n}\left(\frac{k}{|k|} s+v\right), \quad n=0, \ldots, d-1
\end{align*}
$$

By (A.5), (A.7), using that $\lambda \cdot k=|k| s$, one has

$$
\Gamma(s)=|k|^{d}\left(s^{d}+q_{\Gamma}(s)\right), \quad q_{\Gamma}(s):=\frac{q_{d-1}(s) s^{d-1}}{|k|}+\ldots+\frac{q_{1}(s) s}{|k|^{d-1}}+\frac{q_{0}(s)}{|k|^{d}} .
$$

By (A.6), (A.7), one gets $\left|q_{\Gamma}\right|^{k_{0}, \gamma} \lesssim_{k_{0}, d} \delta$, implying that

$$
\left|\partial_{s}^{d} \Gamma(s)\right| \geq\left(d!-\left|\partial_{s}^{d} q_{\Gamma}(s)\right|\right)|k|^{d} \geq\left(d!-C \delta \gamma^{-k_{0}}\right)|k|^{d} \geq \frac{d!}{2}|k|^{d}
$$

by taking $\delta \gamma^{-k_{0}}$ small enough. The latter estimate together with Theorem 17.1 in 44 implies that

$$
\left|\left\{s: \lambda=\frac{k}{|k|} s+v \in \Omega, \quad|\Gamma(s)|<\frac{C_{2}(d)|k|^{d-1}}{\eta}\right\}\right| \lesssim d\left(\frac{1}{|k| \eta}\right)^{\frac{1}{d}} .
$$

By a Fubini argument one gets that $\left|\widetilde{\mathcal{R}}_{A}\right| \lesssim(|k| \eta)^{-\frac{1}{d}}$ and the claimed statement follows by recalling (A.4).
